BP subcontractors, such as the Center for Toxicology & Environmental Health LLC (CTEH). 2. Any and all Evaluation Information gathered for workers provided by agencies, employers, the individuals themselves, and/or organizations as identified in the Minimum Evaluation Information section of Exhibit A on pages 3 through 5, including but not limited to the information gathered for subjects specifically identified in sections “1. Personal Information,” “2. Response-related information,” and/or “3. Medical Information.” 3. Any recommendations given to individuals subject to the pre-placement evaluation process as identified in the three bullet points at the top of Exhibit A’s page 6, including but not limited to duty limitations, further medical evaluation, and/or specific training prior to deployment. 4. Any communications or records<sup>1</sup> related to issues in monitoring identified on Exhibit A’s page 6 section “5. Exposure monitoring – biological monitoring.” 5. Any follow up communications and/or evaluations records<sup>1</sup> as identified on Exhibit A’s page 7 section “Follow-Up.” (Date Range for Record Search: From 4/20/2010 To 4/30/2011).
