A Juvenile, [REDACTED], was taken to [REDACTED] hospital with appearance of severe frostbite to his lower extremities. [REDACTED] feet were noted to be black with surrounding yellow sloughing tissue and purulent drainage. During the course of the investigation, the accused, stated that the child had been living in a box trailer on the residence property for a couple of months, which had three heaters inside. The child was given poptarts/cereal for breakfast, honeybuns for snack, and either burgers or spaghetti for food. The accused stated that the trailer did not have any windows and the back door goes down but when shut, you can't get out, and the trailer does have a regular door also. The accused stated that the child had a toilet which they change about twice a week. The accused stated that the child was given a bath in a hot tub which was located outside. [REDACTED] transferred the child to [REDACTED] at [REDACTED] where a bilateral emergent guillotine below the knee amputation was performed.
