Hi Randy,

As part of our post-conviction investigation, we have been attempting to obtain Coonce's BOP records, especially any records not included in the discovery produced in the criminal case.

On July 20, 2021, BOP regional counsel Richard Winter wrote us a letter (copy attached) advising that our request met the requirements for "expedited" processing, which could take "up to 6 months." One year and numerous follow-up inquiries later, we have yet to receive anything.

We are prepared to file a lawsuit against BOP if necessary, but prior to taking that step I wanted to see if you might be willing to assist us in obtaining Coonce's records, or maybe could direct us to someone within BOP who might be more responsive to our requests.
