

## Intervention determination Logic

Data sources:

HMIS: Homeless Management Information System

RMS: Resource Management System where we track statuses of housing resources.

A client is considered "Permanently Housed" if either:

1. The client is listed as *Housed* in RMS (Resource Mgmt System) OR
2. The client enrolled in a *Rapid Re-housing* program and has a move-in date OR
3. The client enrolled in a Program with one of these types:
  - '*PH - Housing Only*'
  - '*PH - Housing with Services (no disability required)*'
  - '*PH - Permanent Supportive Housing (disability required)*'

A client is listed as "Matched to Permanent Housing, Not Yet Housed" if they don't meet any of the criteria above and according to RMS are *Matched but not yet Housed*

A client is listed as "Exited to a temporary destination" if they don't meet any of the criteria above and according to RMS (Resource Mgmt System) are *Not Housed*.

And have exited with an exit\_destination of either:

Emergency shelter, including hotel or motel paid for with emergency shelter voucher OR  
Transitional housing for homeless persons (including homeless youth) OR  
Staying or living with family, temporary tenure (room, apartment, or house) OR  
Staying or living with friends, temporary tenure (room, apartment, or house) OR  
Hotel or motel paid for without emergency shelter voucher  
Safe Haven OR  
Moved from one HOPWA funded project to HOPWA TH OR  
Residential project or halfway house with no homeless criteria OR  
Host Home (non-Crisis)

A client is listed as "Exited to a permanent destination" if they don't meet any of the criteria above and have exited with an exit\_destination of either:

Moved from one HOPWA funded project to HOPWA PH  
Owned by client, no ongoing housing subsidy  
Owned by client, with ongoing housing subsidy  
Permanent housing (other than RRH) for formerly homeless persons  
Rental by client in a public housing unit  
Rental by client, no ongoing housing subsidy  
Rental by client, with GPD TIP housing subsidy  
Rental by client, with HCV voucher (tenant or project based)  
Rental by client, with other ongoing housing subsidy  
Rental by client, with RRH or equivalent subsidy  
Rental by client, with VASH housing subsidy  
Staying or living with family, permanent tenure  
Staying or living with friends, permanent tenure

A client is listed as "Exited to an institutional destination" if they don't meet any of the criteria above and according to RMS are *Not Housed* and

have exited with an exit\_destination of either:

Foster care home or foster care group home  
Hospital or other residential non-psychiatric medical facility  
Jail, prison, or juvenile detention facility  
Long-term care facility or nursing home  
Psychiatric hospital or other psychiatric facility  
Substance abuse treatment facility or detox center

A client is listed as "Exited to a place not meant for habitation" if they don't meet any of the criteria above and have exited with an exit\_destination of:

Place not meant for habitation

A client is listed as 'Deceased' if they have an exit destination of 'Deceased'

A client who hasn't exited is listed as "Currently active in *their-program-type* program"
