COUNT 1

I, Mary E. Robnett, Prosecuting Attorney for Pierce County, in the name and by the authority of the State of Washington, do accuse IVEY MARIE LEWIS of the crime of MURDER IN THE FIRST DEGREE, committed as follows:

That IVEY MARIE LEWIS, in the State of Washington, on or about the 12th day of February, 2023, did with premeditated intent to cause the death of another person, cause the death of such person or a third person, P. L., a human being, on or about the 12th day of February, 2023, contrary to RCW 9A.32.030(1)(a), AND FURTHERMORE, the Defendant did commit the above crime against a family or household member; contrary to Revised Code of Washington 10.99.020(7). "Family or household members" means adult persons related by blood or marriage; adult persons

1 who are presently residing together or who have resided together in the past; and/or
2 persons who have a biological or legal parent-child relationship, including stepparents
3 and stepchildren and grandparents and grandchildren., and the crime was aggravated
4 by the following circumstances: pursuant to RCW 9.94A.535(3)(h) The current offense
5 involved domestic violence, as defined in RCW 10.99.020, and one or more of the
6 following was present: (i) The offense was part of an ongoing pattern of psychological,
7 physical, or sexual abuse of the victim manifested by multiple incidents over a
8 prolonged period of time; (ii) The offense occurred within sight or sound of the victim's
9 or the offender's minor children under the age of eighteen years; or (iii) The offender's
10 conduct during the commission of the current offense manifested deliberate cruelty or
11 intimidation of the victim, and against the peace and dignity of the State of
12 Washington.

13 COUNT 2

14 And I, Mary E. Robnett, Prosecuting Attorney for Pierce County, in the name and by
15 the authority of the State of Washington, do accuse IVEY MARIE LEWIS of the crime
16 of MURDER IN THE SECOND DEGREE, a crime of the same or similar character,

18 or constituting parts of a single scheme or plan, and/or so closely connected in respect
19 to time, place and occasion that it would be difficult to separate proof of one charge

22 February, 2023, did with intent to cause the death of another person, cause the death
23 of P.L, a human being, on or about the 12th day of February, 2023, contrary to RCW
24 9A.32.050(1)(a), AND FURTHERMORE, the Defendant did commit the above crime
25 against a family or household member; contrary to Revised Code of Washington
26 10.99.020(7). "Family or household members" means adult persons related by blood

1 or marriage; adult persons who are presently residing together or who have resided
2 together in the past; and/or persons who have a biological or legal parent-child
3 relationship, including stepparents and stepchildren and grandparents and

25 participant in said crime, on or about the 12th day of February, 2023, contrary to RCW
26 9A.32.050(1)(b), AND FURTHERMORE, the Defendant did commit the above crime

1 against a family or household member; contrary to Revised Code of Washington
 2 10.99.020(7). "Family or household members" means adult persons related by blood
 3 or marriage; adult persons who are presently residing together or who have resided
 4 together in the past; and/or persons who have a biological or legal parent-child
 5 relationship, including stepparents and stepchildren and grandparents and
 6 grandchildren., and the crime was aggravated by the following circumstances:
 7 pursuant to RCW 9.94A.535(3)(h) The current offense involved domestic violence, as
