The messages were discovered on 02/08/2023 by the victim's mother, and she contacted law enforcement on 02/09/2023. Your Affiant met with the victim's mother and obtained a consent to search for the victim's cellphone, which she purchased for permission to assume online presence in order for the affiant to pose as the victim and continue communication with the defendant. While your affiant was reviewing the messages on the Snapchat application, the following messages were observed between the victim and the defendant "send me the ass pic. Showing hole (go on hanging). "One time fuck? for \$65? "3 times fucking with you and I'll send the 60. "I want this: you undressing, keep the boxer and nipple play, getting naked, playing with your and ass. The use anything as dildo and fuck your ass, I wanna see that hole getting again, show armpits, lips come nipple legs period and want them as yids no fucked, play with your snaps". The victim identified the defendant via his FL DL. On 2/9/2023, at approximately 2100 hours. Detectives responded to the defendant's residence where he was taken into custody and in the possession of his cell phone. During his arrest, the defendant pulled his hand away from the detectives and attempted to run inside the residence to avoid arrest. The detectives escorted him to the ground in order to affect the arrest. A controlled phone call was made to the defendant's Snapchat account from the victim's Snapchat account. During the controlled call. The defendant's phone displayed an incoming Snapchat call from the victim's account. Post arrest, the defendant invoked his Miranda Rights and refused to provide a statement. A court authorized search warrant was obtained and provided to the defendant, where the defendant was to divulge his passwords for his electronic devices per the judge's order, but he refused to do so.
