The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

Between May 2021 and March 2022, the defendant and the victim engaged in multiple sexual encounters to include sexual intercourse and oral sex in various locations within Hillsborough County. The victim and the defendant also exchanged in several sexual explicit photographs/videos of each other via social media. The victim is currently [REDACTED] and has been sexually active with the defendant since [REDACTED]. The victim informed the defendant of [REDACTED] age and the defendant responded "I don't care" upon learning the age. The defendant willingly exchanged US currency and/or gift cards in exchange for the sexual acts and/or photographs. The conversations were recovered on the victims cellphone phone and

took place via Snapchat and Sniffies social media platform, where they originally met each other in May 2021. The messages were discovered on 02/08/2023 by the victim's mother, and she contacted law enforcement on 02/09/2023. Your Affiant met with the victim's mother and obtained a consent to search for the victim's cellphone, which she purchased for [REDACTED] along with permission to assume online presence in order for the affiant to pose as the victim and continue communication with the defendant. While your affiant was reviewing the messages on the Snapchat application, the following messages were observed between the victim and the defendant "send me the ass pic. Showing hole (go on [REDACTED] hanging). "One time fuck? for \$65? "3 times fucking with you and I'll send the 60. "I want this: you undressing, keep the boxer and nipple play, getting naked, playing with your [REDACTED] and ass. The use anything as dildo and fuck your ass, I wanna see that hole getting fucked, play with your [REDACTED] again, show armpits, lips coma nipple legs period and [REDACTED] I want them as vids no snaps". The victim identified the defendant via his FL DL.

On 2/9/2023, at approximately 2100 hours, Detectives responded to the defendant's residence where he was taken into custody and in the possession of his cell phone. During his arrest, the defendant pulled his hand away from the detectives and attempted to run inside the residence to avoid arrest. The detectives escorted him to the ground in order to affect the arrest. A controlled phone call was made to the defendant's Snapchat account from the victim's Snapchat account. During the controlled call, The defendant's phone displayed an incoming Snapchat call from the victim's account.

Post arrest, the defendant invoked his Miranda Rights and refused to provide a statement. A court authorized search warrant was obtained and provided to the defendant, where the defendant was to divulge his passwords for his electronic devices per the judge's order, but he refused to do so.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
