	stated Dakota forcibly kicked-in the f	
making entry to the secon	nd-floor apartment. Hector stated Da	kota was then warned not to
enter any further advising	g "don't come in, we are going to sho	ot you".

Dakota then exited the residence, advising "I'm going to come back the residence (2) times following the incident. While driving past the second time, Dakota fired two rounds at the occupied structure from his vehicle. At this time, occupants of the residence returned fire, firing an estimated (18) rounds.

Through our investigation, it was determined Dakota arrived at the residence with a firearm to "confront" the occupants. Dakota kicked in the entry door and proceeded inside the structure with the intent to commit a crime, and Dakota fired (2) pistol rounds at the structure, which he knew to be occupied. Based upon these facts, I request an arrest warrant be issued for Dakota W. Kjellerson (for the below charges.
