COMPLAINT {Article 15.04, Texas Code of Criminal Procedure}

BEFORE ME, THE UNDERSIGNED AUTHORITY, PERSONALLY APPEARED THE AFFIANT HEREIN, A PEACE OFFICER UNDER THE LAWS OF TEXAS, WHO, BEING DULY SWORN, ON OATH MADE THE FOLLOWING STATEMENTS AND ACCUSATIONS:

My name is **Mark Morales** and I am commissioned as a peace officer by The City of San Antonio. I hereby state upon my oath that I have reason to believe and do believe that heretofore, and before the making and filing of this Complaint, that

Defendant: Rodolfo Valdivia Aceves (H/M 11/24/2002)

On or about the 24th day of June 2022, in Bexar County, Texas, did then and there commit the offense of **Terroristic Threat** against the laws of the State of Texas.

My probable cause for said belief and accusation is as follows:

A victim in this case has been identified as **Amazon Delivery Station**, a business that fulfills orders for online purchases. The victim, hereinafter referred to as the Complainant, is further identified as Amazon DSX7.

An actor in this case has been identified as *Rodolfo Valdivia Aceves*, a Hispanic male born on November 24, 2002. The actor, hereinafter referred to as the defendant, is further identified in the computer files of the San Antonio Police Department under SID number 1165367.

A witness in this case has been identified but will not be named in this affidavit as they fear for their safety. The identity of this witness will be revealed at the request of this magistrate in private. This witness will hereinafter be referred to as Witness 1.

The information contained in this affidavit is based on the affiants training and experience, my participation in the investigation, and information received from other law enforcement officers and witnesses which I believe to be credible. Because this affidavit is being submitted for a limited purpose, I have set forth only those facts necessary to establish probable cause for the warrant. Except where otherwise indicated, all statements referred to herein are set forth in substance and in part, rather than verbatim and in full.

MM 2001

On Tuesday 27h of June 2022, San Antonio Police Officers from the South Patrol Service Area were dispatched to 8210 Sous Vide Way, an Amazon Delivery Station, for a threats report. The incident was carried under SAPD22136986. When officers arrived, they found that a sub-contractor to the facility had made some remarks to another employee that were disturbing. Officers then transported the witness to the San Antonio Police Department Homicide Office.

MAZM

On Thesday 27h of June 2022, your affiant obtained a video/audio statement from the witness. The witness states that on Friday 24th of June 2022, a fire alarm went off at the complainant's address. The witness, as well as all employees, exited the building. The witness was standing next to the defendant when the defendant stated to the witness that it would be a good idea to pull the fire alarm and have all employees exit the building and to commit a mass shooting. The witness was surprised by the statement. The defendant then said that he will be doing it and he would commit a mass shooting. The witness feared retaliation and chose not to tell her superiors of what the defendant had stated. The witness came forward today and finally told her superiors as she states the defendant is capable of committing a mass shooting. The witness then began to tell me of other comments the defendant has made in the past. The witness then recalls a time when she gave the defendant a ride from work. She told the defendant that she had to pick her children up first. The defendant then stated he would now know what school to go to and shoot up the school. The witness then brought up the Uvalde School Shooting. The defendant told the witness that the shooter in that incident was an idol. Throughout the statement, the witness was very scared of the defendant. The defendant has told the witness in the past that he is tired of living. The defendant also told the witness that he owns a handgun and a rifle he purchased a few months ago.

WW SWM

On rusday, 27h of June 2022, the father of the defendant came into the Homicide Office where your affiant obtained a video/audio statement. The father of the defendant states that the defendant has had mental illness in the past. The father had placed the defendant in a mental health facility twice at the age of 16. The father states that the defendant was prescribed medication but stopped taken the medications after two years. The father found out recently that the defendant purchased an AR platform rifle. The father states that he and his family are scared knowing the defendant has a weapon and knowing the past behavior of the defendant.

Therefore, your affiant believes the defendant threatened to commit an offense involving violence to the complainant and their employees with intent to place a substantial group of the public in fear of serious bodily injury. Your Affiant respectfully requests that a warrant be issued for the arrest of the defendant Rodolfo Valdivia Aceves charging him with the felony criminal offense of Terroristic Threat, in violation of section 22.07 (a) (5) of the Penal Code of the State of Texas.
