MONTREAL, March 7, 2013 - UPAC confirms that Luigi Coretti will appear today for breach of recognizance after contacting a witness involved in his case. His arrest in connection with his breach of recognizance was made earlier this morning by the Corruption Investigation Service of the Sûreté du Québec.

Recall that Luigi Coretti is currently facing charges of fraud, forgery and use of forgery, and that an undertaking had been signed by the accused at the time of his release on June 26, 2012.

UPAC will not issue any further comments in this case.
