- No movement permitted if vision is restricted to less than 1000' by inclement weather. HEADLIGHTS MUST BE ON AT ALL TIMES.
- Maximum highway speed is the posted speed, subject to seasonal restrictions.

- Overall width of tractor or truck shall not exceed 8'6". 7.
- Movement is subject to seasonal weight restrictions when in effect at the time of travel. Lift axles in the drive group will NOT be counted when computing legal weight or weight @ 125%. See Current Weight Restrictions.
- Actual weight for a non-divisible load shall NOT exceed 125% of legal tire loading, axle (group)1, or gross weight. A single detached appurtenance may be carried on the same semitrailer or trailer if it is for the same make and model of equipment being transported. Must NOT cross any bridge with posted limits. Must not cross Port Access Bridge in Anchorage. Must not travel through Whittier Tunnel.
- 10. Time of movement is daylight hours.
- 11. May also travel during hours of darkness following all applicable requirements specified in 49 CFR 390-396, 13 AAC 04.010-145 and the State of Alaska Administrative Permits Manual Section 13.
- 12. Must have clearly readable OVERSIZE signs on the front and rear.
- 13. Must have a roof-mounted (or mounted at roof height) rotating or flashing amber beacon.
- 14. Red or fluorescent orange flag (16" square) on end of overhang.
- 15. DO NOT TRAVEL UNDER ANY OVERHEAD STRUCTURE POSTED AT LESS THAN 15' IN HEIGHT.
