This is an appeal under the Freedom of Information Act (FOIA) on behalf of Karen Lowy and Daniel Jaffe, victims of the April 22, 2022 shooting that took place at/around Edmund Burke School in Northwest Washington D.C. (the "Shooting"). The FOIA request that I submitted on behalf of Ms. Lowy and Mr. Jaffe to the Federal Bureau of Investigation ("FBI") on July 28, 2022 (the "Request") was assigned four identification numbers by the FBI: 1577989-000 (Subject: Jaffe, Daniel Mark); 1577990-000 (Subject: Lowy, Karen); 1554681-000 (Subject: Jaffe, Daniel)¹; and 1554680-000 (Subject: Spencer, Raymond). I received responses to the Request in substantively identical letters from the FBI dated January 11, 2023, which refused, in response to request numbers 1577989-000 and 1577990-000, to release any records about my clients to my clients based on claimed personal privacy exemptions.²

I. Background Of The Request & The FBI's Blanket Denial.

The Request sought records concerning several categories of documents relating to the Shooting, including (i) documents and information related to any weapons used by or in the suspect Raymond Spencer's (the "Suspect") possession and recovered in connection with the incident; (ii) documents and information related to any ammunition used by or in the Suspect's possession and recovered in connection with the Shooting; (iii) documents and information related to any other equipment used by or in the Suspect's possession and recovered in connection with the Shooting, including but not limited to supposed "sniper nest" equipment, M-Lok, high-capacity drum, rifle scope and tripod to prop the weapons, recovered in connection with the incident; (iv) documents and information concerning the Shooting and the Suspect collected from or provided by the Ava Van Ness; (v) documents and information collected, received, and/or provided by any other law enforcement agency to the FBI in connection with the FBI's investigation into the Shooting and the Suspect; (vi) all video and body cam footage obtained in connection with the investigation into the Shooting and/or filmed by any law enforcement agency during the incident; and (vii) all reports and summaries generated by the FBI or by other law enforcement agencies and subsequently provided to or shared with the FBI in connection with the investigation into the Shooting or Suspect. See Exhibit A (FOIA

Request).

Though information about Ms. Lowy and/or Mr. Jaffe may appear in records responsive to the Request because Ms. Lowy was one of the survivors of and was gravely wounded during the Shooting, the Request did not explicitly seek information about Ms. Lowy and Mr. Jaffe. In fact, Ms. Lowy and Mr. Jaffe are only mentioned in the Request as my clients on whose behalf the Request is made. See Ex. A.

In response to correspondence with and a request from the FBI's FOIPA Questions (FOIPAQUESTIONS@FBI.GOV) email address, I submitted the U.S. Department of Justice's Certification of Identity Forms for Ms. Lowy and Mr. Jaffe on January 6, 2023 and stated that my clients "provid[e] authorization to release any records pertaining to them." See Exhibit B (Jan. 6, 2023 Email).

Nevertheless, on January 11, 2023, the FBI denied the Request as it pertains to my clients in its entirety on the basis that the "requested records [concern] . . .one or more third party individuals." The FBI thus refused to confirm or deny the existence of such records under 5 U.S.C. § 552(b)(6) and (b)(7)(C) which, per the FBI's denial letter, exempt from disclosure records that "could reasonably be expected to constitute an unwarranted invasion of personal privacy." See Exhibit C (Jan. 11, 2023 FOIA Denial Letters).

II. There Is A Strong Public Interest In The Information Sought By The Request.

The public has a strong interest in accessing the information sought in the Request, which pertains to a high-profile mass shooting that directly impacted my clients and implicates the public safety of District of Columbia residents, visitors, and workers.

The Request at issue was made on behalf of victims of the Shooting—one of whom was shot multiple times and gravely injured. Her life and the lives of her family members will never be the same as a result. Tragically, this is the case for millions of Americans. Ms. Lowy and Mr. Jaffe have a particularly strong interest in the disclosure of the information sought in the Request as they navigate and grapple with the aftermath of the Shooting. CDC data show that guns are now the leading cause of death of children in America. More than 20,000 people were killed by firearms in each of 2021 and 2022—and tens of thousands more died by suicide using a firearm. There already have been more than 4,000 gun-related deaths in 2023, and we are only a month into the year. So far this year, there have been more mass shootings in America than there have been days. And in addition to the tens of thousands of people killed by guns in the United States every year, there are many thousands more victims of gun violence—like my clients and their family—who suffer serious and long-lasting physical and emotional trauma. The gun violence epidemic has also been an area of focus for the U.S. House Oversight Committee, which has investigated and held several hearings on the issue of gun violence in the United States this summer alone on the practices and

profits of gun manufacturers. ⁷ In sum, this is an issue of immense public interest and importance.

III. The FBI Has Failed to Carry Its Burden To Justify Denial Of The Request Under The Personal Privacy Exemption.

The FBI cannot properly withhold these records on the basis that disclosing documents responsive to the Request would "constitute an unwarranted invasion of personal privacy." See Ex. C (Jan. 11, 2023 FOIA Denial Letters). The "subjects" of these request numbers—Ms. Lowy and Mr. Jaffe—are the individuals making the Request and have provided identity certification forms authorizing the release of any information about them. Notwithstanding that the deceased shooter, Raymond Spencer, is the subject of a different request number, whatever minimal privacy interest he may retain after death plainly does not outweigh the interests of the living victims of the Shooting. See, e.g., McDonnell v. United States, 4 F.3d 1227, 1255 (3d Cir. 1993) (finding "no competing privacy interest" where individual at issue was deceased).

IV. The FBI Has Failed To Carry Its Burden To Justify Denial Of The Request Under Exemption (b)(7)(C).

FOIA mandates that "[a]ny reasonably segregable portion of a record shall be provided . . . after deletion of the portions which are exempt." 5 U.S.C. § 552(b). While there may be some narrow portion of the FBI's investigative file that is properly subject to withholding on the basis of personal privacy concerns of victims other than my clients and other witnesses, the exemption the FBI has invoked does not justify blanket withholding of *all* information pertaining to the investigation into this high-profile Shooting.

Even if the FBI is concerned about privacy interests of third parties other than my clients (who, as discussed above, have consented to the release of any information about them), the lack of privacy interests sufficient to justify withholding of the entire file is underscored by the fact that there is information concerning the Shooting and Spencer already in the public domain, including through several briefings and press conferences provided by various law enforcement agencies in the days following the Shooting. It thus is necessarily the case that there is information in the investigative file that is not properly subject to withholding. In fact, the Fairfax County Police Department, which was also involved in responding to and investigating the Shooting, agreed to (and did) turn over its entire investigative file in response to a Virginia FOIA request similar to that at issue here, mitigating privacy concerns by applying limited redactions to names and addresses. See Exhibit D (Fairfax County PD FOIA Response).

To justify the withholding of any information pursuant to 5 U.S.C. § 552(b)(7)(C), an agency and any reviewing court must "weigh the public interest in the release of information against the privacy interest in nondisclosure." See U.S. Dep't of Just. v. Reporters Comm. for Freedom of the Press, 489 U.S. 749, 762 (1989). This weighing "requires the courts to balance the competing interests in privacy and disclosure." Judicial Watch, Inc. v. Nat'l Archives & Records Admin., 876 F.3d 346, 349 (D.C. Cir. 2017) (quoting Nat'l Archives & Records Admin. v. Favish, 541 U.S. 157, 171 (2004)). As explained, the FBI has claimed to invoke this exemption on my clients' behalf to avoid disclosing any information contrary to the wishes of the very people whose interests it claims to be asserting and in spite of the public interest in disclosure of information about this mass shooting.

My clients were told in June 2022 by a D.C. Metropolitan Police Department Detective that several of the law enforcement entities involved in responding to and investigating the Shooting had completed their investigations and their written reports, but they have not been provided these reports or any other additional information since then. They are – understandably – heartbroken and frustrated at the lack of cooperation they have received from the FBI and other law enforcement agencies in getting information about what happened to them. They deserve answers to their questions.

- Documents and information related to any ammunition used by or in the Suspect's
 possession and recovered in connection with the Incident, including documents
 concerning: (i) the make and model of any such ammunition; (ii) whether any of this
 ammunition was confirmed to have been discharged during the Incident; and (iii) the
 sale or purchase of any of this ammunition, including dates of purchase(s), sales
 receipts and/or invoices or purchase orders, location of purchase(s) and name of seller
 or retailer, price and/or purchase amounts, and method of payment.
