## **Re: FOMB Response to various Budgetary Reprogramming Requests**

Dear Mr. Blanco,

This letter is in response to various budgetary reprogramming requests submitted by various government agencies through the Office of Management and Budget ("OMB") to the Financial Oversight and Management Board ("FOMB") for review and approval. The following agencies' requests are resolved herein:

### A. Prior Year Fund Releases

The following tables list the previous year's unused balance release requests considered in this letter. The following agency requests are resolved herein:

1. <u>2023-53111 Department of Natural and Environmental Resources (050)</u> – Requests a prior year fund release from the environmental emergency fund to cover several unexpected environmental emergencies.

These expenses include the purchase of materials and supplies, as well as food and equipment for the kitchen.

### C. Closed Budgetary Reprograming Requests

The following government agencies did not submit the additional information requested during the review process or did not submit enough information to provide a decision on a timely basis. Therefore, these reapportionment requests will be marked as incomplete and closed by the FOMB.

<u>2023-52193 Puerto Rico Technology and Innovation Services (271)</u> – Requests a reapportionment of \$750,000 within Payroll and Related Costs concept; from salaries to hire 9 transitory positions for Roosevelt Roads data center project and salaries to hire regular vacant positions object costs to salaries for trust employees to cover a projected overspend of \$478K under salaries for trust employees and hire 8 vacant trust positions with new salary scales.

Observation: This request to implement new salary scales requires further review and analysis from the Office of the Administration and Transformation of Human Resources ("OATRH") and the OMB to ensure a level of uniformity and consistency throughout the Government. Given the time required for OATRH and OMB to complete these processes, the Oversight Board has determined to close this budgetary request. Upon receipt of the supporting documents and approvals for the new salary scales, the Agency may resubmit the budgetary reprogramming request for review and approval of the Oversight Board.

Furthermore, OMB should allocate the above-mentioned amounts to the appropriate PRIFAS accounts and communicate their current budgetary allocations by cost object to the agency.

We trust the foregoing answers all included requests and look forward to continuing our work together for the benefit of the people of Puerto Rico.
