## AFFIDAVIT FOR PROBABLE CAUSE

STATE OF INDIANA, COUNTY OF MARION, SS:

JAMAL ABDULLAH SWEARS OR AFFIRMS THAT HE BELIEVES OR HAS GOOD CAUSE TO BELIEVE THAT; On Monday 7-12-98, at approximately 2322 hours, I was on the academy apartment's walkway, 1350 North Meridian Street speaking with the security officer, David L. Irwin, and security officer, Derald K. Cooper, when I observed African male, later identified by his Indiana State ID Card as Joseph M. Webster, date of birth \_\_\_\_\_\_, SSN \_\_\_\_\_\_ walk out from inside the apartment building. When Mr. Webster walked approximately 10 feet from us, I observed Mr. Webster reach inside his jacket and I observed a handgun fall from his person. I observed Mr. Webster bend over to pick up the weapon.

At that time, I drew my weapon from my holster and ordered Mr. Webster to back away from the weapon he dropped. Mr. Webster being argumentative and uncooperative. Mr. Webster was shouting I was making a mistake. He repeatedly shouted he had a gun permit. I observed Mr. Webster take off the black jacket with two white stripes on each sleeve and lay it behind him in the grass. I observed Mr. Webster take off his black shoulder holster and lay it beside the jacket in the grass. I placed handcuffs on Mr. Webster for my safety and security officer Irwin and security officer Coopers safety.

Through my investigation Mr. Webster was unable to pro-

Don's Guns. I arrested Joseph M. Webster for carrying a handgun without a license. I read Mr. Webster Miranda warning. He stated repeatedly he understood his rights.

During a search incident to arrest, I recovered a black arch Motorola pager and a light blue pager on Mr. Webster's gym shorts. I recovered inside his right sock \$65. The Jennings firearm 380 automatic pistol, serial number 885202, I recovered it off the walkway where Mr. Webster dropped it. I recovered in the grass a black shoulder holster and a sonic enterprise LTD XXL jacket where Mr. Webster placed it.

I had A349, officer Robert Stradling, do a search incident to arrest on the jacket Mr. Webster had on, before I released it to his uncle on the scene. During Officer Stradling's search, he recovered a black audiovox handheld phone, serial number 17400779581, in the right front pocket. He recovered a clear plastic sandwich bag with a white hard substance inside the right chest pocket. During my investigation, I counted 24 small individually wrapped hard white substance and one white powdery substance, wrapped in clear plastic. Due to my training and experience as a law enforcement officer, I suspected to be cocaine. Add the additional charges of Dealing Cocaine with a firearm, Possession of Cocaine.

All evidence was transported to the property room by Officer Abdullah, narcotics placed in a heat sealed envelope and placed inside the narcotics drop box.

The suspected substance tested positive as cocaine in the amount of 4.49 grams by chemist Linda McCready.
