Guidance Regarding the Search & Processing of Requested Records

In connection with my request for records, I provide the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- My request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, my request includes all previous messages sent or received in that email chain and any attachments.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA². It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; I have a right to records contained in those files, even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.³

- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to governmentwide requirements to manage agency information electronically⁴, and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, the Preservation of Electronic Messages and Other Records Act, 44 U.S.C. § 29, § 33, or similar mandates and policies. My office received your FOIA/Privacy Act (PA) request on December 28, 2022 (see attached). We asked the Information Technology Division (TC) to search the email accounts of eleven current or former DEA employees provided in your request letter. As provided in your letter, the search excluded emails sent to or received by Kevin Byrnes. We also asked the Office of Professional Responsibility to conduct a search for shared drive records which may be responsive to your request.

TC has advised us that their preliminary search yielded approximately 10,000 pages of *potentially* responsive records. Approximately 900 pages of the records are calendar entries. TC also indicated that the search has exhausted server space availability due to the large dataset and date range for record search. As such, I am reaching out to see if you'd be interested in narrowing the scope of your request or could provide more specific search terms. This will enable us to conduct a more effective record search. It will also reduce the amount of time it will take our office to process your FOIA request.

Please note, DEA ranks in the top six of all Department of Justice (DOJ) components for the number of FOIA requests received per year, and we have limited resources to process requests. See DOJ Annual FOIA Reports
