The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 11 day of APRIL, 2023

at approximately 3:30 PM, at [REDACTED], in Pinellas County did:

UNLAWFULLY, BY AN ACT IMMINENTLY DANGEROUS TO ANOTHER, AND EVINCING A DEPRAVED MIND REGARDLESS OF HUMAN LIFE, BUT WITHOUT A PREMEDITATED DESIGN TO EFFECT THE DEATH OF VICTIM, A HUMAN BEING, DID CHOKED THE VICTIM, WITH HER HANDS, THEREBY INFLECTING UPON THE VICTIM MORTAL WOUNDS, OF WHICH SAID MORTAL WOUNDS, AND BY THE MEANS AFORESAID AND AS A DIRECT RESULT THEREOF, THE VICTIM DIED.

ON APRIL 11, 2023 AT APPROXIMATELY 15:26, THE DEFENDANT CALLED 911 AND STATED SHE HAD JUST "KILLED" THE VICTIM. THE DEFENDANT ALSO STATED ON A THAT SHE HAD "CHOKED" THE VICTIM. OFFICERS RESPONDED TO THE INCIDENT LOCATION TO DISCOVER THE DECEASED VICTIM LAYING ON THE FLOOR JUST INSIDE THE FRONT DOOR. THE VICTIM APPEARED TO HAVE INJURIES CONSISTENT WITH THE DEFENDANTS STATEMENTS.

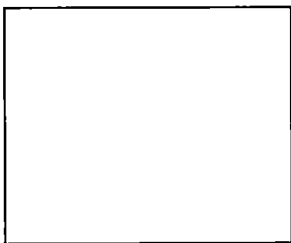
