R/O was dispatched to 999 Civic Center Dr. (Niles Senior Center) for a Trespassing complaint on the third floor (Niles Family Services). While en route R/O was advised by Niles Dispatch that a subject, Carol JOHNSON, who was previously arrested for Trespassing was inside the building. Upon arrival R/O's were directed to the third floor and were advised that JOHNSON was located there. After reaching Family Services R/O spoke with the Complainant Nicole ESPINOZA. ESPINOZA advised that JOHNSON had come into the building looking for clothing after not being able to retrieve her belongings from NPD. ESPINOZA advised JOHNSON several times that she had been banned from the property, ESPINOZA advised JOHNSON would not leave. R/O was advised by Niles Dispatch that JOHNSON had been arrested by NPD on 08/24/17 for Criminal Trespass (N#2017-25871). ESPINOZA advised she would sign Complaints for Criminal Trespass. R/O'S escorted JOHNSON to the first floor and outside the building at which point she was placed under arrest for Criminal Trespass to Property. JOHNSON advised she had shoulder problems and would be uncomfortable with her hands being handcuffed. R/O linked two sets of handcuffs together then placed them on JOHNSON, checking them for fit and double locking them. R/O asked JOHNSON if her shoulders were comfortable in that position, she advised they were.

R/O transported JOHNSON back to NPD for printing and processing. At NPD Skokie Police Officer CABRERA #252 arrived for a search of JOHNSON. JOHNSON was placed into cell 1B10 for A.M. Bond hearing. Her initial court date will be 10/2/17 Room 101 at 0900hrs (H-1 Misdemeanor Key). JOHNSON'S property will be inventoried at NPD for safekeeping.
