Dear Immigration Officer:

I am an attorney in Seattle, Washington, and I represent the above-named person. My G-28 is on file with your office.

On March 25, 2022, I made a request for the OBIM records of my client Maria del Sagrario Martinez Rodriguez (A# 219-101-664). We received the response to that request on April 25, 2022.

Pursuant to 6 C.F.R. § 5.8, we now appeal the FOIA disclosure of April 25. In particular, we believe the photographs pertaining to all of the documented encounters should be released.

The released records document 7 encounters, each with its own encounter ID number. However, of those 7 encounters, the released records only include 2 photographs – for encounter IDs 5489629644 and 6908348185. The other 5 lack a corresponding photograph.

We request that, on appeal, your office review these records and release the photographs corresponding to the other 5 encounters. We believe that some, if not all, of these photographs are in the possession of the government. In particular, we know that there is a photograph relating to encounter ID number 3303201. This is because, when making a FOIA request with the USCIS, the attached document – with a photograph of this encounter – was released to us. However, the copy of the photograph is of poor quality, so we cannot make out the person in the photograph. We therefore request that, when releasing that photograph, your office provide a color copy of it so we are able to discern the identity of the person in it.

We believe that other of the encounters should also have related photographs. And in order to


