AFFIDAVIT OF SPECIAL AGENT ADAM BRUFLAT IN SUPPORT OF CRIMINAL COMPLAINT

I, Adam Bruflat, being duly sworn, state:

- 1. I am a Special Agent with the Federal Bureau of Investigation ("FBI") and have been since September 2021, and I am a "federal law enforcement officer" within the meaning of Federal Rules of Criminal Procedure 41(a)(2)(C). I received basic law enforcement instruction at the FBI Academy from approximately September 2021 through February 2022. During that time, I received training in a variety of investigative techniques and legal matters, including topics on Fourth Amendment Searches, the drafting of search warrant affidavits, and probable cause. I have been assigned to the FBI's Violent Crimes Squad in Fresno, CA since March 2022. I have been employed by the FBI since June of 2017. After initially working as a member of the clerical support staff, I was promoted to Tactical Analyst. While employed as a Tactical Analyst and clerical support staff, I worked various cases and assignments including Iranian and Russian Counter-Intelligence matters, kidnapping, bank fraud, wire fraud, and drug trafficking.
- 2. Since 2021, I have been employed as a Special Agent for the FBI. Upon being hired as a Special Agent with the FBI, I attended the FBI Academy in Quantico, Virginia where I received extensive training on investigating various violations of federal law. Currently, I am assigned to the Sacramento Field Office, Fresno Resident Agency Violent Crimes Squad, where I have worked a variety of cases, including child sexual exploitation, gang violence, narcotics investigations, burglary, kidnap for ransom, and unlawful flight to avoid prosecution cases. Additionally, I am assigned to assist the Fresno Internet Crimes Against Children and have worked a myriad of cases involving child sexual exploitation, child pornography, and online enticement. I possess a Bachelor of Science in Criminal Justice Institutional Theory from John Jay School of Criminal

Justice and a Master of Science in Global Affairs-Transnational Security from New York University.

3. The statements in this affidavit are based in part on information provided by other law enforcement agents, as well as my own investigation of this matter. Because this affidavit is being submitted for the limited purpose of securing an arrest warrant, I have not included every fact known to me concerning this investigation. I have set forth facts that I believe are necessary to establish probable cause to believe that Rodger GITHENS has violated 18 U.S.C. § 2252(a)(2) for receipt and distribution of images of a minor engaging in sexually explicit conduct.

STATUTORY AUTHORITY

4. 18 U.S.C. § 2252(a)(2) prohibits receipt and distribution of images of a minor engaging in sexually explicit conduct if the offense is committed using any means or facility of interstate or foreign commerce.

PROBABLE CAUSE

- 5. The FBI began investigating **GITHENS** for online enticement of a minor, and the attempt to commit this offense, because he demonstrated his desire and intent to travel to Fresno, California to engage in sexual activities with someone he believed to be a minor. **GITHENS** began engaging in online chats on the application Grindr with an FBI Online Undercover Employee (OCE) on March 25, 2023. The OCE created an undercover account on Grindr¹ with a profile for a 30-year-old white male, located near Fresno, California, who was a "taboo²-friendly" uncle. Additionally, the OCE placed "tags" on the account such as "dirty, discreet, curious, and parent".
- 6. Within one hour the OCE was contacted by a profile on Grindr labeled "Tall laid back" (referenced below as TARGET GRINDR ACCOUNT or TGA). The

¹ Grindr is described online as a location-based social networking and online dating application targeted towards members of the gay, bisexual, transgender, and queer community.

² Taboo is considered to be sexual activity that is forbidden or not talked about publicly, such as incest, rape, or sex with a minor.

TGA had profile information such as: height 6'4", weight 240lbs., ethnicity white, and an age of 44 years old. The TGA initiated messaging with the OCE by sending, "Hi how's it going?". It should be noted that Grindr notifies a user how another user found them on the application. The TGA identified the OCE Grindr account by searching for the tag "Parent". Conversation between the OCE and target Grindr account continued with both discussing what they were into and looking for. The target Grindr account identified as a 45-year-old, white male, living in Sacramento, CA. Additionally, the subject identified himself as "Tod", who loved "Taboo" and was "with a guy". Shortly after contacting the OCE on Grindr, the TGA requested the OCE download the Session or Telegram³ messaging service as they are considered more secure.

Telegram Chats with User: wiy300

- 7. The OCE agreed to download Telegram, and the conversation soon continued via the Telegram application. The OCE created a Telegram account with the username "mikeyp559x" and the user from the TGA messaged the OCE via Telegram with username "wiy300" (Target Telegram Account or TTA). The OCE and user of the TTA (later confirmed to be **GITHENS**) continued messaging via Telegram. The OCE revealed to the user of the TTA that the OCE had a 7-year-old niece with whom he was sexually active. The TTA continued communication with the OCE on a reoccurring basis over the course of several days. Pertinent portions of those conversations are provided below:
 - 8. Initial Telegram conversation: March 25, 2023:

9. The above conversation continued and OCE explained to the TTA that he had a 7-year-old niece that he had been sexual with and occasionally babysat when her mom was working. The user of the TTA explained that he loved "little puffy pussy lips" and would "love to have a dad or uncle invite me". During the conversation, TTA explained that he was 45 years old and lived in Sacramento, California. The user of the TTA said he was married to a 35-year-old Mexican man who was his Spanish tutor when they met. The user of the TTA described his work as "consulting" and that he would explain more when he met OCE in person.

10. The Telegram conversation excerpted below occurred on March 25, 2023:

11. The above conversation continued and TTA explained that he nearly had sexual contact with a one-year-old boy connected to his godfather. TTA met a man on Grindr and had agreed to meet him in Hawaii and have sexual contact together with his one-year-old godson. But due to Covid-19 travel restrictions, the trip never took place.

12. On March 26, 2023, Telegram messaging between the TTA and OCE resumed. The user of the TTA revealed additional information about his husband. The TTA user stated that his husband was into "young" (as young as 8 years-old) as well and had been with as young as 13 years-old. The TTA user reiterated that his husband was 35, Mexican, and they had been together for 13 years. The TTA user explained that he believed kids were "property," and that it used to be what your kids could do for you. The TTA user explained that he was originally from the Midwest and had traveled to Mexico before. Additionally, the TTA user reiterated in the below conversation that he had past sexual contact with minors:

wiy300	You ever done light touching with any other kids?
OCE-12020	None except my niece. Not saying I wouldn't. But don't get much opportunity.

OCE-12020	Did he like it?

13. Continued Telegram conversation on 26 March 2023:

14. Continued Telegram conversation on 26 March 2023

wiy300	You spoil her with gifts I bet

OCE-12020	She's 7

15. Later that same day, March 26, 2023, the TTA user described to the OCE how he wanted to feel her (OCE's 7 year-old niece) "getting wet" and instructed OCE that he should, "try to get her to orgasm. I know boys that young can. They moan and stuff. Shake etc. Dry cum". TTA continued to elaborate on the sexual nature of children:

Stair: Shake etc.	by cam: 1111 continued to chaorate on the sexual nature of children.
wiy300	Yeah little kids are so sexual
wiy300	Society just tries to hide it
OCE-12020	I think she could probably take my cock. I've just been scared to
OCE-12020	Are you well hung?
wiy300	Yeah I'm sure. You need to before she can get pregnant
wiy300	I'm not. U?
OCE-12020	Yeah 100%
OCE-12020	Above average haha
wiy300	Nice how big?
OCE-12020	Just making sure you wouldn't kill her haha

16. On March 27, 2023, the TTA user messaged the OCE and explained that he had a friend over at his house and would be too busy to message. The TTA user then explained the background of his friend:

17. The following day, March 28, 2023, the TTA user continued his Telegram

message conversation with the OCE:

OCE-12020	You mentioned you had heard about that in Mexico. But that was about it
OCE-12020	What happened
wiy300	This was in Mexico City. I spent a day with a guy who said he was a perv. I think he was but he was also a scam artist. Was supposedly getting a 5 yo for ID to share
wiy300	*us not ID

wiy300	Anyway he disappeared after I gave him the money. I was stupid for giving it up front
OCE-12020	Damn that's interesting. How much he take?
wiy300	400 ugh
OCE-12020	Still go to Mexico ever?
OCE-12020	Damn that sucks. \$400 is a little chunk
wiy300	Yeah about once a year

18. Telegram conversations continued on March 28, 2023. The TTA user and the OCE chatted about the best day to meet and decided on a Thursday or Friday. The TTA user wrote that they should do voice chat at some point. The TTA user went onto explain what he wants to do upon meeting:

And no problem about not joining. Even though I'm not your type you'd still be ok with me playing with her?
Yeah 100%. Everything you said the other day is cool. Just don't hurt her or leave marks.
Whatever you want to do
Hot af
I'll just watch:)
So nice
;)
I wish I had our messages from before. Gets me hard when you tell me what you're gonna do
Hehe yeah. I would love to breed her
Damn tell me more
She loves playing with my pedo cock. I bet she'll love yours too
I would love to cum inside her pussy
You'd be the first. So fucking hot
What else. You got me going. Tell me moreeee
You'd let me do it before you?
I want to feel my load go deep inside get if i can

19. Later that same day, the TTA user explained that he is a "very tall typical white guy. Shaved head professional type". The TTA user and the OCE then discussed what the OCE and the niece were doing for the night. The OCE explained that he was watching movies, etc. The TTA user asked the OCE for a picture of his niece watching cartoons. The OCE explained that he would take a picture at bedtime.

20. Telegram conversations between the TTA user and the OCE continued on March 29, 2023. The OCE and TTA discussed sending selfie photos of each other and a photo of the child. The TTA user subsequently sent an image of himself with a 30 second self-destruct timer.⁴ The TTA user asked how last night went and the OCE sent an (FBI approved) image of a purported child, and this was documented in the below conversation. The image was of a young female approximately 7-8 years old, wearing underwear, and the bed sheet was lifted exposing the child's lower abdomen and white underwear.

OCE-12020	Only 1 for now. And you'll send me a pic also? So I know you're real?

21. Later that same day, the OCE sent two selfie-type photos to the TTA user. One of the images showed a male holding up a piece of paper with "wiy300" and "3-29-23" written on it. In response, the TTA user sent a second selfie holding up a piece of

⁴ Telegram features a "self-destruct" timer which permits a user to send content that disappears after a specified time. The content cannot be recovered once it self destructs.

paper with "@mikeyp559x" on it. This is the username for the OCE's Telegram account. The TTA user continued to discuss future meet-up plans with the OCE, and the TTA user said that he would bring OCE's niece her favorite chocolate bar (Hershey's Dark Chocolate with Almonds) and an Ariel doll (Ariel is a character in a Disney movie).

22. The next day, March 30, 2023, the TTA user and the OCE discussed meeting earlier than previously planned. The TTA user agreed to meet the OCE in Fresno on April 7, 2023. The TTA user reiterated that he would like to video chat with the OCE sometime prior to traveling to Fresno and meeting in person.

IDENTIFICATION OF RODGER GITHENS AS TELEGRAM USER WIY300 (TTA)

- 23. Throughout the communications with the TTA user, the OCE was unable to identify the user since Telegram rarely responds to legal process from the United States and often provides limited information if it does respond. As noted above, on March 29, 2023, the TTA user sent two "selfie-type" photos, which clearly showed his face. On one of the photos, the TTA user drew on a note the OCE's Telegram name. The OCE captured videos of both images by using a device separate from the device on which the OCE was chatting. On March 30, 2023, I submitted these photographs for open-source checks in an attempt to identify the user of the TTA.
- 24. On March 30, 2023, the FBI returned positive hits for the images I had submitted. Images visually consistent with the images provided by the TTA user were located on open-source image repositories. The images were connected to Rodger GITHENS.

 GITHENS has a date of birth in August 1977, which makes him approximately 45 years old, the same age as claimed by the user of the TTA. On March 30, 2023, I conducted DMV records checks for GITHENS, and learned that GITHENS's height is 6'4" on his California driver's license. DMV images of GITHENS visually match the photos sent from the TTA user.

25. Open-source checks also revealed that **GITHENS** has been an Assistant Dean at the University of the Pacific and was currently listed as an Associate Professor at the university. There are numerous photos of **GITHENS** on the University of Pacific website and on other open-source internet sites. **GITHENS** appears to have studied religious studies in Chicago, and he has several degrees from the University of Illinois, which aligns with his messaging to the OCE about originally being from the Midwest. Lastly, throughout conversations, the TTA user referred to himself as "Tod". On numerous online sources **GITHENS** lists himself as "Rod", short for Rodger. This is similar to the name **GITHENS** goes by on Telegram, "Tod". I believe that this also explains why TTA's screen name is "R', which is likely short for Rod or Rodger.

WIY300 CONNECTIONS TO CHATTING FROM HOME AND VEHICLE IDENTIFICATION

26. Throughout the Telegram chats with **GITHENS**, the user of the TTA, it was clear that the user of the TTA worked from home often and was chatting with the OCE while at home on several occasions. On March 28, 2023, the user of the TTA messaged the OCE and mentioned working from his residence:

OCE-12020	Wru up to the rest of the day
wiy300	Just working and meetings you?
OCE-12020	Work and gym soon. And then get the little one
OCE-12020	Do you have a ton of meetings?
wiy300	Oh perfect
wiy300	Some days more than others. Today is a little lower key
OCE-12020	Online meetings or do you have to go out and stuff
wiy300	Both but today is all online. Tomorrow I'll be on site with one of my clients
wiy300	I work from home about 70% of the time usually

27. Additional Telegram chats on March 30, 2023, regarding the TTA user

being at home:

OCE-12020	Wru up to today?
wiy300	Oh damn that sucks
wiy300	I'm working at home today
wiy300	Been thinking about you two
OCE-12020	Oh yeah

OCE-12020	What you been thinking about
wiy300	Hanging out, me giving her gifts, you enjoying seeing her with another man
wiy300	It's all hot af

On March 30, 2023, an FBI agent from the Sacramento Field Office conducted surveillance at AVENUE, WEST SACRAMENTO, CA (the **TARGET RESIDENCE**). This is the listed address for **GITHENS** on multiple law enforcement databases and the Department of Motor Vehicles (DMV). During this surveillance, which was on the same day that the TTA user messaged the OCE that he was working from home, the FBI agent identified a silver Nissan SUV bearing California license plate (TARGET VEHICLE). This vehicle is registered to **GITHENS** with the California DMV as a 2015 Nissan.

ATTEMPTS TO MEET GITHENS

29. On several occasions from April 7, 2023, to April 19, 2023, OCE-12020 and GITHENS arranged several meet ups in Fresno for GITHENS to meet OCE-12020 and get comfortable with each other in order for GITHENS to have sex with OCE-12020's purported 7-year old niece. All of these potential meet ups were cancelled by GITHENS for various reasons relating to his schedule, work, or spouse. However, even after several cancellations, GITHENS still professed to OCE-12020 that he was still interested in meeting and needed to be comfortable prior to making the drive to Fresno.

CHATS WITH GITHENS FOLLOWING INTIAL CANCELLATIONS

OCE-12020	Hey Tod are you alive man? Still good for Friday or what?
wiy300	Hey, I'm going to need to cancel for this week
OCE-12020	There you are. Thought you were gone man
wiy300	Nah why did you think that
OCE-12020	People always ghost

- 30. wiy300 did not respond to the last message above and effectively cancelled the planned meet up with the OCE in Fresno that was scheduled for April 7, 2023. On April 5, 2023 OCE-12020 messaged wiy300 "Should have known you were just all talk. I even kept you a pair of her panties I snagged on Monday. Oh well". The messaged showed two checkmarks once delivered, meaning wiy300 had read the message, but did not respond.
 - 31. On April 12, 2023, OCE had the below limited conversation with wiy300.

OCE-12020	Hey man haven't heard from you. You all good? Did you still want to video chat?

32. Telegram conversation April 13, 2023:

OCE and wiy300 discussed possibly meeting up the following day. OCE-12020 mentioned to wiy300 that he taken some pics recently and wasn't sure if wiy300 wanted them. wiy300 responded "definitely". Meeting the following day in Fresno would depend on wiy300's schedule.

This conversation was captured via audio/video equipment and is contained in the case file as an evidence item.

his husband's schedule. wiy300 stated he would check that night if his husband was going to be visiting friends on the April 15, 2023. wiy300 responded later that night at 6:37PM "So I definitely won't be alone tomorrow. He wants to go hiking or get out somewhere. :(".

38. OCE-12020 and wiy300 had limited contact on Saturday, April 15, 2023. Conversations continued on April 16, 2023. wiy300 requested OCE-12020 send a picture of OCE-12020's niece at a playground waving at the camera. OCE-12020 sent wiy300 a picture of a purported child at a playground and a video of a purported child saying "hi Tod" while going down a slide. Additionally, OCE-12020 and wiy300 discussed that wiy300 would let OCE-12020 know by Tuesday, the 18th if wiy300 could come to Fresno on the 21st of April. Conversations continued below with wiy300 and OCE-12020 discussing OCE-12020's time at the playground.

39. The above conversation continued and OCE-12020 notified wiy300 that Wednesday, April 19th could also work. wiy300 said that may work but he would need to check on some stuff. wiy300 said he would probably get a hotel nearby. OCE-12020

referred wiy300 to the Hyatt Place, at 7333 N. Fresno St., Fresno, CA. wiy300 and OCE-12020 had limited conversations on April 17 and April 18. However, wiy300 notified OCE-12020 that "some shit hit the fan" at work with a project on April 17, 2023. On April 18, 2023, wiy300 notified OCE-12020 that tomorrow (April 19th) may not work to meet due to work issues.

SEARCH OF GITHENS BODY, DEVICES, & RESIDENCE

- electronic devices, and residence of Avenue, West Sacramento, CA was executed by FBI agents. GITHENS was observed by FBI surveillance units on the afternoon of April 19, 2023, at his residence. Shortly thereafter, a call and text were sent to GITHENS's registered phone number from a West Sacramento Police Sergeant advising GITHENS his stolen packages, about which he had contacted West Sacramento Police Department in the months prior, had been recovered. GITHENS was instructed to stop by the department that day and pick up his packages. Shortly thereafter GITHENS was observed leaving his residence and a vehicle stop by West Sacramento Police units was performed. GITHENS was transported to his residence for questioning and to complete a search of his body and devices. During the initial contact with GITHENS an Apple iPhone was recovered in GITHENS possession that had the lock screen unlocked. GITHENS advised to officers that this was his phone.
- 41. **GITHENS** was brought to his residence, uncuffed, advised of his rights, and interviewed by agents. During **GITHENS's** interview, agents completed a cursory review of the seized iPhone in **GITHENS's** possession. The Telegram application was discovered on **GITHENS's** device, with the username of wiy300, the same username that had been chatting with OCE-12020. The chats between OCE-12020's Telegram account "mikeyp559x" and **GITHENS**, "wiy300" were discovered on the seized Apple iPhone. Additionally, agents reviewed several messages within **GITHENS's** Telegram

application and discovered numerous chats **GITHENS** was having with multiple Telegram users. Many of these chats were similar to the same chats **GITHENS** had with OCE-12020. For example, **GITHENS** messaged a "Joel Perez freano sac 36" account, "I want to share a boy with you". **GITHENS** then later distributed a video to this user depicting a young minor boy performing oral sex on what appears to be an adult male. **GITHENS** and the user then went on to discuss the ease of arranging sex in Mexico with young children, similar to the conversation **GITHENS** had with OCE-12020. **GITHENS** then sent an additional video to the same user. The video depicts a young child, possibly under the age of eight years old being raped by an adult male. **GITHENS** messaged "Hope it won't freak you out", and "I get it completely it's pretty extreme." **GITHENS** next shared a video depicting a young male child, who appeared to be under the age of 12 performing oral sex on an adult male. **GITHENS** wrote under the video, "This cutie likes it". This text exchange between **GITHENS** and the above user was only one of several chats that **GITHENS** possessed in his Telegram account, wiy300.

agents discovered that **GITHENS** had received numerous child pornography images and videos from several Telegram users. Several of these conversations were in Spanish, thus it was not immediately possible to know the what the text associated with images stated. But there were numerous videos/photos of children, several of whom appeared to be prepubescent, performing sexual acts with adults. Additionally, **GITHENS** had a "photo vault" style application on his phone that was thumbprint protected. This means that only **GITHENS**'s thumbprint could open the vault application. **GITHENS** was asked to unlock this application and did so. Within the application were numerous folders with different labels. One of those folders was labeled "Fresno" and contained the images sent by OCE-12020 of an adult white male and OCE-12020's purported seven-year old niece. There was an additional locked folder within the photo vault that required an additional

password to unlock. Agents were unable to view the contents of this folder during the cursory review.

CONCLUSION

- 44. Based on the information above, I submit that there is probable cause that RODGER GITHENS, aka "wiy300" on Telegram, committed the crime of Receipt and Distribution of Images of a Minor Engaged in Sexually Explicit Conduct, in violation of 18 U.S.C. § 2252(a)(2).
 - 45. I request that the Court issue an arrest warrant for **GITHENS**.
