Dear FOIA Requester:

This letter is the 1st rolling release to your Freedom of Information Act (FOIA) request received by the National Guard Bureau on May 10, 2021 and assigned FOIA case number J-21-0172. You requested copies of the following:

1. Any report of an incident of white supremacist, white nationalist, white separatist, far-right, alt-right, or pro-Nazi activity or ideology among military personnel.
2. Any study concerning incidents of white supremacist, white nationalist, white separatist, far-right, alt-right, or pro-Nazi activity or ideology among military personnel I the possession of or created, utilized, maintained, received, or distributed by the National Guard Bureau.
3. Records sufficient to identify the number of incidents or reports of white supremacist, white nationalist, white separatist, far-right, alt-right, or pro-Nazi activity or ideology among military personnel, and any ensuing action recommended or executed by your agency, since January 1, 2017, or the earliest date thereafter for which this information is available.

This office is providing the first rolling release to you through the Department of Justice. Enclosed are copies of documents deemed responsive to your request totaling 28 pages. The records are being released to you in part. After a thorough review of the documents, it was determined that portions of information are exempt from disclosure under the FOIA, 5 U.S.C. § 552 (b)(6) and (b)(7)(C). FOIA Exemption 6 applies to information, which, if released, would constitute a clearly unwarranted invasion of the personal privacy of individuals. Under this exemption, I am withholding the names of all DoD personnel below the rank of General Officer as well as personal information on third parties. FOIA exemption (b)(7)(C) protect the release of information that could reasonably be expected to constitute an unwarranted invasion of personal privacy.

Boss,

As a follow-up to our conversation, here is a rollup:

On 4 Dec 2020, (b) (6) contacted CW3 (b) (6) and received the following details regarding the VEC reported to the NGB.

On 3 Dec 2020, (b) (6), CI Team Chief, NGB G2X, was contacted by a source within the FBI, who advised there was an internal FBI bulletin written regarding Guardsmen from Kansas and Missouri with possible involvement in the "Boogaloo Boys", a loosely organized anti-government movement. NOTE: This movement is affiliated with criminal activities such as kidnaping LE officers, the murder of LE officers, and also have been linked to the plot to kidnap the current Michigan Governor. No specific names were given as to who the Guardsmen are/were, however it is believed the names of the Guardsman in question are the same individuals mentioned in the Sept 22-28 2020 Army CID Command Intelligence Operations Center (CIOC) Suspicious and Threat Activity Report (STAR) (see attached at page 3). Details are also outlined in the attached 23 Sept 2020 FBI St. Louis CT Incident Report (see attached). The source iterated to (b) (6) that it was believed that IF the Guardsmen used their access to their own weapons, but utilized their military training, organizational skills and leadership, they could enhance the "Boogaloo Boys" efforts being tracked by the FBI.

To the best of our knowledge, there is no active investigation into this matter.

There was alleged to be a briefing to the FBI SAC, however CW3 (b) (6) was unsure as to when that would happen. He also stated there was chatter about briefing the Kansas and Missouri TAG, however that would be next week.

There were no substantial details given other than what he received and no actual numbers or ID's on who this briefing was specifically concerning.

I am in the loop and have contacted the J3-4 here and they are aware of the details. Mr. (b) (6) is aware of my role and we have been in contact as well, and he was a substantial help in this!

If there are meetings scheduled I will absolutely attend and ensure Maj (b) (6) is aware as well. Any details I obtain will be provided to you ASAP.

Narrative

(b)(6) (b)(7)(C) is allegedly serving in the US Army National Guard in Texas since 2018. We're filling this form because in the past, some of us learned during conversations with him either in person or online that this individual has made disturbing statements and that he holds extreme neonazi beliefs and is a possible threat to others.

He has used multiple extremist phrases associated with fascist and other extreme leaders like Adolf Hitler. He once had a social media account on Instagram where he would comment in praise of Hitler and criticism of Jewish people as "dirty", though this account was later disabled by Instagram. He also has made inappropriate statements on hating women and various minorities. These include memes with "I fucking hate women," and calling people "nigger," "gook," and "kike."

He is very opposed to most of our living presidents including the previous and current administration (Donald Trump, and Joe Biden), and his comments toward those two include disturbing criticism on their policies beyond mainstream criticism and vulgar slurs including "cuck," "fag," "fucking Jew," etc. We aren't aware as whether he joined for any peculiar reason, though we know he seeks to use his skills for something to do with insurrection or takeover of the military or the government.

He has been disciplined at his high school, (a person who claimed to be his classmate stated it was Life High School Waxahachie) for some of his comments on minorities (Jewish, African, etc.) and was investigated after a female student claimed that he threatened to "rape" her.

We'll also be sending a photo he sent to people which implies some of his neonazi beliefs and mishandling of weapons (holding a loaded firearm in the air indoors with safety off).

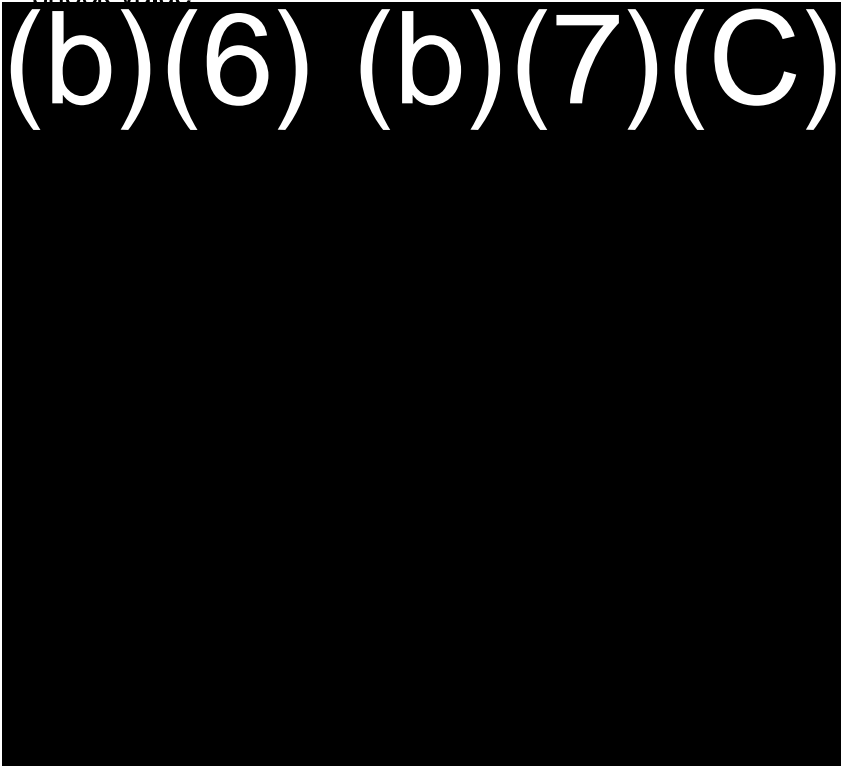

Synopsis: PFC (b)(6) (b)(7)(C) Facebook activity indicates an affinity for fascist, racist, and anti-U.S. government ideology.

a. Reference: Raw Data File (RDF) 0004-2020-CID101-Tab 13 and (b)(6) (b)(7)(C)

b. Source of Information: This information was developed from (b)(6) (b)(7)(C) dated 19 Feb 20 and the above RDF.

c. Narrative: On 19 Feb 20, HQ USACIDC, Quantico, Virginia 22134, received a P3 Tip reflecting SPC (b)(6) (b)(7)(C) was posting "white nationalist things" on Facebook. A review of SPC (b)(6) (b)(7)(C) Facebook page,

(b)(6) (b)(7)(C) along with numerous anti-government, racist and white nationalist posts. (b)(6) (b)(7)(C)

(b)(6) (b)(7)(C) in a photo posted on 29 Jul 19. The Sonnenrad is an ancient Norse/Celtic symbol appropriated by Nazi Germany and currently favored by white supremacists. PFC (b)(6) (b)(7)(C) posted two other photos depicting the Sonnenrad. In one, PFC (b)(6) (b)(7)(C)

is wearing a T-shirt with the Sonnenrad on it and in another, a Sonnenrad flag is hanging on a wall in the background. On 20 Apr 19, PFC (b)(6) (b)(7)(C) posted a photo of himself aiming a rifle with the phrase "Go away fed" emblazoned in red letters across the bottom.

On 17 Feb 20, PFC (b)(6) (b)(7)(C) posted an eleven second video in which he points a pistol at a beer can on the ground as he proclaims, "You've been marked an enemy of the state." PFC (b)(6) (b)(7)(C)

then fires four rounds into the can, turns to the camera and states "It's dead." His Facebook "Likes" include several fascist pages, one of which is titled "Odinic Memes For Fashy Teens." This page,

(b)(6) (b)(7)(C) describes itself as

"un-ironically severely racist."

On 22 Aug 19, PFC ^{(b)(6) (b)(7)(C)} posted a photo of a gas pump showing a cash total of \$14.88. Fourteen is a reference to the white supremacist fourteen word slogan, "We must secure the existence of our people and a future for white children." Eight refers to the eighth letter of the alphabet "H", with "88" (HH) standing for "Heil Hitler."

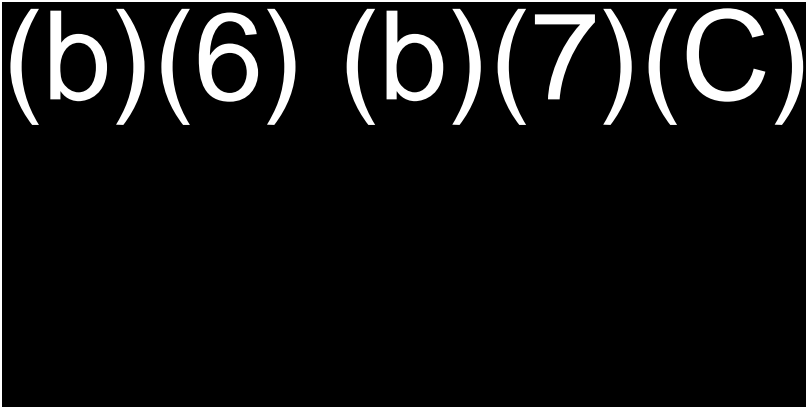


Figure 2. Photo of PFC ^{(b)(6) (b)(7)(C)} and Sonnenrad flag

d. Additional Information: PFC ^{(b)(6) (b)(7)(C)} enlisted in the Idaho National Guard on 28 Jun 18. He attended one station unit training at Fort Benning, GA. No derogatory information was noted in his iPERMS files. No other social media website besides Facebook was identified for PFC ^{(b)(6) (b)(7)(C)}

e. Recommendations: This CIR is submitted for intelligence purposes only. The information contained within should not be the sole basis for any adverse action taken against PFC ^{(b)(6) (b)(7)(C)}. The information contained in this CIR is meant to inform CID and the chain of command about PFC ^{(b)(6) (b)(7)(C)} Facebook posts containing white nationalist and anti-Government ideology. The chain of command should be briefed that DODI 1325.06, Handling Dissident and Protest Activities among Members of the Armed Forces and AR 600-20, Army Command Policy prohibits participation in criminal gangs and in other organizations that advocate supremacist, extremist, or criminal gang doctrine. Additionally, associations with these type of activities should be reported to the unit security officer, especially if the individual has a security clearance, access to classified/sensitive databases/information, or is responsible for high dollar equipment.

f. Additional CIRs will be submitted as additional information is developed. Distribution of this CIR is limited to CID, the U.S. Army National Guard Bureau (NGB) PMO, the subject's commander and individuals with a need to know.

in a photo posted on 29 Jul 19. The Sonnenrad is an ancient Norse/Celtic symbol appropriated by Nazi Germany and currently favored by white supremacists. In one, PFC (b)(6) (b)(7)(C) is wearing a T-shirt with the Sonnenrad on it and in another, a Sonnenrad flag is hanging on a wall in the background.

On 20 Apr 19, PFC (b)(6) (b)(7)(C) posted a photo of himself aiming a rifle with the phrase “Go away fed” emblazoned in red letters across the bottom.

On 17 Feb 20, PFC (b)(6) (b)(7)(C) posted an eleven second video in which he points a pistol at a beer can on the ground as he proclaims, "You've been marked an enemy of the state." PFC (b)(6) (b)(7)(C) then fires four rounds into the can, turns to the camera and states "It's dead."

SPC (b)(6) (b)(7)(C) Facebook "Likes" include several fascist pages, one of which is titled "Odinic Memes For Fashy Teens."

(b)(6) (b)(7)(C) describes itself as "un-ironically severely racist."

On 22 Aug 19, PFC (b)(6) (b)(7)(C) posted a photo of a gas pump showing a cash total of \$14.88. Fourteen is a reference to the white supremacist fourteen word slogan, "We must secure the existence of our people and a future for white children." Incident Summary: #DoD-On Monday, January 3, 2022, the New York National Guard (NYNG) J34 received notification from a Binghamton, NY based New York Army National Guard (NYARNG) Recruiter stating an individual in the Recruit Sustainment Program (RSP) admitted association with a III'er Anti-Government Militia. The recruiter further explained the individual expressed concerns about leaving for Initial Entry Training (IET), claiming he is associated with an extremist militia, who pressured him to join the NYARNG as an Infantryman (11B), in order to return and train others within the militia.

On January 5, 2022, the NYNG J34 received notification from the NYARNG recruiting command, that the individual failed to ship to IET, and went AWOL while at the airport in Syracuse, NY, where he was in route to IET. The recruiters reached out to the individual upon hearing he missed his flight and failed to ship to IET. The individual was contacted and stated his family and self may be in harm's way now, and agreed to meet with the recruiter.

Upon meeting with the recruiting the individual signed a statement claiming again, stating his affiliation with the militia, and was influenced by them to join with the intent of providing experience and training upon return. The individual request separation from the NYARNG.

The individual had an III%’er tattoo removed in order to enlist in the NYARNG, in which was listed on a processed tattoo waiver. The individual signed a statement during enlistment, that he had no association with extremist organizations.

The individual’s home of record is in (b)(6); (b)(7)(C) and his NYARNG unit of assignment is located in Ithaca, NY. The NYNG J34 believes there is a presence of anti-government militias as historical reporting indicates militias have referenced it as potentially for access to military arms, vehicles and equipment.

We are unable to ascertain if the individual is affiliated with an extremist organization or simply using it as a means to avoid military service obligation. Texted between the recruiter and the individual do not mention any association to AGME. During interview with the recruiter, the individual stated he doesn't know the names of those militia members who influenced him to enlist. Recruiter stated the individual appeared to be mentally instable during their meeting after he failed to ship to IET.



FOIA exemption 7(C) protect the release of information that could reasonably be expected to constitute an unwarranted invasion of personal privacy.

FOIA exemption 7(E) applies to information, that could disclose investigative techniques and procedures.

ATLANTA - Two Georgia men targeted earlier this year by online activists for their associations with radical white extremism have been kicked out of the Army National Guard, following months of investigation.

Army investigators started looking into Dalton Woodward and Trent East, both members of a neo-pagan sect called the Asatru Folk Assembly, earlier this year after the activist group Atlanta Antifascists published a report linking the two men to the controversial sect of paganism identified by the Southern Poverty Law Center as a hate group.

At the time, Woodward was on active duty with the Georgia National Guard in Afghanistan. East, a member of the Alabama National Guard, was not on active duty when he was "doxxed," or publicly outed, by the activist group.

National Guard officials have not released details about their investigations. Woodward's unit returned from its deployment in June and an investigation into his connections with white supremacy concluded in October.

A spokeswoman for the Georgia National Guard said he was "no longer a member" of the guard but declined to comment on the terms of his separation or give details about the investigation. The Atlanta Journal-Constitution had filed a Freedom of Information Act request seeking more details, but that request is pending with the U.S. Defense Department. The AJC requested comment from Woodward through his longtime friend East, but received no response.

The military has struggled in recent years rooting out personnel with

membership in white supremacist organizations or who have expressed sympathy for white power causes. In 2017, the Military Times polled active-duty troops and found nearly one in four had seen signs of white nationalism among their fellow service members. Among nonwhite troops, the percentage was much higher with 42% saying they had personally experienced examples of white nationalism on the job.

Just this month the Air Force moved to discharge a sergeant stationed at Schriever Air Force Base in Colorado after he was identified as a local organizer for the American Identity Movement, a white nationalist organization formerly called Identity Evropa.

The investigation into East took longer and is still regarded as an open investigation, even though East told the AJC he received official notice of his separation Dec. 14.

A spokesman for the Alabama Guard said East has 45 days to contest the findings and the investigation remains officially open until then. That spokesman also declined to give specifics about the terms of East's separation, but East told the AJC the Army was recommending he be given a general discharge, a step down from a traditional honorable discharge that indicates unacceptable conduct not in accord with military standards.

Soldiers with general discharges are not eligible for some veteran benefits, such as the GI Bill.

Following the Atlanta Antifascists report, East lost his job as a jailer for the Haralson County Sheriff's Office.

East contends he is not a racist, and that he is just interested in his ancestry and worshipping in the same way they did centuries ago.

"The whole race thing started with me finding Asatru or Odinism or whatever you want to call it and seeing that as a better option than Christianity as a spirituality," he said. "I've just never been a fan of Christianity, and so seeing a faith that was about my ethnic roots was something I could get into a little more."

The Asatru Folk Assembly, which is based in Tennessee, adheres to a "neo-Folkish" brand of Norse paganism that traces its roots to pre-Christian Europe, but its whites-only emphasis on racial identity has attracted neo-Nazis and other white supremacists.

East's social media profile, much of it deleted since his doxxing, included numerous memes and slogans popular among white supremacists, and his contacts include neo-Nazis and other extremists. After his doxxing, East opened an account on VK.com, a Russian social media platform popular among the racist far right.

East and Woodward both attended a 2017 speech by white nationalist celebrity Richard Spencer at Auburn University. Photos from the event show the men carrying signs with a variant of the "white genocide" theory prevalent among

white supremacists.

"The existence of our people is not negotiable," East's sign reads. Woodward's sign read, "We have a right to exist." Both echo the so-called "14 words" motto popular among white supremacists who espouse the theory that nonwhite groups are displacing whites.

Following the Spencer speech, East posted on his group's Facebook page, "It was a great talk, lots of great stuff was said. I highly recommend finding a video of it."

In an interview with the AJC, East downplayed his attendance at the speech.

Along with his jailer job, East said the resulting attention has cost him other jobs, as well as friends and family members who disagree with his beliefs.

"I just went there because at the time I heard he was talking about the recent removal of Confederate monuments. That's something I wanted to hear," he said. "And it turned into something a little worse obviously."

He also minimized his contact on social media with neo-Nazis and white supremacists, some of whom claim membership in the Asatru Folk Assembly. He said he stays away from those that are "Hitler worshipy."

"I don't necessarily agree with it, because there is a lot of racial issues there," he said.

A spokesperson for Atlanta Antifascists said East was merely "dissembling his beliefs" in an attempt to make his statements and actions appear less extreme.

"He's a confirmed white supremacist just shopping around in the marketplace, picking and choosing by aesthetics," she said. "I'm surprised he is not backtracking more."

This letter is the 4th rolling release and the final response to your Freedom of Information Act (FOIA) request received by the National Guard Bureau on May 10, 2021 and assigned FOIA case number J-21-0172. You requested copies of the following:

1. Any report of an incident of white supremacist, white nationalist, white separatist, far-right, alt-right, or pro-Nazi activity or ideology among military personnel.
2. Any study concerning incidents of white supremacist, white nationalist, white separatist, far-right, alt-right, or pro-Nazi activity or ideology among military personnel | the possession of or created, utilized, maintained, received, or distributed by the National Guard Bureau.
3. Records sufficient to identify the number of incidents or reports of white supremacist, white nationalist, white separatist, far-right, alt-right, or pro-Nazi activity or ideology among military personnel, and any ensuing action recommended or executed by your agency, since January 1, 2017, or the earliest date thereafter for which this information is available.

A search of NGB files both electronic and paper resulted in no records responsive to items number one and three.

This office is providing the fourth rolling release and final response to you through the Department of Justice. Enclosed are copies of documents deemed responsive to item number 2 of your request totaling 3 pages. The records are being released to you in part. After a thorough review of the documents, by the appropriate OSD/JS components determined that portions of information are exempt from disclosure under the FOIA, 5 U.S.C. § 552 (b)(6), (b)(7)(C), and (b)(7)(E). FOIA Exemption 6 applies to information, which, if released, would constitute a clearly unwarranted invasion of the personal privacy of individuals. Under this exemption, the names of DoD personnel below the rank of General Officer and the names of other federal government agencies are being withheld from public release, as well as personal information on third parties. FOIA exemption 7(C) protects the release of information that could reasonably be expected to constitute an unwarranted invasion of personal privacy. FOIA exemption 7(E) applies to information, that could disclose investigative techniques and procedures. Please note that we have considered the

foreseeable harm standard when reviewing records and applying exemptions under the FOIA in processing of this request.

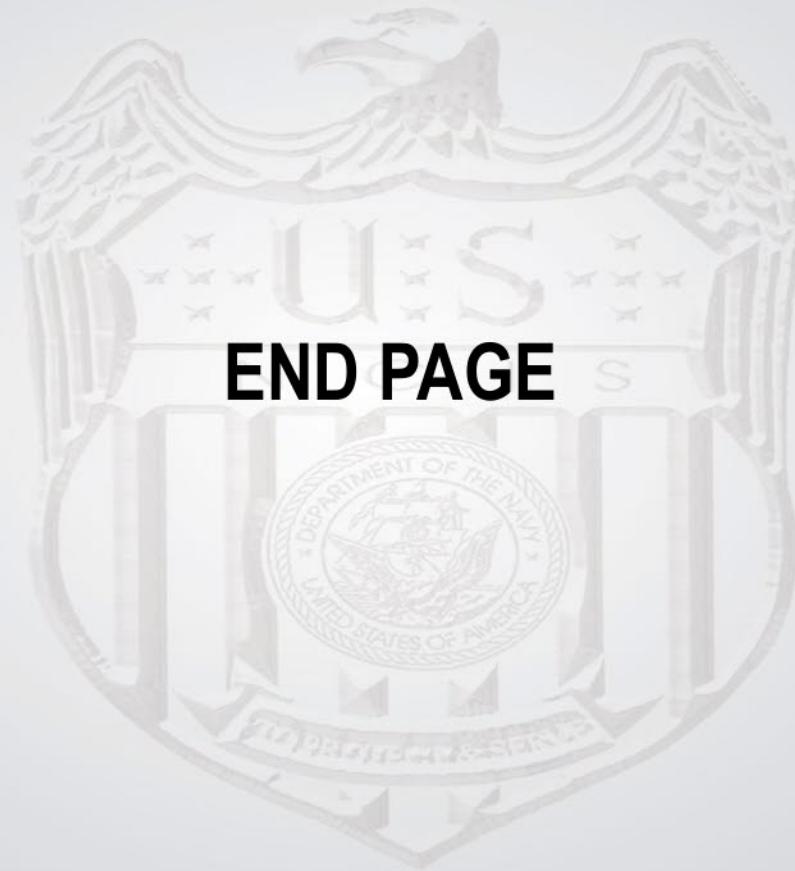
