Payor Mix

Payments on behalf of certain patients are made to UofL Health, Inc. by the federal government under the Medicare program, by the Commonwealth of Kentucky, by commercial insurance carriers, by managed care entities such as health maintenance organizations and preferred provider organizations and through private payment. The following is a summary of gross patient service revenue by payor source for UofL Health, Inc.

Essentially all Medicaid recipients in the Commonwealth are enrolled in Medicaid managed care. There is a supplemental funding program through the Medicaid Managed Care Organizations ("MCOs") as described below. Managed care contracts are mainly with Anthem, Humana, United, Cigna and Aetna. For the nine months ended March 31, 2023 and 2022, Anthem is UofL Health, Inc.'s largest commercial payor. Anthem agreements have automatic renewals with annual negotiated payment updates.
