 Before Me, the undersigned authority personally appeared _____ who being duly sworn, alleges, on information and belief, that on the 12th day of May, 2023, in LAKE County, Florida, the defendant did:

Commit the offenses of:
 Manslaughter F.S.S. 782.07(1)
 Aggravated Battery with a Firearm 784.045(1)(a)(2)

On 05/12/2023 the Lake County Sheriff's Office received a 911 call in reference to a person who had just been shot on or near _____ in Lake County, reference LCSO Case 230059388.

Upon arrival at the crime scene, LCSO deputies found _____ to have a gunshot wound to his torso. _____ was transported to Waterman Hospital in Eustis where he succumbed to his injury and was pronounced deceased.

During the investigation, it was found that the defendant, Wallace Mannin Kirkland had shot _____ once in the chest with a semi-automatic pistol.

Based on multiple interviews with witnesses, it appeared that Mr. Kirkland and _____ had several verbal altercations in the past.

On the evening of 05/12/2023 Wallace Mannin Kirkland, his wife Dorothy Kirkland, and Ronald West (a neighbor) were standing on the side of the road across from _____ and were conversing. _____ came driving by in a Cam am dune buggy/side by side type of vehicle. Based on testimony, Wallace Kirkland either attempted to or did throw a beer can over _____ vehicle as he passed. _____ then exited his vehicle and approached Wallace Kirkland and stated something similar to "I'm going to kill you." When interviewed, witnesses did not note any weapons in _____ hands. Also, _____ was outnumbered and was physically smaller than both Wallace Kirkland and Ronald West. When _____ got within approximately 3 to 4 feet, witnesses heard a gunshot and _____ stated that he couldn't believe that Wallace Kirkland shot him. _____ then returned to the vehicle, drove a short distance further, and appeared to lose consciousness.

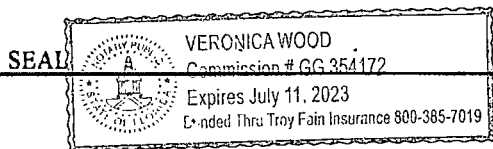

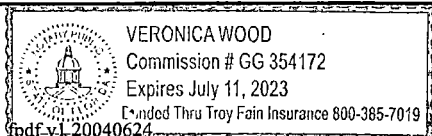

FIRST APPEARANCE FINDINGS & ORDERS

Based upon the foregoing Affidavit and/or Sworn Testimony of the undersigned finds and determines:

- As to charge(s) that there was at the time of arrest and is probable cause to believe the defendant has committed the offense with which he/she is accused and it is hereby Ordered and Adjudged that defendant is to be detained or post bond as otherwise affixed pending further proceedings.
As to charge(s) that there is a lack of evidence that the defendant committed the offense with which he/she is accused, and it is hereby Ordered and Adjudged that the Sheriff or Chief of Police having custody is directed to forthwith release defendant from custody on defendant's own recognizance, subject to defendant appearing at all subsequent court proceedings upon proper notice.
As to charge(s) that it is hereby Ordered and Adjudged the matter of probable cause is hereby continued until the next First Appearance Hearing after date hereof, at which Hearing the Arresting Agency shall present any further proof of probable cause that it may possess.

RELEASE ORDER

The above named Defendant was brought before the undersigned on this date at 9:30 o'clock, A.M. for a first appearance hearing and the undersigned thereupon informed him/her of the charge against him/her and provided him/her with a copy thereof and also adequately advised him/her that (1) he/she was not required to say anything and that anything he/she did say might be used against him/her, (2) if he/she was financially unable to afford an attorney that the Court would appoint one to represent him/her, and (3) he/she had the right to communicate with his/her attorney, his/her family, or his/her friends and if necessary reasonable means would be provided to enable him/her to do so; and the undersigned having considered all available relevant factors necessary to determine whether bail is necessary to assure Defendant's future appearance, and found that same is necessary, it is upon consideration thereof ORDERED AND ADJUDGED that the Defendant

- Be released on his/her own recognizance upon the condition that he/she appear as agreed below.
Be admitted to bail in the amount of \$ as to charge A, as to charge B, \$ as to charge C, \$ as to charge D, and \$ as to charge E, upon the condition that he/she appear as agreed below.
