Please accept this request for records under the Freedom of Information Act, 5 U.S.C. § 552, et seq., on behalf of the State of Florida. Copies of the following records must be provided:

Any records of a relevant DOE official that discuss, mention, or relate to the July 19, 2022 Dear Colleague letters, "Guidance for Institutions Seeking to Change or Add Accrediting Agencies" (GEN-22-10) and "Procedures for Institutions Seeking Approval of a Request to Change or Add Accrediting Agencies" (GEN-22-11).

Further, given that many Florida educational institutions have imminent accreditation timelines, it is urgent that Florida be aware of any such interference.

I ask that any fees be waived because of the significant public interest in the continued accreditation of educational institutions and provision of student aid through these state institutions.
