They advised me that their adopted daughter, I, was found to have a cellphone which is against their rules. Deborah advised that when she found the cell phone, she demanded the pass code from I. She stated that I refused to give her the pass code. Deborah advised that the two of them got into a verbal altercation and that during the argument, she shoved I onto the couch. Deborah stated that the family was getting ready to leave for an event and that I refused to go out and get in the truck. Deborah stated that her husband, Matthew, picked I up, carried her to the truck, and placed her in the back seat. Matthew and Deborah stated that while Matthew was carrying her, I was thrashing around trying to get away. He stated that when he got her into the back seat, due to her thrashing around, she hit her head on the right rear C post of the truck causing her nose to start bleeding. They advised that as they were about to leave, I exited the vehicle and ran down the street. Deborah stated that is when she called the police. I then went to speak with I who had blood all over her face, neck, hands, and clothes. I stated that she did in fact have a phone that she wasn't supposed to have and that she refused to give the pass code to Deborah. She stated that the two of them began arguing and Deborah grabbed her throat shoving her onto the couch. I stated that Deborah was cursing and screaming at her while holding her down, choking her. I stated that Deborah told her "I'm going to choke the fuck out

I advised that Deborah grabbed her by the hair and pulled her up from the floor and that Matthew shoved her head down between her own knees and stated "it's my turn" stated she could not recall everything that happened but eventually Matthew picked her up and carried her to the truck. stated that when Matthew placed her into the truck he hit her in the mouth multiple time calling her "a little whore." stated that her mouth and nose started bleeding. waited until Deborah and Matthew got into the truck and she unlocked the door and ran on foot until intercepted by police. I then stated that there were cameras in the living room that would have captured the incident and that Deborah had access to them on her cell phone. I spoke with Deborah and she was reluctant at first when asked about the cameras but she relented and agreed to show me the videos. Deborah voluntarily signed a consent to search form for her cellphone and allowed Officer Bare to send the videos to he and myself. I was able to watch the videos and observed Deborah Wiles grab I by the throat, shove her onto the couch, and sav to her "You're going to die today cause I've had enough". While Deborah was choking, v on the couch, walks over and smacks in the face and demands her to give them passcode. In another clip, Deborah can be seen strangling v with her right hand and states "I'm going to choke you the fuck out" Deborah could also be seen pulling v around on the floor by her hair. At one point in the videos Matthew could be seen holding v down on the floor. He can then be seen carrying

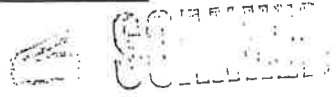

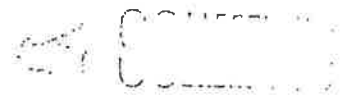
