Dear Mr. Singer-Vine and Mr. Faife,

This is the final response to your Freedom of Information Act (FOIA) request, which you submitted to our office on March 31, 2023. Our office received your request on April 4, 2023, and assigned it case number 23-0102. You requested the following: "1) All database records in the Peace Corps PC-7 "Reasons for Resignation" database and PC-17 (VIDA/PCVDBMS), excluding fields containing PII or other sensitive user information. We request all database records stored within the PC-7 system (as well as all analogous resignation form records stored in systems that may have preceded or succeeded PC-7), with the exception of data fields that contain personally-identifiable information, i.e., name and social security number. To the extent that the requested records are stored as structured information in a database, it should be possible to withhold non-disclosable data fields without the need to individually review or redact such records, and without the need to withhold any other portion of those records."

A search conducted by of the Office of the Chief Information Officer and the Office of Strategic Information, Research and Planning returned one spreadsheet, totaling two pages, as printed. I have reviewed the information to consider the release of any reasonably segregable portions of information. I have considered the foreseeable harm standard in my review of these records and my application of the following FOIA exemptions. FOIA exemption (b)(5) protects privileged communications within or between agencies. In this instance it protects the deliberative process privilege (provided the records were created less than 25 years before the date on which they were requested).
