Introduction for Habeas Corpus

## INTRODUCTION

*Pro se* petitioner Ernesto Javier Rocha Cuadra ("Petitioner"), A civil immigration detainee currently held at the Central Louisiana Processing Center, Seeks A *Writ of Habeas Corpus* pursuant to 28 U.S.C. 2241. Petitioner contends that he is entitled to release on supervision.

## BACKGROUND

## I. Factual Background

Petitioner is a Native and Citizen of Nicaragua. He first entered the United States on February, 1988, as a political Refugee, on June 20, 1989 was Granted Political Asylum, and was wrongfully removed in November 16 2009, Petitioner then attempted to re-enter the United States to seek Political Asylum, buy turning Himself in to ICE at the Tijuana / San Yesidro crossing, where he was turned away and being told that they were only taking people from the Ukraine.

Then two days later he tried to turn himself in again at the Los Algodones / Yuma Arizona crossing and being told again the same thing only taking people from the Ukraine only...! but this time was told to cross and turn himself in to CBP AND SEEK ASYLUM THAT WAY. Which he did on Easter Sunday on April 3<sup>rd</sup>, 2022. When trying to cross he and Group of people trying to cross were Shot at by the Coyotes/ Cartel for trying to cross without paying at that crossing point which was under their control.

At that time, he help a signal mother crossing with here three Kids so he took her smallest kid she was carrying in to his arms and tripped over a large rock hurting his had fracturing his right hand.

After crossing the River/ Water the rest of the group hind in the Bushes. At this time he kept walking around 100 yards looking For the CBP Officer to turn himself In which he Did.

After being processed He was taken to Yuma Hospital Emergency Room for his fractured hand.

And stay there for two or three days.

Then on April 6<sup>th</sup> 2022 he was bused to the Imperial Beach CBP station. And being held there without seeing anyone or taking to anyone he was finally on April 21<sup>st</sup> 2022 he was woken up around 2am and questioned where he made his statement and telling the CBP agent that he was Seeking Asylum and telling the CBP that he was doing everything According to regulation and protocol under the Convention Against Torture and under Article 31.1 which States the following

Article 31(1) of the Convention provides:

The contracting States shall not impose penalties, on account of their illegal entry or presence, on refugees, who, coming directly from a territory where their life or freedom was threatened. . . enter or are present in their territory without authorization, provided they present themselves without delay to the authorities and show good cause for their illegal entry or presence. Convention Relating to the Status of Refugees art. XXXI(1), at this point the CBP Agent tried to reinstate prior order and the time it read that the penalty was for 20 years so he did not sign any more documents. Because the order was for Ernesto Javier Rocha Quadra,

The CBP agent got mad a Put Rocha back in the holding Cell. He was not given any copies or Documents in till June 13<sup>th</sup> 2022 when he was at the LaSalle ICE Processing Center. By an ICE officer. On April 24<sup>th</sup> 2022 he was bused again to the Chula Vista CBP Station where he got his third Covi-19 vaccine.

On April 26, he was once again transferred by plane all the way to Alexandria International Airport in Louisiana. Then he was bused to the LaSalle Richwood Ice Detention Center. Where his Right hand was reinjured when he was shackle to his waist when he went to the restroom that was on the bus when the bus hit a bump and swerved. He told the driver and the guard. What happened and they ignored him and he complained about the cold air as well. Where the thermostat was at 62 degrees in the back part of the bus where there was a lot of elderly people. And the thermostat in the front of the bus was set at 74 degrees . HE filed Report and complaint about his injury to his right hand. the medical Staff treated him and sent him to Emergency room. Then being there for a month and trying to file his I-589 Asylum form. He was told by the court officer, MR. Philipps and the Ice lesions that it was a federal Crime for him to have application before it was given by the immigration Judge...! He told them that the instructions said to file the application 10 days be for the court date so he mailed the Application to the Nebraska Processing Center on May 9<sup>th</sup> 2022 They were not giving the notice from the courts to the detainees. So he filled a report with the Inspector General after being there under his real name he was shortly after that incident.

He was transferred to LaSalle Ice Processing Center on May 19<sup>th</sup>, 2022 Under the Name Ernesto Javier Rocha Quadra...! And Placed in Administrative Segregation Since day one and till this day he has been there because Geo Staff First Asks the Detainees Who Run the dorm's there for permission be for placing in Detainee in the dorm since they are ran by the prison gang there. And since Mr. Rocha did not want to run with the prison gangs there he was put in Administrative Segregation under security Risk.

On June 13<sup>th</sup> ,2022 he was finally given the Reinstated order. Ice has given him a document stating that his 90-day Review was to be held on July 20<sup>th</sup>,2022. Dated April 21<sup>st</sup>, 2022. On July 1<sup>st</sup>, 2022 he has been in custody 90 day

On September 27<sup>th</sup>,2022 he was given Documents Stating that Decision to Continue Detention was Issued by ICE Reviewing Officials on August 4<sup>th</sup>, 2022, That Upon Review of the factors set forth at C.F.R 241.4(e),(f) and (g).

ICE has Determined to maintain his Custody Because: You have not Demonstrated that, If Released You will not:

Pose a Significant Risk of Flight pending your removal from the united states....

Pose a Significant Risk to Public Safety....

Case history, for continued Detention pursuant to 8 CFR 241.4(e),(f),(g), (Flight Risk). On the same day ICE gave him a Notice that the 180-day Review was Scheduled for October 18<sup>th</sup>, 2022. Pursuant to; 8 C.F.R 241.4(c)(2).

On November 21<sup>st</sup>, 2022 ICE conducted A Personal Interview Pursuant to 8 C.F.R (i)(3) this personal interview is being conducted on behalf of Immigration and Customs Enforcement HEADQUARTERS Custody Management Unit.

And on December 6<sup>th</sup>, 2022 ICE Conducted Another Personal Interview Pursuant to 8 C.F.R (i)(3) this personal interview is being conducted on behalf of Immigration and Customs Enforcement HEADQUARTERS Custody Management Unit. Stating that they had lost all paper work from the November 21<sup>st</sup> 2022 Interview. So Rocha Cuadra Submitted all paper work and documents from the first inter view.! And told the Ice agent that he has actually been in ICE custody Since Easter Sunday being April 3<sup>rd</sup>,2022. With a Total Of 248 days..

Final Order Issued:

On April 21<sup>st</sup>, 2022. On July 1<sup>st</sup>, 2022 been in custody 90 days!

On October 1<sup>st</sup>, 2022 Been in Custody 180 days!

On December 1<sup>st</sup>, 2022 I have been in custody 270 days!

#### Meed for interpreter or special consideration

Normally, the review will happen within a few days. You may consult with your representative before the review by the immigration judge, provided it does not cause unreasonable delay. You will be given a copy of the asylum officer's record of determination prior to the review by the immigration judge. If any of the information is incorrect, you should notify the immigration judge. The immigration judge may decide that you do have a reasonable fear and that you are eligible hearing to apply for withholding or removal. If the immigration judge agrees with the determination that you do not have a reasonable fear of persecution or torture, you may be removed from the United States.



### ALFARO GARCIA, ET AL. V. JOHNSON, ET AL., Case No. 4:14-cv-01775-YGR IN THE UNITED STATES DISTRICT COURT FOR THE NORTHERN DISTRICT OF CALIFORNIA

TO: All individuals who meet all of the following characteristics (collectively "the Class"):

- Are or will be subject to a reinstated order of removal under 8 U.S.C. § 1231(a)(5) or an administrative removal order under 8 U.S.C. § 1228(b);
- Have expressed, or in the future express, a fear of returning to their country of removal;
- Are detained in the custody of the Department of Homeland Security ("DHS"); and
- Have not received, or do not receive, an initial reasonable fear determination by U.S. Citizenship and Immigration Services ("USCIS") under 8 C.F.R. § 208.31 within ten (10) days of referral to USCIS and still have not received a reasonable fear determination.

You are hereby notified that on October 27, 2015, the Honorable Yvonne Gonzalez Rogers of the United States District Court for the Northern District of California approved a settlement of the claims that were brought on your behalf in this lawsuit.

#### Background

This class action lawsuit alleges that the U.S. Government is failing to process, in a timely manner, claims to protection from removal from the United States based on a fear of persecution or torture, in violation of a binding federal regulation at 8 C.F.R. § 208.31(b), which requires a "reasonable fear determination" be made within ten days in the absence of exceptional circumstances. The parties have now reached a settlement that the Court has approved.

#### Description of Settlement Agreement

The following description is only a summary of the key points in the Settlement Agreement. Information on obtaining a copy of the full Agreement is provided after this summary.

1. ICE must make prompt referrals for reasonable fear determinations: U.S. Immigration and Customs Enforcement ("ICE") will refer an individual who qualifies for a reasonable fear determination to USCIS "immediately, as practicable." Within a year after the date of the Settlement Agreement, ICE will achieve a national average of no more than five (5) days for referrals and, at that time, the parties will meet and confer to establish a new, shorter benchmark for referrals. ICE will update any future published training guides or manuals addressing procedures for reinstatement of removal and/or administrative removal to include its obligations under the Settlement Agreement.

2. The USCIS Asylum Division must conduct reasonable fear determinations promptly and within a national average of ten days: By November 27, 2015, USCIS is obligated to achieve a national average of no more than ten (10) court days from the date of referral to complete reasonable fear determinations. In addition, USCIS will take no longer than twenty (20) court days from the date of referral to complete any individual reasonable fear U. S. ## Information about Reasonable Fear Interview

#### Purpose of this notice

The purpose of this notice is to explain what will happen while your case is being decided, what rights you have, and what may happen to you as a result of statements you make. It is important that you understand your rights and what will happen. <u>PLEASE</u> READ THIS NOTICE CAREFULLY.

You have been ordered removed because the U.S. Immigration and Naturalization Service (INS) has determined that you do not have the right to stay in the United States. You have indicated an intention to apply for withholding of removal, or have expressed a fear of persecution, torture, or return to your country. You will be interviewed by a specially trained asylum officer to determine if you have a "reasonable fear of persecution or torture." You may be detained both before and after the interview if the INS determines that it is appropriate to detain you.

#### Right to consult with other persons

Normally, you will receive an orientation by an asylum officer shortly after you are ordered removed. The asylum officer will explain the reasonable fear process to you, and will tell you when your interview is scheduled. Normally the interview is 48 hours after your orientation. You may use this time to find a lawyer or accredited representative who will represent you. If you need additional time, you should inform an INS officer. You may request that the interview take place sooner if you are prepared to discuss your fears or claim immediately.

You may consult with a lawyer or representative of your choosing, provided that such consultation is at no expense to the government and does not delay the process. Your representative can be present with you at your interview, or can participate by telephone. A list of representatives who may be able to speak to you free of charge is attached to this notice. You may use the telephone while you are in detention to call a representative, friend or family member in the United States, collect or at your own expense. If you wish to call someone, you may ask an INS officer for assistance. You also may contact the United States Office of the United Nations High Commissioner for Refugees, at (202) 296-5191 from 9:00 a.m.-5:00 p.m. (eastern standard time), Monday through Friday.

#### Description of reasonable fear interview

The purpose of the reasonable fear interview is to determine whether you might be eligible to apply for withholding of removal or other protection before an immigration judge. This interview is not a formal withholding of removal hearing. It is only to help us determine whether you could be eligible for withholding of removal and should therefore be allowed to present your case before an immigration judge.

At your interview, you will have the opportunity to explain to the asylum officer why you think you should not be returned to your home country. If you want to apply for withholding of removal or think you will be harmed, persecuted or tortured if you return to your home country, you must show an asylum officer that you have a reasonable fear of being harmed or persecuted because of your race, religion, nationality, membership in a particular social group or political opinion, or that there is a reasonable possibility that you will be tortured. The officer will take written notes.

If the officer determines that you have a reasonable fear of persecution or torture in the country to which you have been ordered removed, you will be able to ask an immigration judge for withholding of removal or deferral of removal to that country, by completing a Form I-589 Application for Asylum and for Withholding of Removal and filing this with the Immigration Court.

It is very important that you tell the officer all the reasons why you have concerns about being removed to the country to which you have been ordered removed. United States law provides strict rules to prevent disclosure of what you tell an asylum officer about the reasons you fear harm. The information you provide about the reasons for your fear will not be disclosed to your government, except in exceptional circumstances.

It is also very important that you tell the truth during your interview. Although the purpose of this interview is not to gather evidence against you, failure to tell the truth could be used against you in this or in any future immigration proceeding.



#### Need for interpreter or special consideration

If you do not speak English well or if you prefer to be interviewed in your own language, INS will provide an interpreter for the interview. The interpreter has been told to keep the information you discuss confidential. If the interpreter is not translating correctly or you do not feel comfortable with the interpreter, you may request another interpreter.

You may request a female officer and female interpreter, or a male officer and male interpreter, if this would make it easier for you to tell the asylum officer about information that is very personal or difficult to discuss. The INS will provide them if they are available. You will also have the opportunity to speak with the asylum officer separately from your family if you so desire.

#### Consequences of failure to establish reasonable fear and review of determination

If the asylum officer determines that you do not have a reasonable fear of persecution or torture, you may ask to have an immigration judge review that decision. If you do not request such review, you may be removed. If you request review, the immigration judge's review will be in person or by telephone or video connection. Normally, the review will happen within a few days. You may consult with your representative before the review by the immigration judge, provided it does not cause unreasonable delay. You will be given a copy of the asylum officer's record of determination prior to the review by the immigration judge. If any of the information is incorrect, you should notify the immigration judge. The immigration judge may decide that you do have a reasonable fear and that you are eligible hearing to apply for withholding or removal. If the immigration judge agrees with the determination that you do not have a reasonable fear of persecution or torture, you may be removed from the United States.

determination and, if USCIS fails to complete any reasonable fear determination within twenty (20) court days from the date of referral, it will notify Class Counsel.

3. The time periods can be extended in certain circumstances: The period for calculating the relevant time period for completion of the reasonable fear determination begins on the date of a "proper" referral from ICE to USCIS and ends on the date that USCIS makes the reasonable fear determination and serves it upon the Class Member. The determination period shall be "tolled" (which means it will be extended but the extension will not count toward calculation of the average time period in paragraph 2 above) when an individual (or his or her representative) requests additional time to prepare for the interview. The tolling period will be limited to the time requested by the individual (or his or her representative) and agreed to by USCIS or a default period of no longer than ten (10) court days. The determination period can also be tolled if an individual refuses to participate in the reasonable fear interview or accept service of the determination. The determination period can also be tolled for "exceptional circumstances," which do not include "unusual but reasonably foreseeable circumstances."

4. The government must regularly report information about whether it is meeting the requirements of the agreement: To facilitate monitoring of the Government's compliance with the prescribed timing requirements, the Government must make best efforts to produce regular reports with data on referrals, and will produce reports on reasonable fear determinations to Class Counsel and permit Class Counsel to access a sample of class members' files. If the Government achieves certain benchmarks after one (1) year, reporting will thereafter be required only on a quarterly basis. If, at the end of three (3) years, the Government has achieved all benchmarks, the government can seek an early termination of the five (5)-year Agreement.

**The Court can enforce the agreement if there are any violations:** The Court will retain jurisdiction to enforce the terms of the Settlement Agreement.

6. Attorneys' fees and costs: The Government will pay Class Counsel reasonable attorneys' fees and costs in the amount of \$327,047.66.

7. **Release of claims**: Class Members will release the Government from all claims that were asserted on behalf of the Class arising from or related to the facts and circumstances alleged in the lawsuit.





Esta entrevista no es una audiencia oficial para que no lo deporten. Simplemente nos ayuda a determinar si usted no tiene que ser deportado y, por consiguiente, permitirle que presente su caso ante un juez de inmigración.

Durante la entrevista, tendrá la oportunidad de explicar al funcionario de asuntos de asilo por qué usted considera que no debe ser deportado a su país de origen. Si el funcionario determina que es razonable su miedo a la persecución o la tortura en el país donde va a ser deportado, usted podrá pedir al juez de inmigración que no lo deporten o que pospongan su deportación a ese país, mediante el Formulario I-589 (Solicitud de Asilo y No Deportación) que deberá llenar y presentar ante el Tribunal de Inmigración.

Es muy importante que usted le diga al funcionario de asuntos de asilo por qué le preocupa la orden de deportación al país en cuestión. La ley estadounidense prohíbe estrictamente que se divulguen las razones que usted le haya dado al funcionario y por las cuales siente temor a que le hagan daño. La información que proporcione sobre las razones de su temor no se divulgarán a su gobierno, salvo en circunstancias excepcionales.

También es muy importante que diga la verdad durante su entrevista. Si bien el propósito de la entrevista no es el de obtener pruebas en su contra, el hecho de que no diga la verdad podría ser usado en su contra en este procedimiento de inmigración o en cualquier otro en el futuro.

El INS cumplirá con su pedido siempre y cuando haya personal disponible. Asimismo, usted tendrá la oportunidad de hablar con el funcionario de asuntos de asilo en privado, sin que su familia esté presente, si así lo desea.

## Las consecuencias si no se establece que hay temor razonable y examen de la decisión

Si el funcionario de asuntos de asilo decide que su temor de persecución o tortura no es razonable, usted puede pedir que un juez de inmigración examine esa decisión. Si no pide ese examen, usted será deportado. Si pide que se examine el caso, el juez de inmigración lo hará personalmente o por teléfono o videoconexión. Generalmente, el examen tiene lugar en unos pocos días. Usted puede consultar con su representante antes de ese examen, siempre y cuando no produzca ningún atraso indebido. Usted recíbirá una copia del registro de la decisión del funcionario de asuntos de asilo antes del examen que haga el juez de inmigración. Si parte de la información es incorrecta, usted debe notificar al juez de inmigración, quién puede decidir que en efecto su temor es razonable y que reúne los requisitos para una audiencia en la que solicitará que no lo deporten. Si el juez de inmigración está de acuerdo con la decisión de que su temor de persecución o tortura no es razonable, se le podrá deportar de los Estados Unidos.

- 1. You will have a hearing by an Immigration Judge who will enter a decision after the hearing is completed. If you are not satisfied with that decision, you have a right to appeal to the Board of Immigration Appeals, unless you waive your right to appeal.
- 2. If you wish to appeal your case, you must complete and file a Notice of Appeal (Form EOIR-26) with the Board of Immigration Appeals. You must send the Form EOIR-26 so that it is received by the Board of Immigration Appeals within thirty (30) calendar days after the Immigration Judge=s oral decision or within thirty (30) calendar days after the date the Immigration Judge=s written decision was mailed, if no oral decision was rendered. Simply mailing the Form EOIR-26 within the time limit may not insure that the Form EOIR-26 is timely received by the Board.
- 3. You can get a Form EOIR-26 from any Immigration Court.
- 4. You must pay <u>\$110.00</u> fee when filing the Form EOIR-26 (except there is no fee for an appeal of an Immigration Judge=s bond decision). If you cannot afford this fee, you may apply for a fee waiver. In order to ask for a fee waiver, you must file along with your appeal, an Appeal Fee Waiver Request Form (EOIR-26A). This form requests your monthly income and expenses and contains a sworn statement which must be signed which asserts that the information in the form is true and correct to your knowledge. The Board of Immigration Appeals will consider this information when deciding whether to grant your fee waiver request.
- 5. You may, at no expense to the government, consult with an attorney in order to assist with your appeal.
- 6. Unless you have waived your right to appeal from the Immigration Judge=s decision to the Board of Immigration Appeals, you will not be required to depart from the United States during the time allowed for the filing of an appeal; further, you will not be required to depart from the United States while an appeal is pending before the Board or while your case is pending before the Board by way of certification.

## ALFARO GARCIA, ET AL. V. JOHNSON, ET AL., Case No. 4:14-cv-01775-YGR IN THE UNITED STATES DISTRICT COURT FOR THE NORTHERN DISTRICT OF CALIFORNIA

TO: All individuals who meet all of the following characteristics (collectively "the Class"):

- Are or will be subject to a reinstated order of removal under 8 U.S.C. § 1231(a)(5) or an administrative removal order under 8 U.S.C. § 1228(b);
- Have expressed, or in the future express, a fear of returning to their country of removal;
- Are detained in the custody of the Department of Homeland Security ("DHS"); and
- Have not received, or do not receive, an initial reasonable fear determination by U.S. Citizenship and Immigration Services ("USCIS") under 8 C.F.R. § 208.31 within ten (10) days of referral to USCIS and still have not received a reasonable fear determination.

You are hereby notified that on October 27, 2015, the Honorable Yvonne Gonzalez Rogers of the United States District Court for the Northern District of California approved a settlement of the claims that were brought on your behalf in this lawsuit.

## Background

This class action lawsuit alleges that the U.S. Government is failing to process, in a timely manner, claims to protection from removal from the United States based on a fear of persecution or torture, in violation of a binding federal regulation at 8 C.F.R. § 208.31(b), which requires a "reasonable fear determination" be made within ten days in the absence of exceptional circumstances. The parties have now reached a settlement that the Court has approved.

## **Description of Settlement Agreement**

The following description is only a summary of the key points in the Settlement Agreement. Information on obtaining a copy of the full Agreement is provided after this summary.

1. ICE must make prompt referrals for reasonable fear determinations: U.S. Immigration and Customs Enforcement ("ICE") will refer an individual who qualifies for a reasonable fear determination to USCIS "immediately, as practicable." Within a year after the date of the Settlement Agreement, ICE will achieve a national average of no more than five (5) days for referrals and, at that time, the parties will meet and confer to establish a new, shorter benchmark for referrals. ICE will update any future published training guides or manuals addressing procedures for reinstatement of removal and/or administrative removal to include its obligations under the Settlement Agreement.

2. The USCIS Asylum Division must conduct reasonable fear determinations promptly and within a national average of ten days: By November 27, 2015, USCIS is obligated to achieve a national average of no more than ten (10) court days from the date of referral to complete reasonable fear determinations. In addition, USCIS will take no longer than twenty (20) court days from the date of referral to complete any individual reasonable fear

determination and, if USCIS fails to complete any reasonable fear determination within twenty (20) court days from the date of referral, it will notify Class Counsel.

3. The time periods can be extended in certain circumstances: The period for calculating the relevant time period for completion of the reasonable fear determination begins on the date of a "proper" referral from ICE to USCIS and ends on the date that USCIS makes the reasonable fear determination and serves it upon the Class Member. The determination period shall be "tolled" (which means it will be extended but the extension will not count toward calculation of the average time period in paragraph 2 above) when an individual (or his or her representative) requests additional time to prepare for the interview. The tolling period will be limited to the time requested by the individual (or his or her representative) and agreed to by USCIS or a default period of no longer than ten (10) court days. The determination period can also be tolled <u>if an individual refuses to participate in the reasonable fear interview or accept service of the determination</u>. The determination period can also be tolled for "<u>exceptional circumstances</u>," which do <u>not</u> include "unusual but reasonably foreseeable circumstances."

4. The government must regularly report information about whether it is meeting the requirements of the agreement: To facilitate monitoring of the Government's compliance with the prescribed timing requirements, the Government must make best efforts to produce regular reports with data on referrals, and will produce reports on reasonable fear determinations to Class Counsel and permit Class Counsel to access a sample of class members' files. If the Government achieves certain benchmarks after one (1) year, reporting will thereafter be required only on a quarterly basis. If, at the end of three (3) years, the Government has achieved all benchmarks, the government can seek an early termination of the five (5)-year Agreement.

5. The Court can enforce the agreement if there are any violations: The Court will retain jurisdiction to enforce the terms of the Settlement Agreement.

6. Attorneys' fees and costs: The Government will pay Class Counsel reasonable attorneys' fees and costs in the amount of \$327,047.66.

7. **Release of claims**: Class Members will release the Government from all claims that were asserted on behalf of the Class arising from or related to the facts and circumstances alleged in the lawsuit.



## **Decision to Continue Detention**

This letter is to inform you that your custody status has been reviewed, and it has been determined that you will not be released from the custody of U.S. Immigration and Customs Enforcement (ICE) at this time. Based on the above, you are to remain in ICE custody pending your removal from the United States as ICE is unable to conclude that the factors set forth at 8 C.F.R. § 241.4(e) have been satisfied. You are advised that you must demonstrate that you are making reasonable efforts to comply with the order of removal and that you are cooperating with ICE's efforts to remove you by taking whatever actions ICE requests to affect your removal. We are writing to inform you of an unintentional information disclosure that occurred on November 28, 2022. On that date, a document was mistakenly posted on Immigration and Customs Enforcement's (ICE) public-facing website, ICE.gov. that included limited information on some individuals in ICE custody. Specifically, the document contained names, A-numbers, dates of birth, countries of citizenship, detention facility names, and other immigration information, including credible or reasonable fear decisions associated with each case. Unfortunately, ICE's review has determined that your information was included in the document.

After learning of this incident on the same day it occurred, ICE immediately removed the document from its website and began working to secure the information and notify everyone who was impacted. In addition to letting you know what happened, ICE is taking proactive steps to protect your privacy, including online monitoring for potential re-posting of the document and identifying parties who may have accessed it while it was briefly online. Once this review is complete, ICE will request confirmation from anyone who downloaded the document that they have destroyed it and will not further share it.

Additionally, because the disclosure violated confidentiality obligations under 8 C.F.R. § 208.6 by revealing that you sought protection in the United States, if you are currently subject to a final order of removal, ICE will delay your removal for 30 days. This delay is intended to allow you to determine what actions you wish to take, including consulting with an attorney.

While ICE recognizes that some individuals going through the immigration process already have legal representation, ICE is including a list of free or low-cost legal representatives along with this letter to help those who do not. If you already have an attorney on file with ICE, we will send them a copy of this letter.

ICE deeply regrets that this error occurred and will continue to work to protect the privacy of everyone who was impacted, as well as to prevent similar incidents from happening in the future.

If you have further questions or concerns about this incident, please contact your assigned ICE Enforcement Removal Operations case officer for assistance.

Once the alien has an administratively final order of removal (i.e., an unappealed order of removal by an immigration judge or an order of removal by the Board of Immigration Appeals), the removal period begins. See INA 241(a)(1)(B)(i). 2. Once the removal period begins, the alien is subject to mandatory detention pursuant to INA 241(a)(2). If the alien delays his removal (e.g., by failing to make timely application for travel documents), the removal period is extended beyond 90 days. See INA 241(a)(1)(C). The INS must continue to detain the alien during this extended removal period pursuant to INA 241(a)(2) (which mandates detention even though INA 241(a)(1)(C) permits release for other aliens during the extended removal period).

If the alien seeks judicial review (whether or not barred from doing so by INA 242(a)(2)(C)), the removal period continues to run for a period of 90 days from the date of the final administrative order. However, if the court has issued a stay of the alien's removal (or if the alien has filed a petition for a writ of habeas corpus, in which case the INS accepts a stay automatically), the court's final order on the petition, if adverse to the alien, will trigger a new 90-day removal period. See INA 241(a)(1)(A), 241(a)(1)(B)(ii). During the second removal period, the alien is once again subject to mandatory detention under 241(a)(2).

If the INS has not removed the alien during the initial removal period, it may continue to detain him, as a criminal or a terrorist, pursuant to INA 241(a)(6), or it may release him under an order of supervision pending removal pursuant to INA 241(a)(3). 3. INA Sections 241(a)(6) and 241(a)(3) also apply to an alien who has not been removed by the expiration of any second removal period.
