About 11:10PM Wednesday 07/13/2023 Officer Daley and Depina in the A103F responded to Shots Fired at 257 Hanover St. Boston, MA Modern Pastry. The (A906) Sgt. Whightman, (A426F) Officer Kennedy, (A691F) Officer Gorman, (A437F) Officer Miranda and other additional units assisted.

The (A810) Detective Walsh, (A808) Detective Curley and (A807) Detective McDonough responded to the scene.

Upon arrival officers spoke to witness [REDACTED] who stated he observed a male SUSPECT fire one shot with a hand gun and fled the scene towards Cross St. Officers also spoke to witness [REDACTED] (DOB: Unknown) who stated he was [REDACTED] when he heard 3 shots fired and a male flee on a bike with the handgun still in hand towards Cross St. Officers spoke with witness [REDACTED]

The (A437F) Ofc. Kennedy spoke to victim, [REDACTED] who stated that the SUSPECT, [REDACTED] walked up to him and stated [REDACTED] shot at the VICTIM 3 times and fled the scene. The VICTIM stated he dove behind a parked vehicle.

The (A103F) were notified by a by-stander that there was ballistic damage in the glass window of Modern Pastry.

The VICTIM did not sustain any injuries.

**NARRATIVE**

This report is in regards to an ongoing investigation by Detective Kenneth Curley (A808), and the Boston Police Department into a SHOTS FIRED incident at occurred on Wednesday, July, 12, 2023, at about 11 PM, in front 257 Hanover Street, Boston.

On the morning of July, 13<sup>th</sup>, 2023, about 12:15 AM, Detective Thomas McDonough (A807) conducted an [REDACTED] interview with victim, [REDACTED]. The victim, [REDACTED], detailed the following information that at about 10:30 PM, July 12<sup>th</sup>, he was standing in front of the Modern Pastry, 257 Hanover Street [REDACTED]. He stated that he observed suspect, Patrick Mendoza, riding his bicycle down Hanover Street. [REDACTED] stated that Mendoza began swearing and yelling at him, calling him [REDACTED] and stated [REDACTED] stated that Mendoza then turned around on his bike and came back in his direction. Mendoza dropped the bike on the street and reached behind his waist, pulling a FIREARM.

[REDACTED] stated he fled down the sidewalk trying to take cover behind a jeep that was parked in front of 257 Hanover Street. [REDACTED] stated that Mendoza DISCHARGED THE FIREARM two times in his direction. [REDACTED] stated one of the shots narrowly missed him and impacted the front window of Modern Pastry.

[REDACTED] stated he was "running [REDACTED]," down Hanover Street towards the Greenway where he encountered a police officer.

The victim described the firearm as a snub nosed .38 (revolver).

white male, with a black bandana, short brown hair, and a skinny build. He described the firearm as a pistol, color black, with rectangular shaped barrel. The witness did not recognize the suspect, but noted that he slammed into the hood of a vehicle park in front of the pastry shop.

Detective Curley and Detective Mark Walsh (A810) responded to 257 Hanover Street to process the crime scene.
