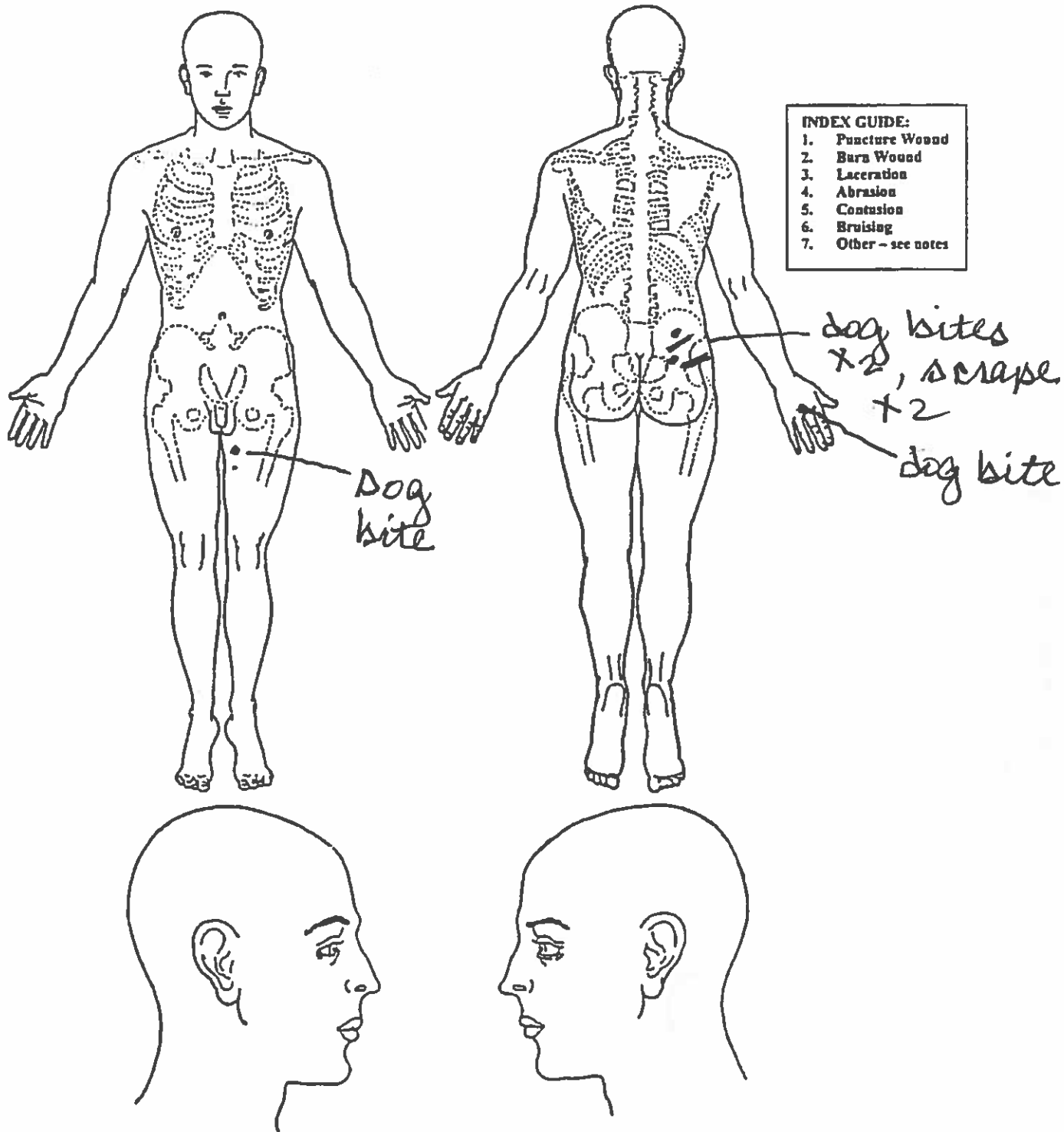

Description of Incident:	<p>On 10-12-2018 at approximately 1902 hours, a 10-33 was called on the radio inmate on inmate fight in 2 Alpha pod. I Canine Officer Jones and Canine Officers Franklin immediately responded with our assigned canines. When I arrived, I gave several warnings, "State Canine, stop fighting or I will release my dog. Officer Branch was trying to separate both offenders off the ground but they keep fighting, Officer Branch then moved out of the way because both offenders ignored my warning I then gave my assigned Canine Jerko 888-01-0428 the verbal command to engaged Offender Defour, Jeremy #1127163. Canine Officer Franklin responded shortly after with his assign Canine he notice Offender Defour, Jeremy reaching underneath his stomach he then ordered Offender Defour, Jeremy to show him his hands. Canine Officer Jones and Franklin noticed an officer radio underneath Offender Defour, Jeremy. I then gave my assign canine the order to disengage Offender Defour, Jeremy my assigned then disengaged from Offender Defour, Jeremy # 1127163. I Canine Officer Jones and Franklin remained on the Pod with our assign canines until all offenders were lock downed and secured in their cells. Both offenders fighting was escorted to medical by staff. There was no injuries to myself or Canine Officer Franklin and our assign canine. End of Report.</p>
