**Bite Narrative**

On Wednesday March 15th 2017 at approximately 3:38 pm, I was monitoring A Building movement with my assigned K9 [REDACTED]. I K9 Officer [REDACTED] responded to a 1018 (offender on offender fight) called over the radio in A5 Pod. Upon entering the pod I observed multiple offenders [REDACTED] fighting under the stairs in front of cell A502. I began to issue several warnings of "State Canine stop fighting or I will release the dog". All offenders refused to comply with the direct orders. At this time I deployed my assigned Canine [REDACTED]. Canine [REDACTED] engaged offender [REDACTED] on the lower left leg in the calf area. I immediately began issuing orders to "lay face down arms out palms up". Offender [REDACTED] did not comply with those orders and began twisting towards myself and Canine [REDACTED]. He began kicking my canine with the opposite leg in an attempt to disengage him. I continued to give multiple orders of "stop fighting the K9, lay face down arms out palms up" as he continued twisting and fighting my canine. Per orders of Sgt. [REDACTED] to have the offender back away from the other offenders not comply with my multiple orders to "get on the ground", I gave offender [REDACTED] orders to push himself backwards toward myself and my canine to a safe distance from cell A502. Once reaching a safe distance the offender complied with my orders to "lay face down arms out palms up". At this time I gave the command for K9 [REDACTED] to release and he did so. Offender [REDACTED] at this time was restrained and taken to medical
