Canines Present and Engagements

Methodology

The data was collected by selecting all Internal Incident Reports (IIRs) with the nature 'Canine present-force used/engaged' and 'Canine present – no force/not engaged' from April 2016 to the end of June 2022. The IIR must have the status of Level 1 Completed, Addendum Open, or Addendum Closed, this means the IIR has been finalized and approved. Any incident that has the status of new or pending level 1 review was not included.

This data represents the number of incidents in which a canine was present and how many incidents a canine engaged in based on the internal incident reports for 'Canine present- force used/engaged' and 'Canine present – no force/not engaged' only.

This data is not limited to incidents involving only inmates. These can include canines present for searches on any individual including staff or visitors or a canine engaged on a staff member. The engagements could include accidental or commanded engagements. This data does not indicate how many individuals had a canine engaged on their person or how many times the canine engaged in the incident. One incident may result in canines engaging on multiple inmates and may have engaged multiple times on one individual.

Data Limitations and Notes:

- This date is as of June 30, 2022 and subject to change due to changes in Virginia CORIS.
- This is dependent on reporting staff entering the internal incident report into Virginia CORIS and selecting the appropriate incident type. The data assumes the accurate internal incident nature was selected.
- The IIRs may include a combination of incidents. For example, multiple individuals or internal areas may be searched by a canine that is all included in one IIR.
- There may be duplicate incidents included if the internal incident reports do not match the criteria stated below.

Process to Remove Duplicate Internal Incident Reports (IIRs)

Since IIRs are submitted by multiple staff for the same incident per policy, the process for removing duplicate incident reports is noted below.

Variables Used:

- LocationId This is the specific identification assigned to the location
- IncidentDate This is the date and time of the incident that is entered by staff
- IncidentDesc This is the description of the incident reported by staff
- InternalIncidentNatureId.1 This is the nature selected on the internal incident report. In this
 data it is either 'Canine present- force used/engaged' and 'Canine present no force/not
 engaged'
- OffenderId.1 This is the largest OffenderId associated with the IIR. It can be blank if no inmate was listed.
- VisitorId.1 This is the largest VisitorId associated with the IIR. It can be blank if no visitor was listed.
- OffenderId_1 This is the smallest OffenderId associated with the IIR. It can be blank if no inmate was listed.
- VisitorId_1 This is the smallest VisitorId associated with the IIR. It can be blank if no visitor was
 listed.
- Date This is the date of the incident without the timestamp

Steps to Remove Duplicate IIRs: All steps were sorted by a variable that indicates the IIR had a participant listed so the IIR with a participant would be retained for future steps.

- 1. The LocationId, IncidentDate, IncidentDesc, InternalIncidentNatureId.1 had to match to be considered a duplicate report. [29 duplicates removed]
- 2. The LocationId, IncidentDate, and IncidentDesc had to match. This step removed the criteria the internal incident nature had to match. [0 duplicates found]
- 3. The LocationId, IncidentDesc, and InternalIncidentNatureId.1 had to match. This step removed the incident date/time criteria, it assumes if all the criteria noted above the report is a duplicate. [3 duplicates removed]
- 4. The LocationId, IncidentDate, InternalIncidentNatureId.1, OffenderId.1, and VisitorId.1 had to match. The offenderid and visitorid may be blank if there were no inmate/visitor participants or they were not entered. If all the criteria matched in this step it was assumed to be a duplicate, including reports that did not have any inmate/visitor participants. [573 duplicates removed]
- 5. The LocationId, IncidentDate, InternalIncidentNatureId.1, OffenderId_1, and VisitorId_1 had to match. The offenderid and visitorid may be blank if there were no inmate/visitor participants or they were not entered. If all the criteria matched in this step it was assumed to be a duplicate, including reports that did not have any inmate/visitor participants. [7 duplicates removed]
- 6. The LocationId, Date, InternalIncidentNatureId.1, offenderId.1, and visitorId.1 had to match. This step took away the requirement to match on the time of the incident. Any internal incident report that did not list an inmate/visitor participant were assumed to be unique entries. [114 duplicates removed]

- 7. The LocationId, Date, InternalIncidentNatureId.1, OffenderId_1, and visitorId_1 had to match. This step took away the requirement to match on the time of the incident. Any internal incident report that did not list an inmate/visitor participant were assumed to be unique entries. [8 duplicates]
- 8. The LocationId, Date, offenderId.1, and visitorId.1 had to match. This step removes the criteria that the incident had to have the same Canine Present IIR nature. Any internal incident report that did not list an inmate/visitor participant were assumed to be unique entries. A variable was created to identify the IIR retained as including both canine present natures. [68 duplicates removed]
- 9. The LocationId, Date, OffenderId_1, and visitorId_1 had to match. This step removes the criteria that the incident had to have the same Canine Present IIR nature. Any internal incident report that did not list an inmate/visitor participant were assumed to be unique entries. A variable was created to identify the IIR retained as including both canine present natures. [1 duplicate removed]

Data and Statistics Provided in the Tables in the Excel File

- <u>Total Canine Present</u> -- Total times a canine was present. This includes both IIR natures 'Canine present- force used/engaged' and 'Canine present no force/not engaged.' Incidents that were flagged as having both IIR natures in the same incident were only counted once.
- <u>Canine present force used/engaged</u> -- Total internal incident reports (IIRs) that reported 'Canine present- force used/engaged.'
- <u>% Canine Present with Engagement</u>-- Percent of canines engaged out of the total times a canine was present.

• Average Canine Presents per Month – This is the average time per month a canine was present across the 75 months (April 2016-June 2022).
