Before me this date personally appeared **RUSSO, SCOTT 1016** who being first duly sworn deposes and says that on the **24th day of March, 2015** at **4600 N STATE RD 7 CORAL SPRINGS, FL 33067-** the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

ON 3/24/15 I RESPONDED TO A CRASH WITH INJURIES AT 4600 SR 7. UPON ARRIVAL I OBSERVED NICOLA FISHER'S VEHICLE, THE 2012 BLACK FIAT 2 DOOR (FL/TAG CLCS38), STRUCK A 2008 RED HYUNDAI VAN (FL/TAG 251VMT) IN THE REAR. UPON MY ARRIVAL, THE DRIVER OF THE HYUNDAI VAN HAD ALREADY BEEN TRANSPORTED BY CSFD DUE TO THE EXTENT AND SERIOUSNESS OF HIS INJURIES.

I MADE CONTACT WITH NICOLA ON SCENE IN HER DRIVER'S SEAT, IN PHYSICAL CONTROL OF HER VEHICLE. I IMMEDIATELY RECOGNIZED THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE EMANATING FROM HER BREATH AS SHE SPOKE. HER EYES WERE RED AND WATERY, AND SHE WAS SLURRING HER SPEECH. I ASKED HER WHERE SHE WAS COMING FROM AND AFTER SEVERAL ATTEMPTS TO RESPOND DUE TO HER SLURRING AND STUTTERING OVER HER WORDS SHE STATED "LONDON". AT ONE POINT SHE ATTEMPTED TO GET OUT OF THE CAR, STUMBLING AND WAS UNSTEADY ON HER FEET. CSFD THEN PLACED HER ON A STRETCHER AND PLACED HER INTO THE RESCUE TRUCK DUE TO HER CLAIMING SHE WANTED TO GO TO THE HOSPITAL. WHILE IN THE RESCUE TRUCK ON SCENE, I INFORMED HER I BELIEVED SHE WAS UNDER THE INFLUENCE AND THAT WOULD BE CONDUCTING A CRIMINAL INVESTIGATION.
