I, JAWAN LEE #1410914 DO HEREBY STATE THAT THE FOLLOWING EVENTS TOOK PLACE AND THAT THIS AFFIDAVIT [WRITTEN STATEMENT IS MADE OF MY OWN FREE WILL AND UNDER THE PENALTY OF LAW:

1. ON 4-5-2022 I WAS A VIRGINIA PRISONER HOUSED AT A VIRGINIA SUPER MAX LEVEL 6 PRISON [REDONION STATE PRISON] LOCATED AT 10800 H JACK ROSE HWY POUND, VA 241279 ON GENERAL POPULATION - A-1 UNIT CELL #44 [TOP TIER] AND ON 4-5-2022 AT APPROXIMATELY 11:35 AM I WAS STANDING AT MY CELL [44] PREPARING TO BE LET OUT FOR TRAY FEEDING, I NOTICED THE BOTTOM TIER WAS LET OUT "TEN" CELLS" AT A TIME AS USUAL, BUT AS THOSE INMATES WERE LET BACK IN THEIR ASSIGNED CELLS, THE "FLOOR OFFICER" WHO WAS RESPONSIBLE FOR CONDUCTING POD FEEDING WAS BUSY PAYING ATTENTION TO THE CONVERSATION HE WAS HAVING WITH A [SGT - AR MULLINS] THEY "BOTH" WERE LOCATED AT THE MIDDIE POD TABLE AND "BOTH" FAILED TO FOLLOW PROCEDURE'S WHICH MEANS ENSURING THOSE CELLS 1-10 - AND 11-20 WAS SECURE AFTER INMATES RETURNED TO THEM AFTER WHICH THEY FAILED TO DO SO, SO AS 1-10 WERE LET IN - "NO" SECURITY CHECK WAS DONE THE FLOOR OFFICER'S WERE [OFC KING] AND [SERGENT A.R MULLINS] AS 11-20 WAS THEN LET OUT AND RETURNED TO CELLS "STILL" NO SECURITY CHECKS WERE MADE, THE SAME WITH CELLS 21-32, AND ~~33-44~~ ~~my~~ my GROUP OF CELLS WERE LET OUT 33-44 AND AS I PROCEEDED TO RETRIEVE MY TRAY I WALKED

DOWN THE STAIRS, I NOTICED AN INMATE [GREGORY AZEEZ] WALK PAST THE TWO CORRECTIONAL OFFICERS WHO NEVER PAID ATTENTION TO THE ACTIVITY OF THE UNIT, WHEN THEY HAD CLEAR VIEW OF THE POD AND SHOULDVE SEEN THE INMATE [GREGORY AZEEZ] COME OUT HIS CELL # 3 BOTTOM TIER, THE INMATE [AZEEZ] WALKING AGGRESSIVELY DIRECTLY TOWARDS ME, AND I REALIZED QUICKLY THE INMATE WAS ABOUT TO "ATTACK ME" I PREPARED TO DEFEND MYSELF AS THIS WAS MY RIGHT, NOT KNOWING IF THIS INMATE WAS TRYING TO CAUSE DEADLY HARM IT WAS A FIGHT FOR MY LIFE. WE FIGHT, AND AS WE DO SO WE WENT IMMEDIATELY TO THE GROUND, THERE I WAS PUT INTO A HEADLOCK AN PUNCH<sup>ED</sup> REPEATEDLY, WHILE PROTECTING MYSELF I TRIED DESPERATELY TO GRAB AZEEZ "HANDS" WHILE ON TOP OF ME. STILL NOT KNOWING IF I WAS BEING STABBED, [CO'S SGT MULLINS AND OFC KING] RAN OVER "NEVER" ATTEMPTING TO BREAK UP THE ATTACK BUT ONLY STOOD DISTANT AND SPRAYED THE "OC SPRAY" WHICH BLINDED ME ENTIRELY, THE INMATE STILL MANAGED TO CONTINUE ASSAULT, I MANAGED TO BREAK AWAY AND ATTEMPT TO COMPLY, AS I STILL WAS BLINDED "HANDS AND BODY ON THE GROUND, I FELT A "SHARP PAIN ON MY LOWER RIGHT LEG RIGHT ABOVE MY ANKLE THE PAIN FROM A K-9 "BITING DOWN" ON MY LEG CAUSED ME TO "SCREAM" OUT IN PAIN, IN A PANICK AND IN PAIN I YELLED "IM DOWN IM DOWN" AS LOUD AS I CAN, STILL THE DOG HANDLER [UNKNOWN JOHN DOE] SHOOK THE CHAIN AND THE K-9 STARTED SHAKING MY LEG VICIOUSLY AND THEN THE DOG HANDLER RIPPED THE K-9 OFF MY LEG AND I IMMEDIATELY FELT THAT MY LEG WAS GONE, I WAS CUFFED AND DESPITE THE VICIOUS AND SADISTIC ATTACK I WAS

made to WALK LIMPING ON ONE LEG, BEGGING OFFICERS TO ALLOW ME TO SIT IN A WHEEL CHAIR "I WAS DENIED" BUT FORCED TO WALK ON ONE LEG TO THE MEDICAL DEPT. STILL BLINDED I WAS "EXAMINED" BY NURSES THAT "GASPED" AND MAKING HORRIBLE SOUNDS AT THE SCENE OF MY LEG HAVING BEEN CHEWED UP, HEARING NURSES GASPED AND SAY "THIS IS BAD" "WE NEED TO GET TRANSPORT" CONFIRMED MY FEARS THAT MY LEG WAS ULTIMATELY DISFIGURED, I WAS TRANSPORTED TO "NORTON HOSPITAL" I FINALLY WAS ABLE TO SEE HOW BAD MY LEG WAS, AND I SEEN WHERE IT LOOKED AS THO A HALF OF REGULAR SIZE ORANGE CHUNK WAS RIPPED OFF OF MY LEG AND ATLEAST "8" K-9 TEETH HOLES WAS PRESENT ALL AROUND THE FRONT OF MY LEG, U COULD TELL THE K-9 "BIT DOWN" IN 2 DIFFERENT PLACES, DOCTORS HAD TO LET THE "HOLES" PUNCTURED BY K-9 LEAK OUT, AND THE SERIOUS WOUND I HAD "ZERO FEELING" IN THAT AREA "I" WAS TOLD BY DOCTOR OF NORTON THAT I HAD "EXTREME NERVE DAMAGE IN THAT AREA, I DIDNT FEEL NOTHING THE "NEEDLE" THEY USED TO PROVIDE NUMBING SOLUTION, "NOR" DID I FEEL THE NEEDLE THEY USED TO PUT ATLEAST 9 DIFFERENT STITCHES ON ONE SIDE OF MY LEG THE OTHER SIDE THAT SEVERELY HAD A CHUNK MISSING THE DOCTOR SAID "SHE" COULD SEE DOWN TO MY "BONE" AND COULD SEE WHERE THE "K-9" SCRAPED BONE... AND SAID IF THE DOG DIDNT LET GO AND WOULDVE GOT EXTRA TEETH IN MY LEG IT WOULD BE GONE" AFTER THE RETURN FROM HOSPITAL I WAS HOUSED IN MEDICAL FOR "3 WEEKS" NOT ABLE TO WALK OR APPLY ANY PRESSURE ON MY LEG, I WAS IN SO MUCH PAIN THAT I COULD NOT SLEEP, I WASNT GIVEN

"NO" PAIN MEDICINE BUT "TYLENOL", EVERY NIGHT I WAS HAUNTED BY THE EVENT THAT TOOK PLACE 4-5-2022 IN A-1 # HOUSING UNIT, NIGHTMARES OF THE DOG BITTING MY LEG OFF AND DAILY FLASHBACKS @ EVERYTIME I HEAR A "DOG BARK", I JUMP IN MY SLEEP, "TOSS AND TURN" EVERY NIGHT, I TRIED COMPLAINING TO "MENTAL HEALTH" THEY CAME TO SEE ME "ONE" TIME TOLD ME FILL OUT PAPERWORK PACKET I DID SO AND "NEVER" DID THAT DEPT. RETURN TO SEE ME, "NOT ONCE" [IN PACKET I STRESSED MY DEEPEST FEELINGS THAT I HAVE THESE REGULAR EPISODES AND THAT I CLINCH MY JAW" AND TENSE UP "EVERY" TIME I HEAR A "DOG" WHICH HAS BEEN ALMOST DAILY, NO HELP CAME AT ALL AND I COMPLAINED I COULD NOT SLEEP, NO HELP, ONLY HELP I RECEIVED WAS THERAPY FOR MY LEG WHICH WAS FOR ABOUT A MONTH, ONCE OR TWICE A WEEK! I SUFFER STILL EVERYDAY" FEAR THAT I WILL BE ATTACKED AGAIN BY K-9, IVE BEEN TARGETED BY ADMINISTRATION WHEN I SUBMIT COMPLAINTS" WHICH I ENCLOSED WITH THE WRITTEN STATEMENT OF FACTS, I HAVE BEEN "RETALIATED" AGAINST ~~ONE~~ <sup>BY</sup> [OFC KING] SET MULLINS] AND THE [MAJOR KING] THAT I WILL BE TRANSFERRED IF I CONTINUE WITH THE STEPS OF MY COMPLAINTS, WHEN INMATES ARE SUPPOSE TO HAVE FREEDOM TO WRITE COMPLAINTS IN "GOOD FAITH" FIRST I WAS CALLED OUT BY [LT BARTA] OF HOUSING UNIT A-1 ABOUT COMPLAINT I PUT IN RELATING TO INCIDENT FROM [4-5-22] INTO THE "LT OFFICE AND I WAS ACCOMPANIED BY ANOTHER INMATE [MARK DEYE] OF A-1 TO BE A BYSANDER WITNESS" TO ENSURE THAT I WASNT BEING SET-UP FOR RETALIATION, AND SO "I" JAWAN LEE WAS IN THE

OFFICE WITH "LT BARTA" OF A-1 AND "SGT A.R. MULLINS"  
THE SAME ONE WHO WAS "PRESENT" IN A-1 DAY ROOM  
THE DAY THAT ATTACK ON ME HAPPENED ON [4-5-22]  
LT BARTA "ADMITTED" THE OFFICERS VIOLATED PROCEDURES  
"BY NOT SECURING DOORS AND DOING ROUND OF SECURITY  
CHECKS AFTER THOSE 1-10 CETIS AND ETC WAS LET OUT"  
AND RETURNED BACK INTO CETIS, WHICH IS "DOCUMENTED"  
ON COMPLAINT FORM ENCLOSED [LOG # 00631] ASSIGNED  
TO UM OF A BODG "DAY" AND IT "STATES", "I LT  
BARTA ALONG WITH "UM" DAY "CORRECTED" AND ADD-  
RESSED THE ISSUE WITH THE OFFICERS, CONCERN-  
ING THE CETI DOORS BEING UNSECURED! DATED: 4-28-  
22- AND SIGNATURE BY LT M. BARTA! SO WITH THE  
OFFICE VISIT LT BARTA ATTEMPTED TO GET ME TO WITH-  
DRAW MY COMPLAINT BY SAYING THE DOG HANDLER  
WAS SANCTIONED FOR HIS EXCESSIVE FORCE ACT AND  
I "JAWAN LEE ASKED LT BARTA WHAT WAS THE GIVEN  
SANCTION, AND HE TOLD ME HE DIDNT KNOW BUT THAT  
DEPT. THAT HANDLES DOG HANDLERS OF K-9 WAS  
INFORMED, SO HE PROCEEDED TO TELL ME AN INVESTIGA-  
TION WAS BEING COMPLETED! I TOLD HIM I WILL NOT  
WITHDRAW MY COMPLAINT AND SGT MULLINS SAID "DONT  
TAKE NOTHING PERSONAL THEN" AND I DIDNT  
RESPOND NOT WANTING TO GIVE THEM A REASON TO  
DO ANYTHING TO ME, AND THAT DAY WAS 4-27-22  
AND THEN ON [5-5-22] I WAS CALLED OUT MY CETI  
BY [MAJOR KING] AND I ASKED A INMATE TO BE  
A WITNESS TO ENSURE NOTHING HAPPENS TO ME AND  
TO BE A WITNESS. ENCLOSED I SUBMITTED HOW ..  
I WAS SUBJECT TO MENTAL ABUSE BY "MAJOR KING"  
HE TOLD THE INMATE TO GO BACK IN THE POD, I TOLD KING

I WAS AFRAID THAT I WILL BE RETALIATED AGAINST BY THEM AND "HE STATED IF U WAS SCARED WE CAN GO IN THE POD" WE WENT IN THE POD TO THE TABLE SO I WAS VISUAL IN FRONT OF OTHER WITNESSES, HE STARED ME DOWN, 1 FEET AND KNEW HE WAS TRYNA INTIMIDATE ME" HE SAID MY COMPLAINT WAS "BULLSHIT" AND AGAIN REPEATED WHAT OTHER OFFICERS HAS BEEN SAYING AND THATS "IF I "CONTINUE" TO SUBMIT MY COMPLAINT I WILL BE SHIPPED TO WARSEY'S RIDGE WHERE HE WAS JUST AT LAST YR AND I WILL GET MY ASS BEAT BY OFFICERS" THIS I SUBMITTED A COMPLAINT ON [5-10-22] AFTER BEEN REFUSED FOR 5 DAYZ COMPLAINT FORMS BY OFFICERS OF A-1 ! I NEVER ASKED HIM " TO BE TRANSFERRED AS I NEVER HAD A CONVERSATION WITH HIM "MAJOR KING BEFORE" BUT THAT WOULD NOT BE THE "LAST" TIME, [ON 5-17-2022]

JUST "7 DAYS" AFTER THAT HAPPENED WITH "MAJOR KING" C.O'S SEARCHED MY CELL ATLEAST 7 OFFICERS AND INCLUDED WAS LT BARTA AND SGT MULLINS THEY TOOK MY T.V FOR ABSOLUTELY "NO" REASON AND SO I ASKED THE OFC WHY MY TIV WAS TAKEN HE SAID " ASK SGT MULLINS AND CONTINUED TO LAUGH ! I STOOD UP TO ASK SGT MULLINS WHY MY TIV WAS TAKEN " I WAS TOLD TO SIT DOWN I RESPECTFULLY DID, BUT 5 MINUTES LATER I WAS ESCORTED TO THE HOIE / SEGREGATION AND GIVEN "TWO" FALSE CHARGES, A APPROACHING IN A THREATENING MANNER AND A INTENTIONAIN/ DESTROYING, ALTERING, DAMAGING, OR DEFACING CHARGE, OF A SPRAY THEY CLAIM WAS BURNT AT THE NOZZLE AND WAS IN A PROPERTY BAG I NEVER HAD, AND WITNESS FROM CELL MATE SAYING NO BOTTLE WAS BURNT OR ALTERED. SO I WAS IN THE HOIE B-4#11

AND TOLD I WILL BE IN THE HOLE 2 WEEKS FOR BEHAVIOR,  
AND MY TIV WAS TAKEN AND I DIDNT GET A CONFISCATION  
FORM UNTIL I COMPLAINED AND SUBMITTED COMPLAINT  
AND IN WHICH MAJOR KING INSTRUCTED SGT LITTLE  
AND LT CORNETT TO REMOVE ME FROM SHOWER IN  
WHICH I WALKED OUT IN LEG TRONS AND HAMS BTIND  
MY BACK, TURNED TO WALK UPSTAIRS, I WAS STOPPED  
AND TOLD I HAD TO GO INTO OFFICE I WAS TOLD "NO"  
I DONT WANT TO TALK TO NOBODY" BUT FORCED  
TO GO IN OFFICE, CHAINED TO THE TABLE A MINUTE  
LATER MAJOR KING, LT FIEMING, UIM MILLER, SGT  
LITTLE, AND LT CORNET WAS ALL IN OFFICE, AND READ  
OUT LOUD ALL 3 COMPLAINTS THAT I ENCLOSED, THE  
OFFICERS CROWDED AROUND ME, I FELT SCARED ~~OF~~ THIS  
WOULD TURN INTO ANOTHER ASSAULT, THEY SHOWED  
AGGRESSIVE BEHAVIOR, STARRING AT ME, IT WAS A INTIM-  
IDATION TACTIC, WHEN HE READ WHAT I WROTE ABOUT  
MY TIV BEING CONFISCATED, BUT RIGHTS BEING VIOLATED  
I NEVER GOT A CONFISCATION FORM, HE SAID "SO U  
WANT ME TO GET YOUR TIV WHEN U ARE WRITTING  
COMPLAINTS" I SAID I WANT MY PROPERTY BECAUSE ITS  
NOT ACTERED OR ANYTHING, SO HE SAID U WANT ME  
TO DO SOMETHING FOR YOU, I CUT HIM OFF AND  
SAID I WANT YOU TO DO UR JOB, THEN HE  
SAID PUT THIS "ASSHOLE" BACK IN HIS CELL! BEFORE  
LEAVING HE SAID "I TOLD GRIEVANCE COORDINATOR  
TO GIVE ME ALL UR COMPLAINTS" SO WITH THAT  
BEING SAID ANYTHING I WRITE WENT TO KING DONT  
MATTER HOW SMALL HE WOULD RESPOND A MAJOR  
I FELT HELPLESS, THE SECURITY IN KNOWING I  
COULD SUBMIT ISSUES IN GOOD FAITH IS LOST WITH



THAT STATEMENT, THAT INCIDENT HAPPENED ON 5-25-2022  
IN B-4 PHU OFFICE SEE CAMERA FOOTAGE YOU WILL  
SEE INCIDENT OCCUR, I WROTE COMPLAINT WHICH WAS  
TAKEN SO I HAVE ATTEMPT TO WRITE IT ON GRIEVANCE  
AND I WAS GIVEN IT BACK, EVERY TIME I TRIED TO SUBMIT  
THE COMPLAINT IT WOULD NEVER COME TO ME!  
ENCLOSED IS THE THREE COMPLAINTS I WROTE AND  
RESPONSES ALL FROM [MAJOR C. KING] AND AFTER  
MY 2 WEEKS IN SEGREGATION I WENT BACK TO GENERAL  
POPULATION AND ON 6-8-2022 I RECEIVED RESPONSE  
FROM LT BARTA OF "A BUILDING" WHICH I ENCLOSED  
ALSO AND HE STATES I "RECEIVED MY T.V. BACK WHICH  
WAS SO "ODD" TO ME, BECAUSE PROPERTY DIDNT GIVE  
IT BACK, WHICH MEANT THEY HELD MY T.V. IN  
THEY OFFICE, BUT WANTED TO PUNISH ME, AS A  
WAY TO HOLD IT OVER MY HEAD TO GET ME TO  
WITHDRAW COMPLAINTS, I'M SORRY I'VE BEEN THRU THE  
MOST WITH THIS COMPOUND AND EMOTIONAL DISTRESS IS  
NOT THE WORDS TO DESCRIBE ALL THE THINGS I  
BEEN SUBJECT TO, FOR THOSE 2 WEEKS IN THE TOWER,  
THEY DIDNT GIVE ME "NO" OUT OF CELL RECREATION  
AND WITH NO T.V. I WAS SUBJECT TO ENDURE BAD  
VISIONS OF DOGS ATTACKING ME, NOT KNOWING IF  
I WAS GONE GET ATTACKED BY C.O.'S AND THEN TO  
BE LET OUT THE CELL HOLE AND GIVEN MY T.V.  
BACK! WHY? WHY TAKE IT NOBODY EVER SPOKE  
OF THAT, SO AFTER THAT THE ~~PROPERTY~~ PROPERTY I  
WAS GETTING ORDERED "MIRACULOUSLY" STOP COMING  
TO ME, ON 8-8-2022 A PACKAGE WAS SENT TO  
ME, VIA POSTAL PRIORITY MAIL AND I NEVER GOT IT  
NEVER EVEN WAS AWARE OF THE ORDER UNTIL

I WAS NOTIFIED BY FAMILY MEMBER OF THE ORDER SO  
I WROTE COMPLAINT IN WHICH I ENCLOSED THE RESPONSE  
CLAIMING "I" RECEIVED THAT ORDER ON 8-16-2022  
AND MAJOR KING LIES SAYING HE REVIEWED CAMERA  
FOOTAGE THE DAY 8-16-2022 AND HE SEEN ON  
"THIS IMAGINARY FOOTAGE" ME SIGNING AND GETTING  
MY ORDER, I QUICKLY SENT BRIEVANCE AND HE  
CHANGES HIS RESPONSE SAYING INTEL HAVE THOSE  
ITEMS IM TALKING BOUT AND IT WAS CONFISCATED,  
NOW I DIDNT RECEIVE CONFISCATION FORM TILL [10-13-  
22] "2 MONTHS" AFTER PACKAGE WAS SENT TO [ROSP]  
AND SIGNED FOR, MAJOR KING COVERED UP THAT BUT  
I GOT MY FAMILY TO CONTACT COMPANY AND THEY  
PROVIDED TRACKING #S AND THATS WHEN THE TRUTH  
CAME TO LIGHT ENCLOSED IS PROOF, I APPEALED THE  
CONFISCATION OF MY ITEMS AND THE COMPANY RECEIVED  
FOLLOW UP FROM VADOC THAT NO EVIDENCE OF NEGLIGENCE WAS FOUND" IT WAS ALL A LIE, IT WASNT  
NOTHING BUT 5 JOURNALS WHAT WAS SUSPICIOUS
