To Whom It May Concern:

This is a request for a Mandatory Declassification Review (MDR), under the terms of Executive Order 13526, for a declassification review of: all of the "captured documents/interrogation reports" referenced in the 3730-94-0051 inventory of what is in the Central America Joint Intelligence Team (CAJIT) files from 1983 to 1992. The inventory document referencing the CAJIT files has been attached for your convenience (Attachment 1). There are 50 boxes mentioned in the 3730-94-0051 inventory document we obtained through our litigation with the Department of Defense. We would like to point out that boxes 48 through 50 do not have document numbers listed, they instead have identifying descriptions so please include those descriptions in your search. The inventory was released to us by your agency, so we are confident that the documents we are requesting are in the possession of the Defense Intelligence Agency. I have also attached the letter from the DIA in which the inventory was released to our organization (Attachment 2).

Below is the list of the 50 boxes and the numbers of the documents contained in each box as described in the 3730-94-0051 inventory. The documents inside each box are referred to in the inventory as captured documents/interrogation reports. We are requesting all of the captured documents/interrogation reports inside these 50 boxes listed below for a Mandatory Declassification Review:
