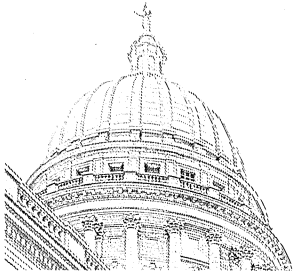

Recently, Ms. Meagan Wolfe suggested that I write to you regarding the nonpartisan Legislative Audit Bureau's (LAB's) ongoing audit of elections administration.

First, on April 13, 2021, I emailed you a copy of a February 8, 2021 memorandum that describes the scope of this audit effort, and I invited you to contact LAB to schedule an opportunity to share any perspective you have about the subject matter. Such an invitation was also extended to other stakeholder groups, including the county and municipal clerks associations, and is typical in our work. As of today, four commissioners have contacted us in response to our invitation, and two commissioners have not responded to our invitation. If you have responded, thank you for doing so. If you have not yet responded, I again invite you to provide your perspective on matters related to the audit scope, which may include your insights about resources, contacts, or processes that you believe are important for us to consider as we conduct our audit work.

Second, on April 14, 2021, I received a letter from the chairperson that asked me to identify the statutory basis for the confidentiality of LAB's audit process. As I indicated in my response on April 21, 2021, s. 13.94, Wis. Stats., states:

"The bureau shall be strictly nonpartisan and shall at all times observe the confidential nature of any audit currently being performed."

As external auditors, we will gather information, including from the staff of the Wisconsin Elections Commission, and use it to perform our analyses independently. I anticipate our audit work will be ongoing for several months.

I hope you find this information helpful.

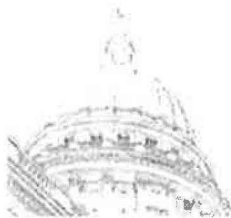



The Bureau announces the release of *Elections Administration* ([report 21-19](#)).

As directed by the Joint Legislative Audit Committee, we evaluated elections administration issues, including:

- efforts by the Wisconsin Elections Commission (WEC) to comply with election laws, including by working with clerks to ensure voter registration records include only eligible voters, and by providing training and guidance to clerks;
- efforts by clerks to comply with election laws, including by administering elections, processing absentee ballots, and performing recount responsibilities, as well as the observations and concerns of clerks regarding elections administration;
- the use of electronic voting equipment, including the methodology and results of WEC's most-recent statutorily required post-election audit and the actions taken as a result of this audit; and
- General Election-related complaints filed with WEC and clerks, as well as how these complaints were addressed.

Because our audit was not approved until three months after the November 2020 General Election, we did not directly observe Election Day practices. Therefore, to complete this audit we relied on available evidence we were able to access. We contacted WEC's staff, surveyed all 1,835 municipal clerks and 72 county clerks in April 2021, contacted 179 clerks to obtain additional information about elections administration issues, analyzed voter registration data, physically reviewed 14,710 certificates that accompanied absentee ballots returned to clerks in 29 municipalities throughout the state, reviewed the results of 175 statutorily required tests of electronic voting

equipment that clerks in 25 municipalities completed before the November 2020 General Election, and reviewed all 45 sworn, written complaints pertaining to the General Election that were filed with WEC as of late-May 2021.

We make 30 recommendations to WEC's staff for various improvements and include 18 issues for legislative consideration.

equipment that clerks in 25 municipalities completed before the November 2020 General Election, and reviewed all 45 sworn, written complaints pertaining to the General Election that were filed with WEC as of late-May 2021.

We make 30 recommendations to WEC's staff for various improvements and include 18 issues for legislative consideration.
