ON 10/1/18, AT APPROX. 1851 HOURS, I WAS DISPATCHED TO 15624 AVEBURY MANOR PLACE IN REFERENCE TO A SUICIDE THREAT. UPON ARRIVAL, I MET WITH [REDACTED]. SHE ADVISED THAT HER HUSBAND, [REDACTED], HAD MADE A SUICIDAL STATEMENT TO HER TODAY.

SHE WENT ON TO SAY, THAT EARLIER THIS EVENING, SHE SAW THAT [REDACTED] WAS DRUNK. SHE TOLD HIM THAT HE WAS AN ALCOHOLIC AND THAT HE NEEDED TO GET HELP. HE REPLIED, "I'VE JUST BEEN WAITING FOR YOU TO KILL ME". I ADVISED HER THAT I NEEDED MORE THAN THAT, IN ORDER TO TAKE HIM INTO CUSTODY UNDER AN ECO. SGT. SALAMIDA ATTEMPTED TO CALL HIM WITH NO SUCCESS. I WENT TO HIS HOUSE AND KNOCKED ON THE DOOR BUT HE DID NOT ANSWER THE DOOR. THE PROCESS FOR OBTAINING AN ECO WAS EXPLAINED TO HER AND SHE DECIDED TO GET THE MAGISTRATE TO ISSUE AN ECO.

AT 2030 HOURS, MAGISTRATE WALLER ISSUED AN ECO FOR [REDACTED]. I RESPONDED BACK TO THE HOUSE AT 2145 HOURS AND PLACED HIM IN CUSTODY UNDER THE ECO. I TRANSPORTED HIM TO CORNWALL ER WHERE ASHLEY FROM MENTAL HEALTH INTERVIEWED HIM. AFTER SPEAKING WITH HIM, ASHLEY DETERMINED THAT SHE WAS GOING TO HAVE THE MAGISTRATE ISSUE A TDO FOR HIM.

AT 0315 HOURS, I EXECUTED THE TDO AND TRANSPORTED HIM UPSTAIRS TO LAMPS.

NO FURTHER, CASE CLOSED.
