

This is his obituary: https://www.cbsnews.com/news/robert-hanssen-dies-convicted-spying-for-russiadead-age-79/Here is a statement from the Bureau of Prisons: On Monday, June 5, 2023, at approximately 6:55 am, inmate Robert Hanssen was found unresponsive at the Federal Correctional Complex (FCC) specifically, the ADX in Florence, Colorado. Responding staff immediately initiated life-saving measures. Staff requested emergency medical services and life-saving efforts continued. The inmate was subsequently pronounced dead by outside emergency medical personnel. The Federal Bureau of Investigation was notified. No staff or other inmates were injured, and at no time was the public in danger. The requested documents will be made available to the general public as part of a piece of journalism, and this request is not being made for commercial purposes. In the event that there are fees, please inform me of the total charges in advance of fulfilling my request (512-653-100). I would prefer the request be filled electronically, by e-mail attachment if available or CD-ROM if not. Thank you in advance for your anticipated cooperation in this matter. I look forward to receiving your response to this request within 20 business days, as the statute requires. Background: Robert Philip Hanssen was an FBI agent from 1979 until 2001, when he was arrested and pled guilty to 15 counts of espionage. He was held in federal custody until his death on June 5, 2023. Most of his prison term was served at the maximum security facility in Florence, CO.
