ORDINANCE NUMBER

An Ordinance concerning offences and prescribing penalties therefor in the City of Anaheim.

The Board of Trustees of the City of Anaheim do ordain as follows:

Section, ----I, --- It shall be unlawful for any person or persons to maliciously or willfully disturb the peace and quiet of any neighborhood, family, public meeting, or assembly of people met for religious worship in the City of Anaheim, by loud or unusual noises, offensive conduct, threatening, traducing, quarrelling, challenging to fight or fighting, or by using obscene language, or gesture;

Section, \gtrsim ---It shall be unlawful for any person or persons to appear upon any highway or public place in a state of intoxication or drunkenness, or in any private grounds to the annoyance of any person therein, in the City of Anaheim;

Section, 3---- It shall be unlawful for any person or persons to behave in an indecent or lewd manner or to make any indecent exposure of their person or to perform any indecent or immoral or lewd play or representation, or to bathe in any public manner, or to create any noise, disorder, or tumult within the City of Anaheim:

Section, 4----It shall be unlawful for any person or persons to fire or discharge any pistol, gun, or other discription of fire arms, or fire works of any kind in the City of Anaheim; Provided that mothing, herein contained shall prohibit any marshal, constable, or police officer from the necessary use of such firearms in the discharge of his official duty;

Section, 5---- It shall be unlawful for any person or persons within the City of Anaheim to draw or to exhibit any firearms,

or knife, or other deadly weapon against the person of another, or otherwise exhibit or display such weapon in a rude, angry or threat ening manner, except in defense of person or property;

Section, 6----It shall be unlawful for any person or person to resist the marshal or any other peace officer, of the City of Anaheim, within the corporate limits of said City, while in the discharge of his official duty, or to refuse to assist any such officer, in the discharge of his duty, when summoned or so requested to do by such officer;

Section, 7----It shall be unlawful for any person or persons within the corporate limits of the City of Anaheim, to carry any pistol, or other deadly weapon, concealed about his person, provided that this section shall not apply persons coming to or leaving or going through said City, for the space of one hour before leaving the town, or after arriving in the said City, nor to persons in the military service, of the United States, or of this State, or members of the militia while in actual duty, or parade, nor to any sheriff, marshal or policeman, or other peace officer, while in the discharge of his official duty;

Section 3----It shall be unlawful for any person or persons to leave in any public street, highway or commons in the City of Anaheim, any horse, mare, mule, jack, jenny or teamof such animals without being securely tied or held so as to prevent their stampeding or running away, nor shall any such animals be ridden or driven along any public street or highway in the City of Anaheim, in a reckless manner or at an immoderate rate of speed, nor shall any such animal be ridden or driven upon any sidewalk within the City of Anaheim;

Section, 9---- It shall be unlawful for any person or persons to keep, ride or drive any wild or unbroken horse mare or other wild untamed or vicious animal in the streets or public grounds of the City of Anaheim;

Section, IO, ---- It shall be unlawful for any person or persons to throw into or deposit upon any public street, highway or common within the City of Anaheim, any glass, broken-ware, rubbish, garbage, dead animals or filth;

Section II, ---It shall be unlawful for any person or persons to dig or cause to be constructed, for irrigation purposes, any ditch, across any street, highway or commons of the City of Anaheim, or to construct or maintain any irrigating ditch along any street, sidewalk, highway or common of the City of Anaheim unless permission to construct or maintain said ditch is first obtained from the Board of Trustees of said City on petition duly presented to said Board at some regular or special meeting thereof;

Any person or persons, who shall for purposes of irrigation dig or cause to be constructed any ditch across or along any public street, highway, or common of the City of Anaheim, shall be compelled to make such ditch so that it will present no obstruction to travelers, or teamsters, or in any way endanger the lives or limbs of travelers on said streets, highways or commons, and any person or persons who may make or cause to be made or constructed such ditch must after using the same, immediately fill the same up to the level of the street;

Section, I2----All owners of, or managers of stallions, jacks or bulls who have such animals within the City of Anaheim for the purposes of propagation shall keep such stallion, jack or bull in suitable buildings, removed from public view, when engaged in service, and the owner or manager of such stallion, jack or bull shall exclude from such building all children;

Section, 13----It shall be unlawful for any person or persons

having the ownership or care of any horses, mules, mares, jacks jennets, cattle, goats, sheep or swine, to suffer the same to run at large, be herded, or picketed upon any highway, street, or public grounds within the City of Anaheim, or to picket or fasten any of t the before mentioned animals in such a manner as to permit them to encroach upon said highways, streets or public grounds;

Section I4---- It shall be unlawful for any person or persons to use any fire or water hydrant, or lamp post for hitching purposes within the City of Anaheim;

Section 15---- Every person who violates any of the provisions of this Ordinance, shall be deemed guilty of a misdemeanor, and on conviction thereof, shall be punished therefor, by a fine of not less than ten dollars nor more than one hundred dollars, or by imprisonment not exceeding thirty days, or by both such fine and imprisonment;

Section I6, --- The City Clerk shall certify to the passage of this ordinance, and cause the same to be published once in the Anaheim Anaheim and thereupon and thereafter it shall take effect and be in full force;
