The undersigned has reason to believe that the Defendant committed the following offense(s):

**COUNT 1: AGGRAVATED CHILD ABUSE**, a second degree felony, in that the defendant, intentionally or knowingly, inflicted upon a child (RF) serious physical injury or, having the care or custody of such child, caused or permitted another to inflict serious physical injury upon said child (and such serious physical injury includes physical torture), in violation of Section 76-5-109.2, Utah Code Annotated, 1953, as amended.

**COUNT 2: AGGRAVATED CHILD ABUSE**, a second degree felony, in that the defendant, intentionally or knowingly, inflicted upon a child (RF) serious physical injury or, having the care or custody of such child, caused or permitted another to inflict serious physical injury upon said child (and such serious physical injury includes any conduct that results in starvation or failure to thrive or malnutrition that jeopardizes the child's life), in violation of Section 76-5-109.2, Utah Code Annotated, 1953, as amended.

**COUNT 3 AGGRAVATED CHILD ABUSE**, a second degree felony, in that the defendant, intentionally or knowingly, inflicted upon a child (RF) serious physical injury or, having the care or custody of such child, caused or permitted another to inflict serious physical injury upon said child (and such serious physical injury includes conduct toward a child that results in severe emotional harm, severe developmental delay or intellectual disability, or severe impairment of

the child's ability to function), in violation of Section 76-5-109.2, Utah Code Annotated, 1953, as amended.

**COUNT 4: AGGRAVATED CHILD ABUSE**, a second degree felony, in that the defendant, intentionally or knowingly, inflicted upon a child (EF) serious physical injury or, having the care or custody of such child, caused or permitted another to inflict serious physical injury upon said child (and such serious physical injury includes any conduct that results in starvation or failure to thrive or malnutrition that jeopardizes the child's life), in violation of Section 76-5-109.2, Utah Code Annotated, 1953, as amended.

**COUNT 5 AGGRAVATED CHILD ABUSE**, a second degree felony, in that the defendant, intentionally or knowingly, inflicted upon a child (EF) serious physical injury or, having the care or custody of such child, caused or permitted another to inflict serious physical injury upon said child (and such serious physical injury includes conduct toward a child that results in severe emotional harm, severe developmental delay or intellectual disability, or severe impairment of the child's ability to function), in violation of Section 76-5-109.2, Utah Code Annotated, 1953, as amended.

**COUNT 6: AGGRAVATED CHILD ABUSE**, a second degree felony, in that the defendant, intentionally or knowingly, inflicted upon a child (EF) serious physical injury or, having the care or custody of such child, caused or permitted another to inflict serious physical injury upon said child (and such serious physical injury includes any combination of two or more physical injuries inflicted by the same person, either at the same time or on different occasions, in violation of Section 76-5-109.2, Utah Code Annotated, 1953, as amended.
