First PIT Attempt:

I WAS PATROLLING ON SOUTH-14 AND OLD-66 IN TIJERAS. AT APPROXIMATELY 8:19 P.M. I OBSERVED A FEMALE STANDING OUTSIDE OF A VEHICLE, ON THE DRIVER'S SIDE WITH THE DOOR OPEN, SHE WAS STARING ACROSS THE STREET. I ACTIVATED MY EMERGENCY EQUIPMENT AND CONDUCTED A MOTORIST ASSIST. THIS VEHICLE WAS STOPPED ON THE ROADWAY AND OTHER VEHICLES HAD TO DRIVE AROUND IT.

I MEET WITH THE DRIVER WHO WAS LATER IDENTIFIED TO ME AS KAREN SINCORE BY HER NEW MEXICO DRIVER'S LICENSE. WHILE SPEAKING WITH MS. SINCOFRE, I COULD SMELL AN ODOR OF AN ALCOHOLIC BEVERAGE EMITTING FROM HER BREATH. I HAD MS. SINCORE PERFORM THE SFST'S TO DETERMINE SHE WAS OPERATING HER VEHICLE SAFLEY. MS. SINCORE HAD STATED SHE HAD BEEN DRINKING AT THE RIBS RESTAURANT IN TIJERAS, NM PRIOR TO DRIVING.

DURING THE SFST'S I OBSERVED SIGNS OF IMPAIRMENT. I THEN DECIDED TO PLACE MS. SINCORE UNDER ARREST FOR SUSPICION OF DUI. I GRABBED HER LEFT WRIST AND PLACED A HANDCUFF ON IT, AS I WAS ATTEMPTING TO SECURE HER RIGHT WRIST SHE TURNED AROUND AND BEGAN TO ACTIVELY RESIST. SHE ALSO BECAME VERY IRATE, AND EMOTIONAL.

I ESCORTED MS. SINCORE TO THE RIGHT REAR PASSENGER SEAT OF MY PATROL VEHICLE. AT MY PATROL VEHICLE MS. SINCORE WAS ABLE TO SLIP THE LEFT HANDCUFF AND TURN AROUND AGAIN. SHE THEN PULLED HER PANTS DOWN AND BEGAN TO URINATE IN THE ROADWAY. WHILE MS. SINCORE WAS URINATING SHE THEN GRABBED AHOLD OF MY LEG.

I ESCORTED MRS. SINCORE TO THE BACK OF MY UNIT TO SECURE HER IN THE BACK SEAT AND SHE BECAME RESISTANT; SHE BECAME RIGID PULLED AWAY FROM ME AND WOULD NOT COMPLY WITH MY ORDERS. MRS. SINCORE WAS ABLE TO TAKE ONE OF THE HANDCUFFS OFF HER WRIST AND PULL HER PANTS DOWN TO URINATE IN THE ROADWAY NEXT TO MY PATROL UNIT. SHE CONTINUED TO PLEAD WITH ME TO NOT TAKE HER TO JAIL. MRS. SINCORE CONTINUED TO SIT ON THE ROADWAY AFTER URINATING, AND NOT COMPLYING WITH MY COMMANDS TO PULL HER PANTS UP, SO I COULD PLACE HER ON THE BACK SEAT OF MY PATROL VEHICLE.

AS I WAS ATTEMPTING TO LIFT HER UP FROM THE GROUND, SHE BEGAN TO PULL AWAY AGAIN STATING, "NO." SHE REFUSED TO GET UP FROM THE GROUND. SHE SAT DOWN ON MY BOOTS AND URINATED ON THE ROAD AND MY BOOTS. SHE WRAPPED HER LEGS AND ARMS AROUND MY RIGHT LEG SO I COULD NOT SECURE HER IN THE BACK SEAT OF MY PATROL UNIT. AS I CALLED FOR ASSISTANCE, SHE STOOD UP. I TOLD HER TO GET INTO THE BACK OF MY PATROL VEHICLE, AND I TRIED TO PLACE THE HANDCUFF BACK ON HER WRIST, AND SHE CONTINUED TO PULL AWAY FROM ME. I TOLD HER SHE WAS FIGHTING ME, AND SHE SAID, "OF COURSE I'M FIGHTING YOU."

TWO BERNALILLO COUNTY SHERIFF (BCSO) DEPUTIES ARRIVED ON THE SCENE TO ASSIST ME IN RESTRAINING MRS. SINCORE. AS I WAS TRYING TO PLACE THE LEFT HANDCUFF ON HER LEFT WRIST SHE AGAIN TURNED AROUND, BEGAN TO PULL AWAY, AND BEGAN SCREAMING. MRS. SINCORE THEN DROPPED TO THE GROUND ONTO HER BACK. I WAS ABLE TO SECURE HER HANDS BEHIND HER BACK AND LIFTED HER UP AND ESCORTED HER TO THE BACK OF MY PATROL VEHICLE WITH THE HELP OF THE BCSO DEPUTIES. AS WE WERE ESCORTING HER SHE CONTINUED TO PUSH BACK. AS WE WERE PLACING HER IN THE BACK SEAT OF MY PATROL VEHICLE, SHE PUT HER LEGS UP IN THE DOOR JAM AREA PUSHING BACK, NOT ALLOWING US TO PLACE HER IN MY PATROL UNIT. MRS. SINCORE WAS ABLE TO SLIP HER LEFT HANDCUFF AGAIN.

MRS. SINCORE AGAIN DROPPED TO THE GROUND AND BEGAN TO SWING A CLOSED FIST TOWARD ONE OF THE BCSO DEPUTIES. SHE WAS TOLD SEVERAL TIMES TO ROLL ONTO HER STOMACH, AND SHE CONTINUED TO TURN TOWARD HER BACK. SHE CONTINUED TO STATE SHE WILL CONTINUE TO FIGHT ME. SHE ALSO BEGAN TO KICK AT ONE OF THE DEPUTIES. THE TWO DEPUTIES WERE ABLE TO GET HER ON HER STOMACH AND WE WERE ABLE TO SECURE HER HANDS BEHIND HER BACK.

NMSP OFFICER DAVID ALLEN ARRIVED ON SCENE, AND WAS ABE TO LIFT HER UP FROM THE GROUND AND PLACE HER ON THE BACKSEAT OF MY PATROL VEHICLE, WHERE SHE WAS SECURED. HER LEGS WERE ALSO RESTRAINED WITH LEG RESTRAINTS.


Incident Summary

At approximately 1024 hours, NMSP Officer Antonio Carrillo and I arrived at 711 Fahey Street which is the primary listed address for Rogelio Cano from his driver's license. Rogelio had three Warrants for his arrest (M-20-VM-2021-00011, M-20-FR-2020-00063, M-19-VM-2021-00057). I knocked on the front door and Rita Salgado (mother of Rogelio) answered and stated Rogelio was not home. As soon as she opened the door I identified and observed Rogelio standing directly behind her but he immediately turned his back. I called him by name several times to which he ignored. Mrs. Salgado then opened the door and I entered the residence. I grabbed his arm and attempted persuade Rogelio to come outside. He began resisting by stiffening and pulling away toward an open bedroom door. I began to push Rogelio toward the front entrance toward his residence. Officer Carrillo and I attempted to pull him outside but he continued to resist. I yelled for him to go outside to which he ignored while he was positioned in the front door frame. Officer Carrillo gave verbal commands as well as he was pulling him as I was pushing him. Rogelio pinned himself in the door frame and refused to exit. At this time I drive stunned Rogelio the top left portion of his back for 2-3 seconds through a sweatshirt. Rogelio fell to the ground still positioned in the door frame and refusing to exit. I then drive stunned Rogelio in the left thigh for 2-3 seconds through basketball style shorts as Officer Carrillo pulled him. Rogelio exited the door frame onto the porch and was handcuffed behind his back. EMS was called and photographs were taken of the drive stun locations.

I conducted a felony stop on the sole male driver. The male exited the vehicle and immediately began ignoring my commands to get on the ground. The male appeared to start walking back to his vehicle. He continued to ignore my commands to lay on the ground. At that point I deployed my department issued X2 taser on the suspect. The deployment caused the suspect to fall onto the pavement. After the 5 second cycle i continued to order the suspect to roll over. He continued to ignore my commands. I had to cycle the taser 3 additional times. Each time approximately 1 second in length. The suspect finally complied by rolling over completely.

EMS arrived on scene to evaluate the suspect and remove the prongs.





Incident Summary

Altercation between prisoner in custody and officer.

Mr. Dominguez was placed in the holding room and secured to a bench with handcuffs.

As I was completing paperwork, Mr. Dominguez became irate he was handcuffed to the bench in the office as he wanted to "lay down and take a nap." At this time, I activated my body camera because Mr. Dominguez was very upset and lead me to believe he would be violent.

Mr. Dominguez slammed the door to the holding room. I opened the door to the holding room and told Mr. Dominguez he is not to close the door, he does not make rules here, and we would be leaving the office soon. Mr. Dominguez calmed down, then became irate again that he was still handcuffed to the bench in the holding room stating the handcuff was too tight. When I put the handcuffs on Mr. Dominguez earlier in the day I fit my pointer finger inside the cuff, it was double locked, and Mr. Dominguez was able to rotate his wrist inside the handcuff. Mr. Dominguez had no markings on his wrist and the handcuffs were not tight. I told Mr. Dominguez once I finish with paperwork we would leave to the jail.

While I had Mr. Dominguez sign citations, I noticed a change in his demeaner. He became short with responses and appeared tense. As Mr. Dominguez was signing, he asked me to loosen up the handcuff. I told him we will, he just needs to sign the citation and we would leave the office. He said he wanted it off to lay down and take a nap. I told him he could have laid down another direction and done so. Mr. Dominguez once again appeared angered with my response. Mr. Dominguez again asked if I am going to loosen the

handcuff a little and I said yes, I will, I just need him to sign the citation and we could leave.

As I uncuffed Mr. Dominguez from the bench in the holding room, he became irate once more that I would not take off the handcuff on his right hand, and I needed to take it off. I told Mr. Dominguez to turn around, and I would loosen it when I put the other handcuff on. Mr. Dominguez said I need to take it off and be respectful. I told him I am being respectful and to turn around. I told him to turn around once more.

At this time, Mr. Dominguez clenched his left hand into a fist and put it by his side. His demeaner became angry and bladed his stance to me.

I told him again he needs to turn around and I am being respectful. Mr. Dominguez then said, "Take it off!" in an angry and demanding tone of voice. I told Mr. Dominguez no, and he again demanded I take off the handcuff. Mr. Dominguez then said, "you better take it off bro," and again clenched his left hand into a fist and had it by his side. His movements became stiff, and he was angry.

Mr. Dominguez said, "take it off bro," and I again told him no. I then grabbed his right elbow to put his hands behind his back. Mr. Dominguez resisted and engaged be in a physical altercation. Still holding Mr. Dominguez 's elbow I had directed him to my right and pinned him against a table in the holding room. I then grabbed his jacket with my right hand and swung him left and onto the ground. I applied a knee-on-belly technique to pin Mr. Dominguez to the ground and pushed the duress button on my radio three times but it did not activate properly. At this time, contact with Mr. Dominguez had turned off my body camera footage. It appears an upward kick to my body had landed on my body camera and turned it off.

Mr. Dominguez scrambled and stood up. At this time, I had a left-hand hold on his jacket. I then retention-drew my Taser. I told Mr. Dominguez "I am going to tase you; I'm going to tase you!" in which he replied, "fucking do it!" I then deployed my department issued taser with little or no effect on Mr. Dominguez. Mr. Dominguez stopped for a moment and began to advance towards me, and I attempted to deploy my taser again. The second cartridge on my taser was defective and did not deploy. I then backed out of the holding room and shut the door with Mr. Dominguez inside. Mr. Dominguez began pulling on the door but was not able to get out. I then locked the deadbolt to the holding room.

I notified dispatch during the altercation that Mr. Dominguez was fighting me. As I locked Mr. Dominguez inside, I notified dispatch to request assistance from Raton Police Department or Colfax (County Sheriff) as the other shift members were, at closest, approximately 30 minutes away at code three. I also notified dispatch Mr. Dominguez had turned off my camera during the altercation, and to notify a supervisor as well.

During the time Raton Police Department and Colfax County Sheriff's office were coming, Mr. Dominguez grabbed a chair in the holding room and attempted to break the back window inside the holding room which leads outside of the facility. He had caused damage to the wall of the holding room in two places, damaged the chair, and slightly damaged the metal windowsill. Mr. Dominguez was attempting to escape the facility.


As Raton Police Department and Colfax County Sheriff's Office arrived, we were able to take Mr. Dominguez back into custody without further incident.

During the altercation, the knuckles on my right wrist were scraped and bleeding. Mr. Dominguez did not sustain any injuries and was inspected by EMS.

The pursuit was safe and no injuries were reported. During my review of the videos I observed when Officer Chavez initially observed and was following the vehicle, he was traveling at a high rate of speed, in the city, with no emergency lights activated. He was also speeding without emergency lights on while ABLE7 was tracking. Though he was trying to allow time for ABLE7 to track the vehicle before attempting to stop it, still very dangerous activity. I performed a verbal counseling with Officer Chavez about traveling over the posted speed limit without emergency lights engaged and when ABLE7 is tracking a vehicle, units need to downgrade emergency lights and follow all traffic laws.

Incident Summary

On 11/06/21 I Sergeant J. Reyes of the New Mexico State Police District 8 Alamogordo office was conducting traffic enforcement operations on US Highway 70. At this time, I was in full class A uniform and displaying my badge of office. I was currently in my NMSP black and white Chevy Tahoe. This traffic stop and incident took place in Otero County and the State of New Mexico on US Highway 70 at milepost 198. The following report is a synopsis of the incident and not verbatim or explicitly chronological. Reference should be made to my Watch Guard recording system.

At approximately 01:38 I conducted a traffic stop on a white Chevy passenger vehicle bearing NM AZTM54. The reason for the stop was 101mph/75mph zone the speed was then locked in at 97mph/75mph zone. Prior to this I was monitoring both eastbound and westbound for traffic violations. I had my issued unit?s radar on stationery rear mode. I observed a single vehicle that appeared to be a small passenger vehicle approaching my unit at 101mph/75mph zone. I then visually tracked and observed both visually and audibly at a reading of 97mph/75mph zone. I then locked the speed into my radar unit and allowed the vehicle to pass my unit. I then turned on my unit?s lights and safely merged into the highway. I then sped my unit up to catch the vehicle responsible for the speed. I then radioed south comm. dispatch of my location and the description of the vehicle. I started to notice things that don't usually happen with most traffic stops before making my initial contact with the driver. It appeared to myself that the vehicle's reverse lights were on, and the driver appeared to be waving or holding what I gathered to be the registration or insurance out of the window. I could also hear from my unit what I thought was yelling from the driver of this vehicle.

This concerned me; as most of the motoring public does not do these actions.

I then exited my unit and walked up to the passenger side of the vehicle. I made contact with the driver who was later identified as DOMINGUEZ, RYAN LORENZO by his NM driver?s license. I stated the reason for the traffic stop and who I worked for. I asked for the the vehicles registration, insurance, and driver?s license. While DOMINGUEZ was gathering these items, I noticed that DOMINGUEZ appeared either under the influence or very tired due to bloodshot and watery eyes. I did not smell or notice any alcoholic beverages while speaking with DOMINGUEZ. DOMINGUEZ stated he worked a 16 hour shift at Holloman Air Force Base. I then asked if DOMINGUEZ was tired why he was doing 97mph/75mph?. DOMINGUEZ "Hell yeah do you want to me to fall asleep on the road?". I then stated to DOMINGUEZ that this was not a joke and that it was very unsafe at that speed and given the other factors of already being tired, the time of and recent accidents involving Oryx animals on US 70. DOMINGUEZ stated due what you have to do and I could feel was starting to become uncooperative. I then had DOMINGUEZ step out of his vehicle to have him come back to my unit to issue the citation(s). (It should be noted that as a matter of training, experience and previously held specialty positions within the department; I have most if not all my traffic stopped drivers exit the vehicle and come back to my passenger side to conduct traffic stop business). (Further Pennsylvania V. Mimms 434 U. S. 106 1977 allows for police officer to order a driver or occupants out of the vehicle during a lawful traffic stop and perform a weapons pat search).

As DOMINGUEZ was exiting, I overheard DOMINGUEZ state something to the effect of "whats up nigga? or whats with it then?" I took this statement as a threatening statement toward me and my authority on scene at the time. I informed DOMINGUEZ not to tell me "whats up" Based on previous behaviors of DOMINGUEZ such as the excessive speed, yelling when first pulled over, dangling of paperwork on the driver?s side door and increasingly uncooperative behavior, I decided to conduct a weapons search for my safety. As DOMINGUEZ came from the driver?s side door area to the rear hatchback area of the car. I told DOMINGUEZ to turn around approximately two times. At this point DOMINGUEZ complied turned around and outstretched his hands. I then asked DOMINGUEZ to put his hands behind his back. Immediately at this point DOMINGUEZ spun around and started to say "hey" "you can't do this or that" "wait wait".

In my opinion and in review of OPR: 01 DOMINGUEZ was demonstrating ACTIVE RESISTANCE: which is defined as physically evasive movements to defeat an officer's attempt to control, including bracing, tensing, pulling away, running away or physically displaying an intent to avoid being taken into custody. I also applied in attempting to deal with DOMINGUEZ Graham v. Connor 490 U.S. 386 1989, specifically but not exclusively (2) whether the subject poses an immediate threat to the safety of the officer(s) or others and (3) whether he is actively resisting arrest or attempting to evade arrest by flight. Case subject matter to also be considered could Plakas v. Drinski 19 F. 3d 1143 7th Cir. 1994.

DOMINGUEZ at this time was wearing a thick Carhatt type of jacket and based on his uncooperative and spontaneous behavior. I took his current actions to either trying to flee the area (foot or car), he was armed with a weapon and did not want me to find or feel it, or was looking for an advantageous position to attack or hurt me either by edged or firearm weapon. I was able to grab a hold his right wrist and push him against DOMINGUEZ vehicle. I stated to DOMINGUEZ to not fight me and to turn around. DOMINGUEZ at this point was attempting to break free from my wrist lock as I could feel his muscles tightening in his wrist and arm. I stated to DOMINGUEZ that he was now resisting at this point and was under arrest. DOMINGUEZ was trying

in my opinion to break free of my grasp. I was relaying on the vehicle keeping DOMINGUEZ in place but at this point I had noticed the vehicle was moving back and forth and was not stuck into place. It was later learned DOMINGUEZ had the vehicle in neutral. I gave DOMINGUEZ multiple commands to stop his actions, stop resisting and allow myself to place him into handcuffs. I again informed DOMINGUEZ that he was under arrest and needed to comply. I attempted to reach my radio but did not want to let go of DOMINGUEZ for fear of either a foot or vehicle pursuit. While dealing with DOMINGUEZ I tried to use the least amount of pressure on his wrist (De Minimis Force) as I felt if I pushed my weight and strength against him, I could potentially break either DOMINGUEZ's wrist or bones. At this point we started to move to the rear of DOMINGUEZ and again the vehicle started to move forward which denied me leverage to use against DOMINGUEZ. I believe it was at this point DOMINGUEZ's body or clothes hit my BDC and activated the standby mode to select a classification. During this time, I was instructing DOMINGUEZ to stop, breathe and let me take him into custody. I believe that DOMINGUEZ was understanding what I was telling him as he was keeping his free hand away from my face and body but still attempting to break free of my grasp and create distance for an unknown reason. I eventually verbally persuaded DOMINGUEZ to turn around and face the ground. As I want going to place DOMINGUEZ's hands behind him and utilize a handcuffing position DOMINGUEZ moved forward resulting in my knee going to the upper top of his should blade area and making DOMINGUEZ's head go forward into the asphalt. At this time again I was attempting to use the least amount of pressure on DOMINGUEZ's wrist and not fully place the entirety of my weight onto his back area, this resulted in myself not being fully able to control DOMINGUEZ's "squirmy" movements.

I was able to utilize both my legs and lock DOMINGUEZ arms behind his back so he could no longer move and place DOMINGUEZ into hand restraints. During this whole time DOMINGUEZ was yelling obscenities and racial slurs either directed at myself or at the situation. I was able to double lock DOMINGUEZ's hand restraints and check for spacing in between the handcuff and wrist. I also performed a quick pat search for weapons of the unknown areas around DOMINGUEZ's belt, upper leg, and shirt areas. Due to wearing my COVID-19 mask my prescription glasses were completely fogged over and it was difficult to see both the immediate and surrounding areas. This increased the severity of the situation and DOMINGUEZ's expressed behavior as I could not effectively see out of my glasses.

DOMINGUEZ's at this point was jumping around and continued to try and pull away from myself escorting him back to my vehicle. I then placed DOMINGUEZ into the back of my unit and seat belted him into the unit. I attempted to deescalate the situation once DOMINGUEZ was in the back seat and explain the situation to him. At this point I informed DOMINGUEZ that he was under arrest for Resisting, Evading or Obstruction (resisting). DOMINGUEZ's behavior would go up and down at this point. I believe initially DOMINGUEZ behavior was due to being excited or frustrated in getting pulled over but then leaned into pure exhaustion based on DOMINGUEZ statements of work and observed body language and indicators.

I then walked away to gather the documents left on DOMINGUEZ's car and notify dispatch of my situation.

Upon backseat WatchGuard review of my unit on a later date. I observed DOMINGUEZ's at Secondary VXL1-008073 01:46:57 appeared to hit his head five times against my units cage, DOMINGUEZ also spit bodily mouth fluid onto my partition.

At approximately 01:35:45 I asked DOMINGUEZ if he would like 10-55 to check him out medically. I then requested DPS Southcomm, to call and request an EMS unit to my location.

At approximately 01:35:45 I requested a 10-46 to my location to secure the vehicle due to DOMINGUEZ's present arrest situation.

At approximately 02:00:03 I checked DOMINGUEZ head no injuries were observed.

At approximately 02:47:19 10-55 AMR unit showed up to my location and checked on DOMINGUEZ health and welfare. DOMINGUEZ declined further medical attention. During this time, I did not notice any cuts, abrasions, or contusions on his head area. I did take some up-close pictures and will be retained in CJIS and in this report.

At approximately 02:58:42 I released DOMINGUEZ with his speeding and NTC citation, gave him back his vehicle documents and watch him drive away from the incident location. I notified dispatch of the 10-58 and issuance of citations. I then notified my supervisor of the perceived use of force and situation. I received a R number for a subsequent O/I report.

Upon further review of Watch Guard of both BDC and Unit important times were noted:

At approximately 02:08:30 DOMINGUEZ apologized for the incident, for the racial slurs and for his actions. Based on these actions (Totality of Circumstances) I decided to utilize officer discretion according to OPR: 33 and issue a Non-Traffic Citation per 31-1-6 for Resisting, Evading or Obstruction 30-22-01(D) and Speeding 66-07-301.

At approximately 02:13:21 I asked DOMINGUEZ if the handcuffs were ok and he stated "yes, I appreciate you not tightening them".





Upon approach of the vehicle, I attempted to speak with the driver later identified as Mr. Casey Marsh, but he would not roll the passenger side window down. While speaking with Mr. Marsh he was placing his hands in his pockets and I told him to stop. Do to the cold weather, I let Mr. Marsh get a jacket out of his vehicle. Mr. Marsh continued to put his hands in his pockets, so I told him I was going to search him for weapons, because I did not know what he had.

While attempting to search Mr. Marsh he resisted, by balling his left fist and pulling away from me. I attempted to utilize a straight armbar takedown and brought him to the ground. While on the ground, I gained control of Mr. Marsh's left wrist from underneath his chest area. I pressed down with my left shoulder on his left shoulder and removed his wrist from underneath him. I placed his left hand behind his back and used my left knee and thigh to keep it behind his back and asked for his other arm. Mr. Marsh refused to give me his other arm, so I began to use a gooseneck technique on his left wrist. Mr. Marsh still did not give me his other arm, so utilized an empty hand technique and placed a little pressure to his left elbow. Mr. Marsh finally gave in and let me gain control of his right hand.

Mr. Marsh was photographed by responding officers, upon their arrival as well as the scene vehicle and myself. Mr. Marsh was seen by Santa Rosa EMS and he refused medical treatment and transport.







Incident Summary

On April 30, 2021 at approximately 2209 hours while on patrol in Las Vegas, NM I was dispatched to a wrong way driver on Interstate 25 mile marker 347. Caller advised possibly a Corvette entered the interstate traveling northbound on the southbound lanes. While attempting to locate the wrong way driver Dispatch got several calls regarding the wrong way driver. Dispatch advised the vehicle was traveling at a high rate of speed, swerving in the traffic lanes and almost colliding head on with traffic.

New Mexico State Police Officer David Trujillo and I were able to locate the vehicle which was a red Corvette bearing New Mexico license plate AANJ74. The Corvette was still traveling the wrong way at approximately 100 mph. There were several vehicles on the roadway. I followed along side the Corvette on the northbound lanes with my lights and sirens activated and the driver refused to stop. Approval was granted for the Pursuit Intervention Technique (P.I.T. maneuver). I crossed to the southbound lanes to execute the P.I.T. maneuver. I was able to catch up to the Corvette and the driver still refused to stop. The Corvette was traveling in the passing lane and swerving into the slow lane and the should near the median. The traffic on the roadway had to swerve off the roadway to the should. The driver of the Corvette would break and then speed up while I was getting into position to P.I.T.

I was able to get into position at approximately 80 MPH which was a failed attempt. I then repositioned and speed was now approximately 46 MPH the P.I.T. maneuver was successful and brought the Corvette to a stop at mile marker 383. I got out of my police vehicle and un-holstered my department issued sidearm and gave the driver of the Corvette commands to get out of the and show his hands. Once the driver complied with commands and I ensured the driver did not have any weapons I holstered my weapon. The driver was





On April 2, 2021, the New Mexico State Police Tactical Team was requested to assist Rio Rancho Police Department for an Armed Barricaded person who detonated an IED on his property. We were also advised suspect was barricaded in a bathroom armed with a sharp weapon. I was operating the Rook and moving vehicles out of the property for officer safety. While I was moving a van I observed the suspect at opening 2. The suspect jumped out the window and ran towards the team at the 1/2 corner. Officer Sedillos deployed less lethal beanbag rounds and a K9 was deployed. I moved the Rook over to prevent the suspect from fleeing the inner perimeter. Several team members from Rio Rancho SWAT were closing the distance to detain the suspect. I exited the Rook and grabbed some handcuffs off of a Rio Rancho SWAT officer. The suspected was being bit by the K9 and was actively resisting. The suspect was violently kicking and not listening to instructions. I grabbed his right leg as he was kicking and I placed 1 cufflink around his ankle to apply pain compliance in the event the suspect attempted to run and to stop the suspect from kicking. The cuff around the ankle has no effect unless the ankle extends or flexes, which would then cause pain. The incident was captured on my issued WatchGuard camera and was uploaded to the server (watchgaurd video event # 00:00:00:01:B7:7B-7983433.)





Incident Summary

On Friday, April 2, 2021 at approximately 13:07 hours, I was advised, via text message on the NMSP Tactical Team text string, by New Mexico State Police Sergeant J. Tenorio of a Tactical Team Activation. I was advised to respond to 1690 Estrellita Road SE, Rio Rancho, NM. The activation was in reference a male subject who had created and detonated an improvised explosive device. The suspect was identified by Rio Rancho Police Department as Mr. Christopher Mireles 08/18/2000. Following an encounter with Rio Rancho Police Department patrol officers, Mr. Mireles barricaded himself inside of a restroom inside of the residence. Patrol officers then exited the residence and established a perimeter and called for additional resources.

Prior to my arrival I was advised via the Tactical Team text string that Mr. Mireles had two warrants for his arrest, one for Burglary and one for Making an Explosive Device. Officers were in the process of drafting a search warrant for the residence.

I responded from Farmington, NM. I arrived on scene at approximately 1512 hours, I dawned my entry vest and helmet along with my department issued rifle and Less Lethal shotgun. I responded to the Command Post where I was provided with a brief from the Rio Rancho SWAT team commander. I was assigned to the 1 side of the residence at the BEARCAT. Utilizing the Rook for cover, I made my way to the BEARCAT. Upon my arrival, NMSP Sergeant and Team Leader J. Wright instructed me to be prepared with my less lethal shotgun. I could hear Public Announcements over the loudspeaker being made. The PA's identified us as law enforcement and gave clear instruction for the suspect to surrender peacefully.

After being only scene for only a couple minutes I could hear yelling coming from the residence, I could not hear what he was saying. I heard another officer say the suspect was standing in the second window from the left and he was holding a knife in his hand. The male stopped yelling and stepped away from the window. A short time later, Mr. Mireles again approached the bedroom window and began yelling out of the open window. He began breaking down the mesh screening, I took a kneeling position to the left of Tactical team member Sergeant N. Levine who was holding lethal coverage with his rifle.

Mr. Mireles broke out the screen and began climbing out of the window. I could hear other officers giving him commands to surrender. The suspect began running toward officers who were behind the Rook Platform Shield. I could see Mr. Mireles had a clenched fist and I could see something in his hand but was unable to identify what it was. Taking into consideration that Mr. Mireles had access to explosives, and he previously had a knife in his hand, and he was running toward other officers who had been clearly identified as Law Enforcement, I made the decision to deploy my less lethal shotgun. As I was taking my Less Lethal Shotgun off of safety, I heard Sergeant Levine say "Hit him, less lethal, less lethal." Mr. Mireles was still running, I aimed for the preferred target area of his thighs. I shot two rounds at his thighs, and he was still running so I shot again. Following the third shot, the suspect jumped back and temporarily paused before he began running again.

At this time, he was behind the Rook Platform Shield. I could see the Rio Rancho K9 running toward the suspect. I repositioned myself closer to the platform so I could keep eyes on the suspect. The Rio Rancho K9 began to apprehend the suspect and he was now laying on the ground. Mr. Mireles was screaming as he was being bit by the K9. I observed a knife in one of Mr. Mireles hands. I gave loud verbal commands for Mr. Mireles to drop the knife, I could hear other officers giving him the exact same command. He refused to drop the knife. Now the K9 was biting the suspect on his upper body. After ignoring multiple commands to drop the knife, and Mr. Mireles was rolling around trying to get away the K9, I believed the suspect was still a threat to the police K9 and officers were unable to approach the suspect to detain him because of the knife. With the K9 away from the suspects legs, I shot two more rounds from my Less Lethal Shotgun, aiming at his thighs. I could see the rounds hit Mr. Mireles in his left inner thigh. Shortly after the second hit, he finally dropped the knife. Other officers were able to safely take him into custody.


I escorted Mr. Mireles to the nearby ambulance where he was immediately given medical attention. I took photos to document the Use of Force. I could clearly see three bruises on his left thigh that were caused by the bean bag. He also had scratches and other marks from the K9. He was released to the custody of Rio Rancho Police Department. After the residence was cleared I returned to the location where the suspect was detained. I observed a kitchen knife handle without a blade lying on the ground.

The event was recorded utilizing my Watchguard Body Camera. The Watchguard Event ID is 00:00:01:d3:3c-6206425.





Incident Summary

On Monday, May 3, 2021, New Mexico State Police Narcotics Agents requested NMSP Tactical Team assistance in conducting a buy bust in the Target parking lot, located at 6100 Paseo Del Norte, Albuquerque, NM. We were advised the target was identified as Antonio Sanchez and he had an active felony warrant for armed robbery. A plan was in place to conduct a Vehicle Blocking Maneuver (VBM) on which ever vehicle the suspect is in. I was assigned to drive a white F150 UC vehicle. Sergeant Tenorio, Officer Chavez, Officer Maggard and Officer Bentley were assigned as the main takedown team in a white F250 UC vehicle. Narcotic Agents were in a UC vehicle and made a phone call to Antonio. Antonio advised he would be driving a white Buick, After some time, the suspect arrived and parked to the south of the narcotic UC vehicle. As the white Buick passed the narcotic UC vehicle, Agents were able to positively identify the driver to be Antonio Sanchez. Sergeant Tenorio advised me to be a front blocker and the "execute" command was given. The VBM was successful and a NFDD was deployed as I ran out of the line of fire. I looped back around to the F250 and I observed Officer Maggard giving commands to Antonio. I moved to Officer Maggard and advised him I had "hands." Officer Maggard told Antonio to keep his hands up. I observed Antonio constantly bringing his hands down towards his waistline as if he were attempting to reach for something. I told Antonio to turn around and walk back to us. As he turned to the right, he dropped his right hand towards his waistline. Antonio walked straight into Officer Maggard and he pushed Antonio forward to create distance. I moved up and grabbed Antonio's left hand and Antonio refused to give me his right hand. Due to Antonio's history of armed robbery, I was afraid he was reaching for a weapon and positioned myself directly behind him. As I

was behind him, I pushed him forward and took him off balance which cause him to fall to the ground. I followed him to the ground while maintaining control of his left arm. Antonio fell on the right side of his torso and I ended up in a rear mount. I immediately switched control over to his right arm because his hand was under him and I could not clear his hand. Antonio was physically resisting by pulling his arms towards the front of his body. I was able to use both hands to pull his right arm from under him and placed his right hand behind his back. I could feel Antonio trying to pull his arm forward. Officer Maggard was able to control his left hand and as I tried to place a handcuff link around his right wrist Antonio pulled away and I dropped my handcuffs. I used both hands to regain control of his right arm to prevent him from reaching for any weapons that may be in his waistline. Officer Maggard placed a cuff link around his left wrist, and I told him to cuff Antonio's right wrist while I held it in place. Once Antonio was in handcuffs and secured he was asked if he had any weapons and I completed a pat search for any weapons. Antonio was sat up advised again we were the State Police. Officer Chavez said Antonio put something in his mouth and Officer Maggard told me he pulled a plastic baggie from his mouth when he was on the ground. Due to minor abrasions on Antonio's face and possibly ingesting narcotics an ambulance was called to render further aide. 



Incident Summary

On Monday May 31, 2021, at approximately 1530 hours, members of the New Mexico State Police Tactical Team were activated to assist Las Cruces Police Department SWAT Team with an armed/ barricaded subject at 5007 Desert Shadow PI in Las Cruces. It was reported that, a male had broken into the residence and was barricaded inside. We were advised the homeowner was not home but out of state. The homeowner advised officers that there was approximately 30 long guns, and 20 handguns inside the residence. We learned the male who was identified as James Ray, had broken into a building on the NMSU Campus earlier that day.

When LCPD arrived on scene, the suspect barricaded himself inside the residence.

Upon arrival to the briefing location, I was assigned to the 1 side of the residence. I took my assigned position behind the BearCat where I held long cover from the turret. An NMSP operator utilized the ROOK to defeat the garage door in order for Officers to be able to look inside. A plan was set in place to move up the garage interior security door and breach it. A team comprised of NMSP and LCPD operators was put together, on the command we moved up to the garage door and began giving public announcements to anyone inside. Myself and an LCPD Officer moved to the electrical box and shut off all power to the residence. I was assigned to breach the garage security door. On the command to breach the door, I moved up utilizing the battering ram and defeated the garage security door leading to the interior of the home. One flash bang was deployed. Several public announcements were given before we tactically retreated back to

the BearCat.

I was preparing the 40MM gas kit for a chemical munitions plan; I was fixing my radio earpiece when I heard Officers began to give commands for someone to stop and calling for less lethal. I grabbed my fully marked less lethal shot gun. I went to the front of the BearCat where I observed a white male without a shirt walking south away from the residence ignoring officers' commands to stop. The male continued to walk south at a faster than normal walk while looking directly at officers while ignoring clear and concise commands to stop. I advised the male to stop as he continued to walk. For the safety of officers and the suspects self, I made the decision to fire one super sock bean bag round at his left leg in attempt to stop the male from continuing to actively resists or running back into the residence where he would again have access to approximately 50 fire arms. The bean bag round struck the male on his left leg above the knee. The male turned to his left exposing his back to officers. An LCPD K9 was released while another LCPD Officer deployed a single 40 MM direct impact round striking the male. The male went down to his knees, officers moved up and took him into custody without further incident.

I was assigned to an entry team. An entry plan was made, NMSP Tactical Team members and LCPD SWAT Members made entry into the residence and cleared the residence of any other people.


I assisted in documenting any damages done to the residence by the New Mexico State Police Tactical Team as well as a diagram.

This concluded my involvement in this mission. I was not involved in the investigative portion of this mission nor did I collect any evidence. Any additional information will be documented in supplemental reports. I recorded the incident on my WatchGuard DVR, body worn camera system, which was uploaded to WG evidence, the event ID number is 00:00:00:01:c4:62-30068141. 



Incident Summary

On Wednesday July 14, 2021, at approximately 1000 hours, New Mexico State Police (NMSP) Tactical Team Assistant Commander, Sergeant Armando Reyes-Llamas requested the Tactical Team to start heading to the parking lot behind the courthouse in Reserve, NM. The NMSP Tactical Team assistance was requested to help with a high-risk search and arrest warrant service on a RV camper for Mr. James Leon Brown, who had a Felony warrant for violation of a court order on multiple charges (case #: 21-2020-MM-000007-A,) to include a violent felony arrest warrant for Aggravated assault with a deadly weapon (3rd degree Felony) and a first-degree battery on a household member. We were advised Catron County Deputy Scott Landrum had positive identification on Mr. Brown currently at the RV located at an RV park on State Road 32 near mile post 6.

Upon arrival at the staging area, several forward observer team members conducted a scout while we were waiting for our Bearcat to arrive. The forward observer team returned and advised the target was positively identified and was outside the RV feeding a dog at the time they observed him.

Team members loaded up in the Bearcat and NMSP Officer Daniel Sedillos and I loaded into my unit where we departed with the forward observer team to provide communication. Soon after I heard over the radio the Bearcat and the rest of the team departed. As we were following the forward observer team, we observed the RV parked to the right just past milepost 6. When we passed the target RV the doors were shut but the driver door of a vehicle directly behind the RV was open. I relayed that information to the Bearcat team that

was enroute. The Bearcat team advised they were approaching milepost 6. The forward observers advised over the radio they were set in place. I started to head back to the only entrance to the RV park and waited for the Bearcat to pass and followed in behind.

As soon as we were set in place a female was detained while I was getting into position behind the Bearcat and Las Cruces Police Department K9 unit. Sirens and Public Announcements were given, and Mr. Brown was observed inside the residence and closed the front door. Mr. Brown was observed at the front window very irate and flipping us off as well as mooning us. A NFDD (noise flash diversionary device) was deployed near the front door, which we were calling the 1 side. NMSP Team Leader Sergeant Jonathan Wright asked me to take the female back to the CP in my unit. I escorted the female to my unit and headed back to the command post where CNT was waiting. I headed back to the Bearcat and supplemented the Bearcat team.

Mr. Brown was making several threatening statements yelling, "You want a war? You will get a war. You are just target practice!" Sergeant Wright requested the Rook driver to place the shield on the 2/3 corner to give that team some armor. The Rook driver was then requested to attach the boom. The boom was not working properly so it was taking some time for the rook to come back to us. EOD had two robots near the Bearcat and the big robot was prepped with a Tri-chamber.

Sergeant Reyes-Llamas advised us over the radio that at first the female was not being cooperative in the debrief and saying there was no weapons in the RV and advised she changed her story to yes there are weapons inside and changed her answer a third time to there is only knives in the RV.

Sergeant Wright requested to breach a window on the 2/3 corner with the big robot and deploy a Trichamber. EOD attempted to breach the 2/3 window but after several minutes of trying to breach the window they were unable to deploy the gas. Mr. Brown would come to the passenger seat very agitated and would flip us off. He got up and shut the blinds on the front windshield, so we no longer had visual. EOD advised they could deploy it through another window which was approved by Sergeant Wright. EOD breached a window on the 1/4 and deployed the Tri-chamber. The Tri-chamber was deployed near the front door so it pushed the suspect to the 2/3 side where I could hear team members on that side giving Mr. Brown verbal commands to keep his hands visible. After the gas saturated the area and Mr. Brown still not exiting the RV, Sergeant Wright requested the Rook driver to breach the door to provide a communication portal as well as take away Mr. Browns sense of security. The door was breach successfully and Mr. Brown still refused to comply with commands. Sergeant Wright then requested the front windshield be removed so we could have a visual into the RV. The Rook driver started to work the windshield at an angle.

The Rook worked the front windshield for several minutes and at one point the RV slightly lifted, the Rook reversed slowly to put it back down. Shortly after Mr. Brown exited his RV aggressively. We had a plan to detain Mr. Brown on the passenger side of the Bearcat, however, Mr. Brown was being uncooperative and not following commands. I grabbed the less lethal bean bag shotgun, which was verified to have Beanbag rounds prior to leaving the staging area. I advised the lethal cover on the passenger side that I was going to bump out to his right, and I briefly saw Mr. Brown advancing towards the driver door of the Bearcat towards the teams K9. This showed he was not afraid of the K9.


I relocated to the driver side and Mr. Brown was extremely agitated and was pointing his finger firmly at the team members. Mr. Brown stopped approximately 10ft from team members and continued to ignore commands to turn around. He stayed standing in a violent posture. Mr. Brown appeared to get a target lock on team members. I was several feet behind the lethal cover and K9 officer. I bumped out to the far left so I would not cover any of my teammates. Mr. Brown did not have anything in his hands but with the information learned that Mr. Brown had access to knives I was concerned he may be concealing a weapon on his person. I felt like Mr. Brown was about to follow through with his statement earlier of, "You want a war? You will get a war. You are just target practice!" To prevent Mr. Brown from being bit by a K9 or lethally shot I utilized the less lethal beanbag shotgun to gain compliance. I gave Mr. Brown multiple clear and loud commands to turn around, which he ignored. I announced "beanbag" three times to advise my teammates of the impending force that was going to be used. I aimed at Mr. Browns right quadricep and shot one round. I accessed the result on Mr. Brown, which he still was not cooperating. I then fired a second shot to the same location and accessed a second time, Mr. Brown took a step back and I fired a third shot to his quad. Mr. Brown then followed commands and laid on his back. I gave him commands to turn over on his stomach, which he complied. A plan was developed to take Mr. Brown into custody, we moved up to detained him.

Mr. Brown was taken to the back of the Bearcat. Mr. Brown was bleeding from his leg later determined to be from a beanbag round that penetrated his quad. Mr. Brown also had a preexisting injury on his stomach. EMS was called and Mr. Brown was transported to the ambulance promptly. A security sweep of the RV was conducted where nobody was located inside. The scene was turned over to investigating officers.





Incident Summary

On Thursday July 15, 2021, at approximately 1147 hours, New Mexico State Police (NMSP) Tactical Team Assistant Commander, Sergeant Armando Reyes-Llamas requested the Tactical Team to start heading to 1202 Pyramid St, Lordsburg, NM. The NMSP Tactical Team assistance was requested to help with an armed barricaded female in room #28. NMSP Officer David Bentley, Officer Robert Archuleta, Officer Lawrence Maggard, and I were advised to meet at the aircraft hangar for a helicopter relay to Lordsburg, NM.

While enroute, we received updates advising Lordsburg Police Department received a call of a female walking around armed with a knife. Officers attempted to contact the female and as they did, she attempted to stab one of the officers. The officer was able to evade the attack, but she was able to make it into room 28 at the motel 10 and barricade herself. The charges were aggravated battery on a peace officer and aggravated assault x2. The female was positively identified as a Ms. Alicia Beth Morrow, and she had an active felony warrant out for her arrest, Battery on a Peace Officer, and a misdemeanor warrant for assault on a peace officer.

CNT spoke with Sergeant Carrasco on scene and was advised all adjoining rooms were evacuated and the search and arrest warrant was being drafted. CNT advised Ms. Morrow had criminal history in Arizona as well.

We received more updates from team members on scene that Ms. Morrow stated she is not going anywhere alive, and she is going to stab everyone, then closed the door. Later, she opened the door and said she wants death by cop. Team members on scene also advised she was at the window with two knives that appeared to be attached to her wrist with wristbands.

Once on scene, we were advised to assist the other team members at the bearcat on the 1 side facing the room 28. While at our position I could see Ms. Morrow at the window and then cracking the door slightly to yell at team members. Public announcements and sirens were on going by Officer Michael Jones. A plan was in place to deploy a noise flash diversionary device (NFDD) to get Ms. Morrow to surrender peacefully. The NFDD was successfully deployed by Las Cruces Police Department (LCPD) SWAT team members who were posted 3 rooms north of room 28, which was located on the upper level. After the NFDD was deployed Ms. Morrow opened the blinds to the window aggressively and then closed them. Sometime later a plan was in place for the LCPD team members to hand deploy a cell phone so Ms. Morrow could contact CNT. The plan was authorized and executed, Ms. Morrow opened the door and retrieved the phone then shut the door. We were advised CNT was online with her and she spoke with CNT for some time. After some time, we were advised she was no longer online with CNT.

Officer Robert Ramirez requested that myself and Sergeant Jonathan Wright move to the second floor to assist LCPD team members in the event that Ms. Morrow exit. Once in position I was assigned to operate the Less Lethal Beanbag Shotgun.

I received an update from Team Leader Officer Robert Ramirez. Officer Ramirez advised me Sergeant Jonathan Tenorio, Tactical Team Commander, contacted Doctor Rodgers and he was advised to continue the PA's in the hopes that Ms. Morrow became tired. We were advised to not deploy gas and to try and tell her to surrender peacefully.

With no contact or movement seen within room 28, Someone from the command post advised over the radio she may have taken medication and passed out. For Ms. Morrow's safety and wellbeing, a second NFDD plan was authorized and executed by LCPD SWAT. There was still no reaction from Ms. Morrow. From our position we could only see the front door but could not see inside the window. It was learned that after the deployment of the second NFDD, Ms. Morrow came to the window armed with the knives still.

It was relayed by CNT that it may be a good idea to place something else in the room that she can take her mind off holding the knives. A plan was in place to take her a fidget spinner using the small robot, the plan was to use the boom of the rook to push in the door and take away her sense of security and allow for a communication portal. The plan of execution was to have the boom attached to the rook breach the door to room 28, once it was breached the big robot that was prepped with a tri chamber would be inserted to prop the door open and prevent Ms. Morrow from exiting, the small robot would then be inserted and provide Ms. Morrow with the fidget spinners. Once everyone was in place the plan was approved the rook moved to

position and placed the boom at the front door, PA's were given from the bearcat for Ms. Morrow to move away from the door.


From my position I could not see the room 28, LCPD team members had visual and from radio communication it was learned that the rook had a positive breach on the door. It was also learned that the robots were attempting to gain entry, but Ms. Morrow had squeezed past the big robot and was standing on the walkway. LCPD team members had eyes on Ms. Morrow and advised She had a knife in each hand. I exited the room we were staged in to assist other team members giving Ms. Morrow commands to "drop the knives". Ms. Morrow did not listen to commands and began closing distance in an aggressive manner. LCPD team member deployed a direct impact round making contact to Ms. Morrows mid-section, Ms. Morrow was still closing distance, so I then stepped forward and advised Ms. Morrow to "drop the knives and to stop" when she kept walking toward the team members and myself, I deployed one less lethal bean bag round at Ms. Morrow contacting her right upper quadricep. When she was impacted, she stopped advancing and turned around. To prevent her from fleeing and possibly running toward team members located on the south stairwell I deployed a second less lethal ben bag round to her left upper thigh. Ms. Morrow then entered back into her room. The decision was made to deploy the tri-chamber to have Ms. Morrow exit. The big robot moved into the threshold and deployed the tri-chamber. The CS tri-chamber had a positive effect on Ms. Morrow as she was coughing, and eventually came to the door and exited. She stopped on the walkway and started spitting over the guardrail. She was advised to keep her hands up and to lay on the floor. Once Ms. Morrow had her hands up and we could see that they were clear team members and myself advanced towards Ms. Morrow and placed her under arrest. Once she was secured, she was transported to the command post where medical personal was staged to provide her first aide. Once Ms. Morrow was escorted away, we made entry into the room and deemed it safe and secure. The scene was then released to investigating officers.

This concluded my involvement in this mission. I was not involved in the investigative portion of this mission, nor did I collect any evidence. Any additional information will be documented in supplemental reports. This mission was captured by my department issued WatchGuard, which will be uploaded to the WatchGuard server.





Incident Summary

On Wednesday, September 15, 2021, I was assigned as part of the Tact Team to assist APD SWAT with a critical incident. APD SWAT was requesting assistance with a barricaded subject that was wanted for Aggravated Assault with a Deadly Weapon and had committed an Armed Robbery earlier that day.

During the critical incident a male neighbor exited his home. The male was in the hot zone of this critical incident and had a high potential of being harmed. He was a distraction and threat to the safety of the tactical officers on scene, who's attention was focused on bringing the critical incident to a peaceful resolution.

He was given several instructions to return to his residence. The instructions were given to him verbally through a PA announcement and through shouting from tactical officers on scene. The instructions stated something like, return to your home and dial 911 if you need assistance. He ignored all instructions and in fact began moving closer the team of officers on the east side of the critical incident.

Due to the dangerous nature of the male's actions during this critical incident a plan was made to remove the male from the hot zone. Utilizing the Rook as protection we moved forward and attempted to detain the male. When we contacted the male, he was again advised to return to his home, or he would be detained. He verbally refused by stating "No, I won't". He was then advised he was being detained, he needed to turn around. Again, he refused and verbally stated, "No, I won't and you can't make me". He was warned that if he did comply force will be used against him. As we approached, he began to move away from us toward the BEARCAT on the southwest perimeter. Next, I handcuffed him utilizing a speed cuffing technique. As we

began to walk back towards the perimeter, he refused by to walk by getting stiff legged and not picking up his feet. I used a handcuffed escort technique to gain compliance. Due to the totality of the circumstances and the need for urgency, since we were in an unsafe area of an active critical incident, I felt this was the most reasonable and least intrusive means of gaining compliance.

When he stated, "ok, I'll walk" the technique was released, and he began walking correctly. He was then escorted to a perimeter officer and turned over to him.


I returned to the critical incident and remained there for the duration.


