Probable Cause Affidavit

Before me this date personally appeared ALMANZAR, ORLANDO F. (1473) who being first duly sworn deposes and says that on 4 day of June, (year) 2018 at _____ (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

HPD Detectives began to surveil BLANC which led them to _____ FL. HPD Detectives notified the Fort Lauderdale Police Department (FLPD). BLANC was seen multiple times throughout the night. BLANC was moving a Waste Management trash container towards the building dumpster. BLANC was laboring to wheel the trash container and left it by the dumpster on the north end of the alleyway. Given the suspicious behavior and similar manner in which the victim _____ body was discarded in the City of Hollywood, FLPD Officer's made contact with BLANC. BLANC was detained and the dumpsters were checked. Inside the trash can was the mutilated body of _____ was also six months pregnant. Broward County Associate Medical Examiner Doctor Sneed responded to the scene and ruled the manner of death a homicide. BLANC was taken into custody and taken to the FLPD to be interviewed. The interview was recorded digitally. Post Miranda BLANC gave a full confession. He gave details about the murder and said he killed _____ because she disrespected him. BLANC said he killed her on Monday June 4th 2018 by shooting her in the head. BLANC tried to dismember the body to make it easier to dispose. But was unable to remove any body parts. BLANC was charged accordingly. He was processed at the FLPD and later transported to the BSO Main Jail.
