Sapp, who drove to the Emergency Room with a deceased female, later identified as Charity Hundley, in the rear storage area of a Chevrolet Tahoe. Charity Hundley was nude and the body was cold to the touch and stiff, indicating signs of rigor mortis. George Sapp was brought to the police station and interviewed. He was given his Miranda Warnings and he signed a form stating He ran into her at the beach about a month and a Suspect said half ago. Suspect stated He had plans to meet the **Suspect stated** victim at the boat ramp at noon, but she was running late. Suspect purchased food from Hooters and waited for the victim. Once she arrived they went out on the boat. Suspect stated He said victim asked him to pay for a facial treatment that was an additional \$145.00. He gave her the additional money for the facial. I asked him about partying, he said He said He said The victim asked him if it would mess her The victim asked him if he had any pills and he told her The victim asked for a half a pill and the suspect gave her a half of a Percocet pill up and he told her The suspect stated of his The suspect said The suspect said The victim went to the suspect's garage with him. The garage is a detached structure. Once at his garage, he laid out 2 flat air mattresses and a pillow.. At approximately 8:30pm suspect went up to his apartment to check in with his girlfriend, who also resides at the apartment. Suspect stated Suspect stated He walked back to his apartment. When questioned about whether the victim was alive at this point the but then recanted his statement. At first he said suspect said He checked his phone to see if the victim had text him, but Suspect stated there were no text messages from the victim. He talked with his girffriend and said He left, paid his electric bill and returned back to his apartment. He talked to his girffriend till she had to check online for work.

Upon finding the victim

deceased, he removed her naked body from the garage, put her in back of his Chevrolet Tahoe, placing a windshield cover over her and drove her to Beaches Baptist Hospital. The suspect was asked how he knew the victim was dead and he said ".

The suspect further stated

I received videos from the Palms Apartments, (entrance/exit points), the North Florida Yacht Ciub/ Marina, Beaches Energy and Beaches Baptist Hospital. The videos gives a time line of when the suspect left his residence on Wednesday 04/05/2023 and when he returned. The video from The North Florida Yacht Club shows the victim walking from her car to the boat. When the suspect and victim returns to the boat ramp, the victim is holding onto the suspect's arm in order to walk. The videos show on Thursday, 04/06/2023 the suspect leaving his residence. He drives to Beaches Energy and pay's his electric bill and returns to his residence. The video shows the suspect leaving, taking the victim to the hospital and when he arrives at the hospital.

The suspect had in his possession a black bag. The suspect was asked if officers could search his bag and he agreed. The suspect signed a "Consent to Search Form". Inside the bag was his Florida driver's license, money, ear phone buds, a bottle with pills, half a pill and brass knuckles. The suspect said in his interview

The pills were sent to the U.S. Department of Justice, Drug Enforcement Administration (DEA) lab for testing. The pills tested positive for Percocet / Oxycodons. The Medical Examiner's Office report (ME#: 23-00827) shows the Cause of Death as combined drug intoxication of Fentanyl, Oxycodone and Ethanol.

Wednesday, 09/13/2023 I made a traffic stop on the suspect in the 1500 block of The Greens Way as he was driving away from his residence. The suspect's vehicle was towed and the firearms were placed in the property room.
