Hello,

Below are two screenshots, one of which includes threats related to Celia Nabor. Celia Nabor is the former Assistant Director of Early Voting for Maricopa County. She recently left her position last month.

She was named last week in a presentation by We The People AZ, who said she was involved with crimes related to signature verification. Because she was no longer employed by the county at the time of the presentation/deposition request, she was accused of fleeing a crime. As a result, people have been trying to dox her. A local law firm involved with the Kari Lake election, Blehm Law, has put out a call for information about her whereabouts.

On telegram, the request from the law firm has been shared in multiple channels. On a post shared to Nick Moseder's channel, there were death threats in the comments: 1) a noose superimposed over Hillary Clinton and 2) "at the bottom of some lake wearing cement shoes". #1 was reported due to the noose while #2 was reported for being a reference to [a type of murder/body disposal method](#) (popular with the mafia).

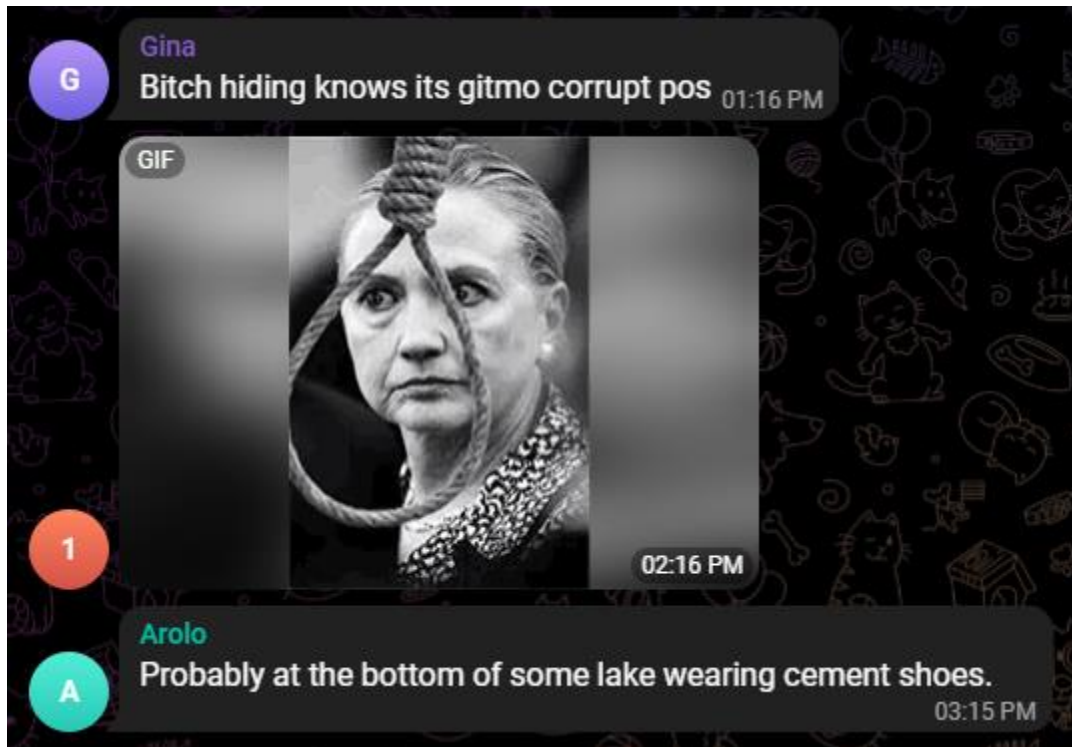
