

Dear Mr. Lehman,

Thank you for your memo. I just wanted to take some time to respond to, and on a few important points, correct this summary memo. I would appreciate if you would include this letter in my employee file as supplementary to your summary memo.

I was disappointed to see that your summary memo of our meeting on May 19, 2023, included several significant items that were never brought up in the meeting. Among the items included in your memo but not discussed in our meeting are the following:

- Regulation 4293.6, related to Employee Dismissal – Definition of Just Cause or about EAP. (Also note, if you are discussing my potential dismissal/termination, this is no longer a "summary memo", but rather a punitive memo. Not only did you not mention this in our meeting, but this kind of language is not appropriate for a "summary memo"

Additionally, several important items discussed in our May 19 meeting were unfortunately left out of your summary memo. Among the noteworthy items discussed but were omitted from your memo include the following:

- I read to you a clearly left-leaning teacher's post in Schoology to all her students. I had mentioned to you that if I had posted something like this about Governor Northam's mask mandates, I would be in all kinds of trouble, yet nothing happened to her. (I have attached the Schoology post to this email for your reference.)
  - During the meeting, I discussed the Community School Coordinator at Mt. Vernon Woods Elementary School is running for Fairfax School Board as a Democrat-endorsed candidate. A friend of mine was volunteering there one day and saw her passing out her campaign literature during school hours after Dr. Reid sent out an email to all FCPS employees discussing Policy 1800 <a href="https://go.boarddocs.com/vsba/fairfax/Board.nsf/goto?open&id=867SAM2A6A9E">https://go.boarddocs.com/vsba/fairfax/Board.nsf/goto?open&id=867SAM2A6A9E</a>.

Also, my good friend Debra Tisler told me that Dawn Schaefer, who is the director for the Office of Special Education Procedural Support, breached her son's privacy by revealing her son's name, school, exceptionality, and class schedule, and yet she was not only not disciplined, but she received a promotion. (Here are many other examples of FCPS employees breaching students' privacy <a href="https://specialeducationaction.com/?s=Privacy+breach">https://specialeducationaction.com/?s=Privacy+breach</a>) However, I have done nothing comparable to this, and yet I get my job threatened.

For these reasons and others, it is hard to escape the impression that there is witch hunt against me because some people don't like my political beliefs. I felt it was important for me to clear things up because I know that I am a good teacher, and I would never place any child is harm's way. Everyone who knows me should know by now that I love and care about ALL my students regardless of gender, race, ethnicity, religion, disability, political affiliation, or any other characteristic.

While you may believe that you would not place a student in harms way, others do not feel that way when you make public posts that are hurtful to some members of the community and share sensitive information about students. Because you continue to make questionable posts, and we have discussed this several times, the memo includes stronger language. It is important you are clear about FCPS expectations and recognize that further disciplinary action could result.

I will be sure to attach your response below.

Thank you for your memo. I just wanted to take some time to respond to, and on a few important points, correct this summary memo. I would appreciate if you would include this letter in my employee file as supplementary to your summary memo.

I was disappointed to see that your summary memo of our meeting on May 19, 2023, included several significant items that were never brought up in the meeting. Among the items included in your memo but not discussed in our meeting are the following:

- Regulation 4293.6, related to Employee Dismissal – Definition of Just Cause or about EAP. (Also note, if you are discussing my potential dismissal/termination, this is no longer a "summary memo", but rather a punitive memo. Not only did you not mention this in our meeting, but this kind of language is not appropriate for a "summary memo"

Additionally, several important items discussed in our May 19 meeting were unfortunately left out of your summary memo. Among the noteworthy items discussed but were omitted from your memo include the following:

- I read to you a clearly left-leaning teacher's post in Schoology to all her students. I had mentioned to you that if I had posted something like this about Governor Northam's mask mandates, I would be in all kinds of trouble, yet nothing happened to her. (I have attached the Schoology post to this email for your reference.)
  - During the meeting, I discussed the Community School Coordinator at Mt. Vernon Woods Elementary School is running for Fairfax School Board as a Democrat-endorsed candidate. A friend of mine was volunteering there one day and saw her passing out her campaign literature during school hours after Dr. Reid sent out an email to all FCPS employees discussing Policy 1800 <a href="http://go.boarddocs.com/vsba/fairfax/Board.nsf/goto?open&id=867SAM2A6A9E">http://go.boarddocs.com/vsba/fairfax/Board.nsf/goto?open&id=867SAM2A6A9E</a>.

Also, my good friend Debra Tisler told me that Dawn Schaefer, who is the director for the Office of Special Education Procedural Support, breached her son's privacy by revealing her son's name, school, exceptionality, and class schedule, and yet she was not only not disciplined, but she received a promotion. (Here are many other examples of FCPS employees breaching students' privacy <a href="https://specialeducationaction.com/?s=Privacy+breach">https://specialeducationaction.com/?s=Privacy+breach</a>) However, I have done nothing comparable to this, and yet I get my job threatened.

For these reasons and others, it is hard to escape the impression that there is witch hunt against me because some people don't like my political beliefs. I felt it was important for me to clear things up because I know that I am a good teacher, and I would never place any child is harm's way. Everyone who knows me should know by now that I love and care about ALL my students regardless of gender, race, ethnicity, religion, disability, political affiliation, or any other characteristic.

They also don't discuss sensitive student information such as medical diagnosis or gender identity. Often what we discuss with you are questionable posts that you make, which either draw a connection between your students, the school, and your political aspirations, or they are hurtful to some members of the community.

Below, I have included the email notice I received about the CPS report. As I told you when we met, the case was not taken by CPS, but it was reported.

I also believe it is important to clear these things up. I am not causing these problems for you. I am having to respond to your actions and decisions, which are impacting the school and/or students, and I too hope that I stops.
