The County of Shasta is in receipt of your records request dated May 10, 2023, titled Public Records Request (CA-SHASTA-23-0451). Pursuant to Government Code § 7922.535(c)(1), (2) and (3), the County exercises its right to extend the time in which to determine whether your requests seek copies of disclosable records and the extent of those disclosable records. I anticipate providing you a determination and, if applicable, an estimate as to when the documents will be produced on or before June 2, 2023. The extension is needed due to the voluminous number of records that may need to be collected and/or examined; and the need to consult with other County departments regarding your requests.

Please be advised that pursuant to Ordinance No. 755, "AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SHASTA ESTABLISHING FEES PERTAINING TO COPYING PUBLIC RECORDS," producing a copy of a public record may be subject to a fee. Based on the voluminous nature of your request, it is possible

It's under 52 USC. §21081(a)(3) - which requires an accessible voting system IF the jurisdiction uses a VOTING SYSTEM in an election for Federal office. I.e., IF a state/county/township uses a voting system (defined under (b)), then it must also have an accessible voting system. If the jurisdiction does not use a mechanical, electromechanical, or electronic voting system, then there is no Federal law which requires use of an accessible voting system. So, how to individuals w/disabilities vote? It's under 52 USC 10508: "Any voter who requires assistance to vote by reason of blindness, disability, or inability to read or write may be given assistance by a person of the voter's choice, other than the voter's employer or agent of that employer or officer or agent of the voter's union."
