Counsel has substantial experience handling, managing, negotiating and appearing for hearings and trials in domestic relations litigation. Counsel for Petitioner has appeared in over 1,300 individual domestic relations matters in 17 counties in the State of Oregon. Counsel for Petitioner's hourly rate of \$400.00 per hour is on the higher side for attorneys within the local geography of Linn County and Benton County where counsel's office is located, but counsel's hourly rate is commensurate with the hourly rate for attorneys that have similar experience and possess a similar breadth and depth of knowledge.

The conduct of the parties in the transactions or occurrences that gave rise to the litigation, and the objective reasonableness of the claims and defenses asserted by the parties

Respondent Jamie Crompton (hereinafter "Respondent") filed three Motions to vacate the original custody Judgment in this matter. That judgment was entered on August 15th, 2019. Respondent waited until almost two years had passed prior to filing her first Motion to Vacate on June 24th, 2021, well past the one year time frame allowed by the Oregon Rules of Civil Procedure, which was denied on June 28th, 2021. In spite of that denial, Respondent proceeded to file an additional motion asking the court to vacate the judgment on October 2nd, 2021, which was denied on October 14th, 2021. On January 5th, 2022 Respondent filed her third and final motion to set aside the 2019 judgment which was denied at a hearing on May 23rd, 2022. Despite the three previous rulings regarding Respondent's repeated motions to vacate or set aside the original judgment, Respondent implicitly raised the issue of setting aside the judgment at trial by covering the same ground and once again covering the same facts and arguments both in Respondent's trial memorandum and at the modification trial before the Court on January 26th, PETITIONER'S ORCP 68 STATEMENT OF ATTORNEY FEES AND COSTS - 6 2023. As examples, Respondent once again focused on the issues of the nature of the relationship between Petitioner and Respondent in 2018, the type of notice Respondent received prior to the judgment being entered, and when Petitioner notified Respondent of the existence of the judgment. Respondent's trial memorandum and the case she presented at trial were interwoven with facts, statements, and arguments regarding setting aside the judgment such as "This case presents an interesting issue to the Court because Petitioner served Mother in a way that she knew Mother would not get actual notice and was dishonest in her declaration filed with the court to show she met the requirements to even be granted legal custody of another person's children." and referring to "…the dishonest and selfish motive that Petitioner has displayed in creating this novel legal situation…" Respondent's renewed, and ultimately her fourth, effort to raise issues relating to setting aside the judgment were unsuccessful at trial.

Petitioner has consistently and repeatedly asserted that she should maintain custody and that Respondent should have phase in parenting time that would ultimately lead to more frequent parenting time between Respondent and the children. The final settlement offer from Petitioner to Respondent was included as a trial exhibit and eventually adopted by the court. Even after the court awarded Respondent parenting time pursuant to the Model Parenting Plan for Linn County, Long Distance Plan, 2018 Revision, Respondent objected to the parenting time provisions in the judgment. At the hearing on objections, Respondent ultimately agreed to a parenting plan that was the rough equivalent of Petitioner's proposed parenting plan at trial and Respondent's own objections and agreements made at the hearing on objections to the form of the judgment resulted in Respondent receiving less parenting time with the children than she was initially awarded by the Court.

The objective reasonableness of the parties and the diligence of the parties in pursuing settlement of the dispute

Petitioner sent multiple settlement offers to Respondent which were denied without reasonable counteroffers. Petitioner offered more frequent parenting time to Respondent which was denied by Respondent due to the hardship of traveling from California to Oregon to see the children. Petitioner then offered less frequent parenting time that would coincide with the times Respondent was in Oregon for parenting time for her other children (not at issue) and that was again denied by Respondent. Had Respondent accepted Petitioner's proposal, she could have spent far more time with the children while this matter was pending and moving towards trial, and had Respondent accepted Petitioner's proposal for parenting time with a phase in, Respondent could have spent the duration of the litigation increasing the amount of time that she spent with them while the plan was phased in. Instead, Respondent refused to consider any alternative besides a change in custody and removing the children from the Petitioner.

Respondent's position throughout the case has been that the children should be returned to her without any sort of phase in or reintegration, and that Petitioner should have no parenting time with the children, despite the length of time the children have resided with Petitioner. Respondent's position and the focus of Respondent's testimony, evidence, and the issues that she raised throughout the course of the present litigation were more about Petitioner's perceived misconduct as opposed to the children, and served primarily to demonstrate the degree of Respondent's animus towards Petitioner as opposed articulating what is in the best interests of two little girls.

Respondent's desire to have Sage and Sadie, who were 6 years old and 5 years old at the time of trial, immediately removed from their home and have no further contact with someone PETITIONER'S ORCP 68 STATEMENT OF ATTORNEY FEES AND COSTS - 8

LAW OFFICE OF IVERS, MILLER & MAZHARY-CLARK 317 FIRST AVE W, SUITE 302, PO BOX 1033 ALBANY, OR 97321 TELEPHONE (541) 928-5875 FAX (541) 967-9730 with whom they enjoyed a parent-child relationship spoke to a desire to remove the children from the Petitioner's life as opposed to having the children's lives enriched by their relationship with Petitioner even if the Court had determined that a change in custody was in their best interest. Respondent's overwhelming focus was consistently on the Petitioner's conduct and not on the children themselves. Her focus was on the Petitioner and wanting to remove the children from the Petitioner's life as opposed to considering whether it was in the children's best interest to have the Petitioner removed from Sage and Sadie's lives.

5. Based on the above, Petitioner is entitled to an award of reasonable and necessary attorney fees in the sum of \$22,000.00 and costs in the amount of \$708.95.
