CABARET, IN REFERENCE TO A BURGLARY TO A MOTOR VEHICLE.

UPON ARRIVAL, I SPOKE TO THE MANAGER ON DUTY, [REDACTED] WHO STATED THAT HE WAS APPROACHED BY TWO MALE WHO STATED THAT THEY HAD SOME ITEMS STOLEN OUT OF THEIR VEHICLE WHILE PARKED IN THE PARKING LOT. [REDACTED] STATED THAT TWO OF THE DANCERS ADVISED HIM THAT THEY CLOSE THE TRUNK LID ON A VEHICLE IN THE PARKING LOT ON THEIR WAY IN, WHICH WAS THE VEHICLE THAT GOT BROKE INTO. [REDACTED] STATED THAT HE WAS GETTING THE DANCERS NOW SO I COULD TALK TO THEM.

I THEN SPOKE TO CAIN AND MCCLENDON WHO STATED THAT THEY LEFT SOME TIME AROUND 1:45 A.M. TO GO BACK TO THEIR HOTEL. THEY STATED WHEN THEY GOT THERE, THEY OPEN THE TRUNK AND A BLACK LEATHER JACKET AND A BLACK COMPUTER BAG WAS GONE. THEY STATED THAT THEY CAME BACK TO THE BUSINESS TO SEE IF ANYBODY TURNED ANYTHING IN OR IF THEY HAVE CAMERA FOOTAGE OF THE PARKING LOT.

CAIN THEN STATED THAT HE WAS A DETECTIVE WITH THE NIAGARA FALLS POLICE DEPARTMENT IN NEW YORK. CAIN STATED THAT IN THE COMPUTER BAG WAS HIS SMITH&WESSON 40CAL. GUN IN A BLACK VELCRO HOLSTER, HIS DETECTIVE BADGE, TWO (18) ROUND MAGAZINES FULL WITH DUTY ROUNDS, A SET OF SLIVER SMITH&WESSON CHAIN HANDCUFFS IN A BLACK CASE, AND HIS CHECK BOOK FROM M&T BANK. I ASKED CAIN IF HE KNEW THE SERIAL NUMBER FOR HIS GUN OR HIS BADGE NUMBER AND HE STATED NO. HE STATED THAT HIS DEPARTMENT HAS ALL THAT INFORMATION.

MYSELF AND OFC. ALLISON THEN CHECKED THE AREA AND LOOKED INSIDE ALL THE VEHICLES PARKED IN THE LOT FOR THE COMPUTER BAG AND THE JACKET WITH NEGATIVE RESULTS.

I THEN SPOKE TO [REDACTED] AND [REDACTED] WHO STATED THAT THEY CAME INTO WORK AROUND 9:30 P.M. AND NOTICED THE TRUNK LID TO THE VEHICLE WAS OPEN. [REDACTED] STATED THAT AS SHE CLOSED THE LID, SHE NOTICED THE JACKET INSIDE THE TRUNK. I




