

CABARET, IN REFERENCE TO A BURGLARY TO A MOTOR VEHICLE.

UPON ARRIVAL, I SPOKE TO THE MANAGER ON DUTY, WHO STATED THAT HE WAS APPROACHED BY TWO MALE WHO STATED THAT THEY HAD SOME ITEMS STOLEN OUT OF THEIR VEHICLE WHILE PARKED IN THE PARKING LOT. STATED THAT TWO OF THE DANCERS ADVISED HIM THAT THEY CLOSE THE TRUNK LID ON A VEHICLE IN THE PARKING LOT ON THEIR WAY IN, WHICH WAS THE VEHICLE THAT GOT BROKE INTO. STATED THAT HE WAS GETTING THE DANCERS NOW SO I COULD TALK TO THEM.
