



WAS INSIDE OF BUSINESS AT APPROX 0205 HRS, ATTEMPTING TO GET EVERYONE OUT OF BAR, WHEN A PATRON CAME BACK IN AND STATED THAT THERE WAS FIXING TO BE A FIGHT OUTSIDE. WHEN WITNESS WALKED OUTSIDE HE OBSERVED ONE W/M RUNNING WHILE 5 W/M'S WERE CHASING HIM.



KNOW WHAT THIS STATEMENT MEANT OR WHY IT WAS SAID.

WAS STANDING IN THE SONIC LOT WHEN THE OFFICER PULLED UP. HE STATED THAT THE OFFICER WAS GETTING OUT OF HIS VEHICLE WHEN A FEMALE RAN UP FROM DOWN THE STREET AND SAID SOMETHING ABOUT A INCIDENT GOING ON DOWN THE ROAD. OFFICER DID NOT ATTEMPT TO IDENTIFY ANYONE OR ATTEMPT TO FIND OUT WHAT WAS GOING ON. THAT IS WHEN THE SUSPECTS GOT INTO THEIR VEHICLES AND FLED.

A WHITE FORD EXTRA CAB TRUCK. LATER GAVE PLATE # (PARTIAL PLATE)

TO THE INITIAL OFFICER. HAD WRITTEN THIS PLATE NUMBER ON HIS HAND.

OFFICER THEN WENT TO AND GROUP AT SOUTHDOWNS TO FIND OUT WHAT WAS GOING ON. DETECTIVE QUESTIONED IF HE, FELT THE OFFICER OBSERVED THE SUSPECTS AND RECOGNIZED THEM. STATED THAT HE DID FEEL THAT WAY, NOT BY WHAT THE OFFICER HAD SAID BUT BECAUSE HE HAD LET THEM LEAVE WITHOUT IDENTIFYING THEM.





ON 04-15-2003 AT APPROX 0930 HRS DETECTIVE CONTACTED OWNER OF SOUTHDOWNS BAR AND GRILL, RODNEY CAREY, AT HIS PLACE OF BUSINESS, 4205 PERKINS RD.

DETECTIVE WAS ABLE TO WATCH VIDEO TAPE APPROX 30 MINUTES LATER IN OFFICE AT 704 MAYFLOWER.

ON THE TAPE APPROX 4 - 5 W/M'S AND ONE W/F ARE SEEN STANDING IN FRONT OF THE BAR AT 0205 HRS. IT APPEARS THERE IS ONE W/M THAT IS HARASSING THE SUBJECTS. ONE SUBJECT IN GROUP APPEARS TO BE HAVING SOME WORDS WITH THE W/M. AT APPROX 0210 HRS, THE W/M RUNS AND THE 4 - 5 SUBJECTS IN GROUP RUN AFTER IN HIM IN PURSUIT. ALL SUBJECTS THEN LEAVE RANGE OF THE CAMERA.

THE TAPE IS VERY DARK AND IT IS EXTREMELY DIFFICULT TO SEE THE FACES OF THE SUSPECTS. DETECTIVE WAS UNABLE TO IDENTIFY ANYONE FROM THIS VIDEO TAPE.

THE TAPE WAS TURNED OVER TO INTERNAL AFFAIRS INVESTIGATORS FOR FURTHER INVESTIGATION AND LATER TO BE TURNED INTO BRPD EVIDENCE.



He advised Detective the bar had closed and he was inside with the bartender, D.J. and bar backs assisting with cleaning up the place to get out for the night. The cleaning was disrupted by a female crying and banging on the door for help. stated he doesn't know what the females' name is but she told them there was a fight in the parking lot.
