Good afternoon,

Thank you for your clarification. Until we have a perfected request, this request will remain with the clock stopped. Did you mean to omit the items on your list between 13 and 18? Are you requesting that 82 individuals complete the search for records? Some of the people on the provided list are not Forest Service employees and therefore are not subject to FOIA. Are you willing to wait several years for the search to be completed and the documents reviewed? As written your request is overly broad, will tie up many employees and will take years to complete at the current rate of review.

I would suggest you have those subject matter experts who are familiar with the Santa Fe Mountains Landscape Resiliency Project, the land management plan and the Gallinas Watershed Prescribed Fire, Las Dispensas Unit and the Hermit's Peak/Calf Canyon Wildfire, Santa Fe National Forest, Pecos-Las Vegas Ranger District familiar with the requested records conduct the search for records. You can always ask for additional documents at a later time, but as currently written, we consider it overly burdensome.

If waiting several years for us to complete your request is acceptable, please let us know.
