On 10/8/2023, at approximately 0822 hours, while on patrol, Escambia County Deputy Sheriff Justin Neel was at the intersection of Scenic Hwy. and Davis Hwy., parked in the Cumberland Farms parking lot.

While at the intersection, a Hispanic male, later identified as VICTIM, walked across the street toward Deputy Neel. VICTIM'S clothing was covered in dried blood, his face was bruised and swollen, he could hardly stand, and he was barefoot.

Deputy Neel made contact with VICTIM and could see that he had large amounts of dried blood on his face, neck, and hands, and had deep lacerations on the front and sides of his neck. VICTIM only spoke Spanish, and Deputy Neel tried to communicate with him by using the Google Translate App on his agency-issued cell phone. EMS Medic #14 arrived on scene and transported VICTIM, to Sacred Heart Hospital.

Prior to VICTIM, being transported to Sacred Heart Hospital, he stated (through the use of the translator app), that his friends attacked him, the woman stuck a knife in VICTIM's neck, the man beat him, they stole VICTIM's car, and threw VICTIM off a bridge. Prior to leaving the scene, Deputy Neel used his agency-issued cell phone to take photos of VICTIM's injuries. A total of 10 photos were taken and uploaded to Quetel. Further interviewing could not be done at the time, due to the VICTIM being taken to surgery for his injuries.

Deputy Ramires #226, Lt. Allday #027, and Deputy Beaty #287 circulated the area of the Hwy 90 bridge between Brown's Fishing Camp Road and Smith's Fish Camp Road but did not see any evidence to locate any witnesses. Deputy Neel followed the ambulance to Sacred Heart Hospital and collected the VICTIM's clothing as evidence. Deputy Neel transported the evidence to the Sheriff's Office Evidence Building and transferred custody of the evidence to CST Kelly #711.

At approximately 1400 hours, Deputy Neel was contacted by the hospital staff who said that the VICTIM was awake and alert. Deputy Ramires arrived at Sacred Heart Hospital (Rm #535), to aid as an interpreter. VICTIM made the following statement under oath, through Deputy Ramires. VICTIM said, about five days ago, he met an unknown female through Facebook. VICTIM said he had added her as a friend, and they began talking online. VICTIM described the female as a Puerto Rican female, approximately 25 years old, with blonde hair "like an afro", who speaks both English and Spanish, but he could not provide her name. VICTIM stated he messaged the female, who said she was having issues with money and needed food, and he offered to take her to dinner or take her to buy some food. Prior to meeting the female, VICTIM drove to to cash his paycheck. VICTIM stated around 1830 hours on 10/7/23, he met the female at 11 W Burgess Rd. (Beacon Gas Station). VICTIM stated when VICTIM got to the store, VICTIM met the female and bought drinks for her children and other food items. VICTIM stated he drove himself and the female in his vehicle to her home.

When asked if he knew the address of the female's home, he could not provide it. VICTIM did state the home was about a 1-minute drive, northbound from the gas station. VICTIM described the home as a normal-looking house that was white, with a fence around the backyard. VICTIM stated once they arrived at the home, he was met by an unknown black male, whom the female stated was her uncle. VICTIM described the black male as approximately 25 years old and having light skin. At approximately 2200 hours, after cooking dinner at their residence, VICTIM stated he was going to take the female and male to his home. It was unclear if VICTIM or one of the suspects were driving VICTIM's vehicle.

VICTIM stated he wanted them to take him back to his home, but they refused. VICTIM stated the male began to beat him in the head. VICTIM stated the female stuck a knife to his throat and told him this would be his last night, and he was going to die tonight. VICTIM stated the female cut him on his neck while the male was hitting him and then the male cut his neck with the knife, telling him he was going to die. VICTIM stated the female to be his stopped on a bridge and the male and female threw him off the bridge into the water. VICTIM stated once he was thrown in the water, he began to swim for a while before making it to a bank and climbing up.

stated that VICTIM stated he was driven to a bridge. Once they stopped at the bridge, both the W/ male and female removed him from the back of the vehicle, beat him some more, and then cut his throat several times. After cutting his throat, the male and female threw VICTIM over the bridge, into the water, and drove off in his vehicle. stated that VICTIM stated he swam in the water for a while until reaching a bank, where he was picked W/ up by an older female in a boat. W/ the state of that VICTIM stated the female boater drove him to the riverbank, where he began to walk up the road and met the deputies at the gas station. VICTIM stated to Deputy Ramires he met the female at the Beacon Gas Station; however, he stated to W/ the state of the met the female at the Xpress Mart. At this time, it is unclear which gas station this occurred at until video footage can be reviewed from each station. At approximately 2040 hours, Deputy Weller #280 (FTO), returned a call from W/ advised . W/ stated she found a note in VICTIM's wallet about a week ago that she believed was from a female. W/ W/ . W/ advised W/ stated the name on the note was Emily and the phone number was stated he called the number, and it went to voicemail with a female's voice he stated sounded Puerto Rican, stating her number had changed along with a new number. At this time, the suspects have not been identified, pending further investigation. The interviews were captured on a body-worn camera and were uploaded to the Sheriff's Office server.

On October 9th, 2023, I (Investigator L. Martinez) was assigned this case. I reviewed the first reports by the patrol deputies and noticed that there were two versions of what happened by VICTIM due to the language barrier. I wanted to conduct a follow-up interview with VICTIM to clarify with him what happened to him on 10/07/2023. VICTIM was still at Sacred Heart Hospital when I went to see him, the interview was conducted in Spanish, and this is a summary of the interview. VICTIM said that while on his Facebook page, he found the female on Facebook and sent her a friend request and she responded to the request. They began to communicate via text on Facebook Messenger. On Friday the 6th of October, after getting off work, he received a message from the female who wanted to know if he could bring her something to eat like a pizza or some McDonald's. The female also sent him directions to her house and the VICTIM not familiar with the area did not go there, so the female would meet with him at the store just past the railroad tracks and the cement place. The store would be Xpress Mart 202 E. Olive Rd. Once there, she got into the vehicle, and they drove to a Taco Food Truck at 6680 N Palafox St, Pensacola, FL 32503, Happy Jacks.

Then VICTIM took the female home and dropped her off. VICTIM later received a message from her thanking him for the tacos and saying that they were very good. On Saturday the 7th while at work, VICTIM started receiving messages from the female again about wanting to see him. VICTIM stated that he told the female that he would come over later after work, while at VICTIM's home the female continued to text wanting to see him. VICTIM told her he would come over later once he cashed his paycheck. VICTIM went back to the same residence and pulled into the driveway and the female came out. The female told VICTIM that she needed to get her cats. So, not knowing where she needed to go, the female suggested she drive and got into the driver's seat and VICTIM was in the passenger seat. VICTIM did not know where they went but the female did pick up one cat and then they returned back to the female's house.

Once at the house, the female went inside the house with the cat, while VICTIM waited in the vehicle and after a few minutes, the female emerged from the house along with a black male. When the black male got into the vehicle, VICTIM stated that the black male showed him that he had a pistol. They left the residence on their way to what the female said was her uncle's house for a cookout. Once at the "Uncle's" house, the female and the black male stayed together, and

VICTIM and an older black male stayed together outside. They all left and went to a nearby store to buy beer and wine, but VICTIM could not remember the name of the store. Only that VICTIM was the one who paid for everything. After coming back to the cookout, the only people that were eating were the black male and female. VICTIM was ready to leave and got back into the vehicle, the female was driving, and the black male got into the vehicle and began punching VICTIM, while the female drove. VICTIM remembers the female telling him that they were going to take him to a place and take everything from him, kill him, and throw him in the water.

VICTIM thought they were joking until they took him to the bridge, got him out of the vehicle, beat him some more, and then the black male grabbed him, held him, and cut VICTIM's throat with a knife. VICTIM yelled, "You killed me!", the black male then threw VICTIM over the side of the bridge into the water. Once VICTIM hit the water, he could feel the water stinging the cut on his neck and throat. VICTIM began swimming towards land and eventually reached an area where he collapsed with exhaustion until morning when VICTIM was awoken by someone in a boat who found him and brought him to shore. VICTIM asked for help and then walked from the location to the Cumberland's at 10398 N Davis Hwy, Pensacola, FL 32514 where VICTIM saw Deputy Neel.

I asked VICTIM if they could show me using Google Earth Maps the house where he picked up the female. Utilizing Street View on Google Earth and using the starting point of the Xpress Mart on E. Olive Rd. VICTIM gave me directions, turned on E Olive Rd, go down to the first right turn, go down the street, and then stop when VICTIM recognized the house. I then asked VICTIM if he could describe the black male. VICTIM described the black male as having big hair, a beard both blonde in color, and a thin build. The female, VICTIM described as having fair skin, blonde hair, with tattoos on her thighs and on her lower leg. VICTIM said that she spoke Spanish and, on her Facebook, profile claimed to be Puerto Rican.

I asked VICTIM if he ever paid the female for sex, and VICTIM's response was no. I asked if she had brought up any conversation about sex for money. VICTIM said, "Yes" and the female told VICTIM that it would cost \$500.00 dollars to have sex with her. VICTIM said he never agreed to pay her for any sex, but VICTIM believes by telling her that he was cashing his check on Saturday the female knew that he would be holding a lot of money. VICTIM told me that he could take me and show me where the house was, once VICTIM got out of the hospital. But with the directions, VICTIM provided, I was sure I could find the residence. I asked VICTIM if "Emily" was the one who did this to him and VICTIM said "No." So, after the interview, I drove to E. Olive Road, and with the directions given by VICTIM and the house he recognized in street view, I found the house on Oak Forest Drive, from the road I could see it was house number

I searched our computer-aided dispatch (CAD) history for any calls for service at COAk Forest Drive, there were a couple of calls for service. The most recent was an armed disturbance on 09/04/2023, (ECSO230FF016694), I then retrieved the body camera footage from the responding deputies and reviewed their videos. In the video, there were three people involved all three said that they live there in the home. The victim was identified as a black male Nafis Na'im Reynolds and his girlfriend, Natalie Fonseca, is a fair-skinned female with ombre hair light to green, a tattoo on the inside right forearm. The third was a black male Rafiq Coles, brother of the victim. In this incident, a physical confrontation escalated between brothers and both parties stabbed each other. Mr. Coles was arrested and is still in custody. I was able to obtain screenshots from the body camera video of Natalie Fonseca and Nafis Reynolds.

On 10/11/2023, Deputy A. Wallace and I went back to the Sacred Heart Hospital to confirm VICTIM's profile Facebook page with VICTIM that he used this to communicate with the female and was notified that VICTIM had been

discharged. I then found VICTIM at his residence and confirmed his Facebook page, VICTIM felt well enough to want to show me where the house was where the female lived. We then drove VICTIM by his directions to the residence which VICTIM said is where he picked up and dropped off the female and where he was on 10/6/2023 and 10/07/2023. VICTIM pointed to **Second Determined** Dak Forest Drive and said, "That's it." We then drove VICTIM to the bridge where he was thrown from, it was the westbound outside lane on Hwy 90 of the Escambia River Bridge. I asked VICTIM what he was wearing on the night of 10/07/2023, VICTIM said he was wearing red shorts, and a white polo shirt with slides. VICTIM was taken back home, and we went to the Xpress Mart to obtain the video footage for the evening of 10/06/2023 and 10/07/2023.

In searching through the video, I found the footage on 10/06/2023 at 2038 p.m. the van pulls into the parking lot, and the driver, VICTIM, and the female park next to the gas pumps. After sitting in van for about four minutes, the female is the first to get out, she is fair-skinned, she is wearing a light grey body suit, and she has two thigh tattoos and another on the back of her right lower leg. Her hair is long, in a ponytail, and ombre blonde to green, she is wearing black socks with black Nike slides. In the footage, VICTIM is following her through the store as they get drinks, they come up to the counter, VICTIM pays, and then they both walk out together, get back in the van and drive out towards E. Olive Road, VICTIM makes a left and heads East.

In the video footage of 10/07/2023, at 2055 p.m. the van pulls into the parking lot, and the same female from 10/06/2023 gets out of the driver's side of the van. She is wearing a white T-shirt with an American flag, the same body suit underneath, black socks, black slides her hair is down. She comes into the store, goes to the same cooler gets drinks, candy, and a cup of ice heads up to the counter and pays, gets back into the van as she is leaving, there is a male in the passenger seat wearing a dark color shirt and VICTIM who is wearing a white shirt can be seen sitting the back seat. While downloading the video, the same female that I have been watching in the video footage walks into the store along with the black male with the light color afro. The female is wearing a red hoodie, red pants, and black Nike slides. The black male is wearing a black/grey hoodie and dark-colored pants, with white shoes. They select some items, make the purchase, and leave. They are walking together east on E. Olive Road; we leave the store and drive past them as they are walking and turn into the second entrance to the neighborhood off Deborah Drive. We set up in a nearby driveway and obtained surveillance video of them walking up Oak Forest Drive and into the yard of the stores.

After reviewing the video footage from the Xpress Mart and noticed that some of the events that VICTIM described were not exactly like the statement that he gave to me in the hospital. On 10/13/2023, Inv. Little and I went to speak with VICTIM. I told VICTIM that on the 6th the female did not get in VICTIM'S vehicle, she was already in the vehicle when they got to the store. VICTIM remembered that it was Friday the 6th when VICTIM cashed his check because VICTIM did not work on Saturday. VICTIM stated that they went and picked the female up at her house, brought her to the store, gave her \$75.00 dollars, they went into the store, bought the drinks and then took her home. The rest of the events of what happened on Saturday the 7th is just as VICTIM gave in the interview at the hospital.

Based on the above facts and circumstances, the video evidence, the verbal statement of VICTIM, and the given physical description of the suspect(s) by VICTIM. VICTIM being on video with the female on 10/6/2023, the same female driving VICTIM's vehicle on 10/07/2023 and who is observed in the Xpress Mart on 10/11/2023 with the black male matching the description given by VICTIM, both observed and captured on video going to the point Dak Forest Drive, the address which VICTIM pointed out as the residence were the female and the black male who eventually would beat, rob, carjack, kidnap and attempt to murder VICTIM reside.
